Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Caddis Capital Management 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE A – DESCRIPTION OF PLAN

The following description of the Caddis Capital Management 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. During 2021, the Plan’s name was changed from Alpine Home Medical Equipment 401(k) Plan to Caddis Capital Management 401(k) Plan. The Plan is a defined contribution plan covering all eligible employees of Caddis Capital Management, Inc and participating members of its affiliated service group, which includes Alpine Home Medical Equipment, LC, Copper Star Medical Supply, LLC and Mountain Peak Associates, LLC (together as a group, the “Company”). It is subject to the provisions of the Employee Retirement Income Act of 1974 (ERISA).

Eligibility. All employees are eligible to participate in the Plan upon six months of service and attainment of age 18, except for (i) union employees, (ii) non-resident aliens with no US source income, and (iii) residents of Puerto Rico. Participation in the Plan is voluntary for eligible employees.

Contributions. Participants may contribute (defer) through salary reduction, the maximum allowable under the Internal Revenue Code (IRC). The Company may contribute a matching contribution equal to 100% of the employee salary deferrals that do not exceed 3% of the employee’s compensation plus 50% of the employee’s salary deferrals between 3% and 5% of the employee’s compensation. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan investments consist of guaranteed interest accounts and registered investment company accounts held by Reliance Trust Company. Contributions are subject to certain limitations.

Participant Accounts. Each participant’s account is credited with (a) the Participant’s contribution, (b) the Company’s matching contribution, (c) earnings from the participant selected investments in the individual participant account, and (d) charged with an allocation of administrative fees and expenses. Allocations are based on each participant’s earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account.

Vesting. Participants are immediately 100% vested in their participants accounts.

Notes Receivable from Participants. The Plan offers two types of loans, which are general-purpose loans and primary residence loans. The repayment period for a general-purpose loan may not exceed 5 years, and the repayment period for a primary residence loan may not exceed 10 years. Participants can only have one outstanding loan at any time unless one loan is a principal residence loan amortized for a period greater than 5 years.

Participants may borrow from their accounts a minimum of \$1,000 and a maximum amount (1) 50% of the Participant’s vested account balance or (2) \$50,000. Loans are secured by the participant’s vested account. Interest rates remain fixed for the life of the loan and are based on a rate that is commensurate with interest charged for loans that would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as notes receivable from participants on the Statements of Net Assets Available for Benefits and are valued at their unpaid principal balance, plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are recorded when incurred. No allowance for credit losses has been recorded as of

December 31, 2024 and 2023. All outstanding loan balances will become due and payable in their entirety upon the occurrence of certain events of default.

Payments of Benefits. On termination of service due to death, disability, retirement, or termination of service due to other reasons, a participant may elect to receive an amount equal to the value of the participants accounts in either a lump-sum amount, or in annual, quarterly, or more frequent installments.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with U.S. generally accepted accounting principles (GAAP).

Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Many factors are considered in arriving at fair value. In general, however, shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. The fair value of the guaranteed contracts is based on contract value which represents contributions made, less withdrawals and administrative expenses, plus interest credited.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (loss) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in current year's net appreciation (loss) in fair value of investments.

Reclassification of Prior Year Investment Income

Prior year amounts included in Net investment income (loss) as presented in the Statements of Changes in Net Assets Available for Benefits have been reclassified to conform to the current year presentation. No change was made to the total net investment income.

Date of Management's Review

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENT

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements.

The fair value of mutual funds held in registered investment accounts is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements.

Guaranteed contracts refer to The Standard Stable Asset D which is available through a rider to Standard Insurance Company's group annuity contract. The fair value of the guaranteed contracts is based on contract value which represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals. The plan's Standard Stable D's contract value is a general liability against Standard Insurance Company on the plan's behalf. Crediting rates for the plan's Stable D are set by Standard Insurance Company using a process similar to that used by banks or other insurance companies for similar products. The credit rating is declared in advance, reset quarterly, and will never be below 1 percent annually. The contract's NAV increases with the daily equivalent of the crediting rate and the Plan's unit value increases along with the contract's NAV offset by the Plan's asset management fees. There are no segregated or identifiable assets of Standard Insurance Company ascribed to the Plan's assets in the contract.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE F – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated December 31, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was amended on March 27, 2020, to implement provisions of the Coronavirus Aid, Relief, and Economic Security Act also known as the CARES Act.

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
