The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered

material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of plan

The following brief description of the WorldSprings 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) Plan covering substantially all employees of WorldSprings (the “Company”) who have met certain periods of service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective on December 29, 2022, the Setting Every Community Up for Retirement Enhancement (“SECURE”) 2.0 Act of 2022 was signed into law. The SECURE 2.0 Act is inclusive of approximately 90 provisions which offer many benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment and auto-escalation, age of required minimum distributions, catchup contributions, and increased dollar threshold for mandatory distributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year.

The Plan has adopted the required minimum distributions at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of the SECURE 2.0 Act by December 31, 2025.

Contributions

Contributions consist of employee elective deferrals, Company safe harbor matching contributions and Company discretionary contributions, if any. Employees may voluntarily contribute up to 100% of their compensation on a pretax or post tax basis (“Roth”), limited to \$23,000 in 2024, as prescribed by the Internal Revenue Code (“IRC”). Participants age 50 and older may elect to make additional catch-up contributions of \$7,500. Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”).

The Plan also includes safe harbor employer matching contributions equal to 100% of the first 3% and 50% on the next 2% of each participant’s elective deferrals to the Plan. No discretionary employer contributions were made in 2024. In addition, contributions are subject to other limits under the IRC.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts

A separate account is maintained for each participant, which is credited with the participant’s contributions, the Rollover contributions, Employer contributions and an allocation of Plan earnings/losses and expenses. Allocation of Plan earnings/losses and expenses is based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, rollovers, employer safe harbor contributions, plus actual earnings thereon. The Company’s safe harbor matching contributions are 100% vested immediately after entering the Plan.

Notes receivable from participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within five years unless used to acquire a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to 1% above the prime rate. Principal and interest are paid ratably through payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan. There were no loans outstanding as of December 31, 2024.

Payment of benefits

Upon termination of service due to death, disability, retirement, resignation, or discharge, a participant will be paid a lump sum amount equal to the participant's vested account value. The Plan provides for hardship distributions which are available only for the purpose of meeting immediate and heavy financial needs. Participants may elect to take a partial or total distribution when they reach age 59½ or at any time thereafter, even if they have not terminated employment with the Company. Upon termination, account balances that are under \$5,000 may be automatically paid out at the discretion of the Company.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year. All gains and losses are reported in the accompanying Statements of Changes in Net Assets Available for Benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on when received. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses have been recorded as of December 31, 2024.

Payments of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Plan expenses

Certain administrative expenses incurred in relation to the maintenance of the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment expenses are netted against the funds market valuation and are not separately identified. Expenses relating to specific participant transactions as noted by the Plan document are charged directly to the participant's account.

Subsequent events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued. No events requiring recognition or disclosure in the financial statements were identified.

3. Fair value measurements

That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* ("ASC 820") are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Information certified by the Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends for the period from May 15, 2024 (inception) to December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company ("Ascensus"), the trustee. As elected by the Plan administrator, no auditing procedures have been performed on this information except to compare such information to the information included in the accompanying financial statements.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

6. Tax status

The Plan uses a non-standardized pre-approved profit sharing plan with CODA, which received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan document has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and believes that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-interest transactions

Certain Plan investments are shares of mutual funds, managed by Vanguard Group Inc. (“Vanguard”), the recordkeeper of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan related to Vanguard’s services rendered amounted to \$355 for the period from May 15, 2024 (inception) to December 31, 2024.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. The Plan administrator, through its investment advisor, monitors the Plan’s investments and the risks associated therewith on a regular basis, which the Plan believes minimizes these risks.
