INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the AerSale 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering all employees of AerSale, Inc. (the Plan sponsor) and it is subject to the provisions of the Internal Revenue Code (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees of the Company were eligible to become participants in the Plan after completing one year and 1,000 hours of eligible service and having reached the age of 21 or older. Effective January 1, 2022, the service requirement was reduced to 60 days. Entrance to the Plan is on the first day of the month on or after the eligibility requirements are satisfied.

Funding

Participants may elect to contribute from their salary in whole percentages, ranging from 1% - 100%, of eligible compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to certain limitations under the IRC. Participants may also contribute amounts representing distributions from other qualified plans. Under Internal Revenue Service (IRS) Code Section 402(g)(1), the maximum deferral of pre-tax earnings was \$23,000 during 2024 and \$22,500 during 2023. Participants who have attained age 50 before the end of the plan year are eligible to contribute an additional \$7,500 of catch-up contributions for the years ended December 31, 2024 and 2023.

The Plan sponsor makes safe harbor qualified non-elective contributions equal to 3% of participant's eligible compensation as defined in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan sponsor's contribution, an allocation of the Plan's earnings or losses, investment fees, and any other administrative expenses paid out of the Plan. Allocations of the Plan's earnings or losses in each investment option and Plan sponsor's contributions are made to the participant's accounts based on the ratio of each participant's current account balance in each investment option to total participant's account balance in the investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are immediately fully vested in their own and Plan sponsor contributions.

Investment Options

Upon enrollment in the Plan, participants may direct contributions to any of the various Principal Life Insurance Company (Principal) investment options (see Note 4). Participants may change their investment options at any time.

Payment of Benefits

Participant contributions and the vested portion of the Plan sponsor's matching contributions are available for distribution upon attainment of age 59½, death, disability, termination of employment or normal retirement age. If the participant's vested account balance was less than \$5,000 at the date of the distribution, then that balance shall be distributed in a single lump-sum payment. If the participant's vested account balance was more than \$5,000 at the date of the distribution, then in addition to either a lump sum or direct rollover, participant may choose to receive installments, request partial withdrawal, or defer receiving payment until age 70½. If a participant chooses to defer payments, their account will continue to be invested in the way they direct and will be adjusted for any gains or losses that occur. Contributions were also available for distribution in the form of a hardship withdrawal.

In the event of death while employed by the Plan sponsor, the participant's vested amount will be used to provide the participant's spouse or beneficiary with a death benefit.

Notes Receivable from Participants

Notes receivable from participants consisted entirely of loans to participants. A loan cannot exceed the lesser of one-half of the vested interest of a participant's account balance or \$50,000 and must be at least \$500. The loans are secured by the participant's vested account balance and bear interest based on rates available for similar loans from commercial lending institution on the day the loan was requested. As of December 31, 2024 and 2023, interest rates on the loans ranged from 5.25% to 10.50% with maturities through 2029. The balances of notes receivable from participants were \$616,422 and \$655,291 as of December 31, 2024 and 2023, respectively.

All loans must be repaid within a five-year period unless it is for the purchase of a principal residence, which allows for repayment within a period of up to 30 years.

Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right to terminate the Plan subject to the provisions of the agreement and ERISA.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting. The preparation of financial statements in accordance with Generally Accepted Accounting Principles (GAAP) in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in these risks and uncertainties in the near term would materially affect participants account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Administrative Expenses

Certain administrative and accounting functions are performed by the Plan sponsor's employees, who receive no compensation from the Plan. Administrative expenses, such as professional fees, are paid directly by the Plan sponsor.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Principal Trust Company (Principal), the custodian, held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule Form 5500 - Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses.

During the year ended on December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,295,273. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

There have been no changes in the methodologies used to measure fair value as of December 31, 2024 and 2023.

The following is a description of the valuation methods used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts (PSA): The majority of the underlying securities have observable quoted pricing inputs obtained from a pricing service. While the net asset value of the PSA is not publicly quoted, it is available via the custodian's website, therefore it has a readily determinable fair market value.

NOTE 5. FULLY BENEFIT-RESPONSIVE INSURANCE CONTRACT

The Plan has a traditional fully benefit-responsive guaranteed insurance contract, which was reported at a contract value of \$404,400 and \$694,133 as of December 31, 2024 and 2023, respectively. Contract value is the aggregation of contributions, plus interests, less withdrawals, if any. The crediting rate is currently reset on a semiannual basis and was as follows:

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were investment funds managed by Principal Life Insurance Company, custodian of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Fees paid during the year for accounting and other services rendered by the parties-in-interest were based on customary and reasonable rates for such services. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

NOTE 7. TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan sponsor, as well as the Plan trustees, believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to December 31, 2021.

NOTE 8. PROHIBITED TRANSACTIONS

The Department of Labor's (DOL) regulation 29 CFR 2510.3-102 requires that participant contributions be remitted to the Plan on the earliest date on which they can reasonably be segregated from the Company's general assets. Failure to remit participant contributions to the Plan in a timely manner results in a prohibited transaction which must be separately reported to the DOL and may result in penalties to the Plan sponsor.

During 2024, participant deferrals for two payroll periods totaling approximately \$100,223 (including participant loan repayments of \$7,845) were not remitted timely to the Plan. All contributions were remitted within the 2024 Plan year excluding interests and gains, which were remitted subsequently to year-end. These are shown as not corrected in the Schedule of Delinquent Participant Contributions.

Late participant contributions from the 2023 plan year were reported as uncorrected during 2023. The Plan Sponsor completed correction under the Department of Labor's Self-Correction Component, including restoration of lost earnings during 2024. As such, these contributions are not reported on the Schedule of Delinquent Participant Contributions for the year ended December 31, 2024.

NOTE 9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
