### ***Basis for Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**NOTE 1 – DESCRIPTION OF PLAN**

MHI Group 401(k) Plan (the Plan) is a multiple employer defined contribution plan adopted by Mitsubishi Heavy Industries America, Inc. (the Plan Sponsor) and participating employers. The Plan Sponsor (MHIA), Mitsubishi Heavy Industries Climate Control, Inc. (MCC); Mitsubishi Nuclear Energy Systems, Inc. (MNES); Crystal Mover Services, Inc. (CMSI), and MHI Compressor International Corporation (MCOI) are all participating in and have adopted the provisions of the Plan and are collectively referred to as the Company. The Plan was established effective April 1, 1985 and was amended and restated effective April 1, 2022. The Plan was most recently amended effective December 31, 2023. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

Eligibility: Effective January 1, 2023, all non-excluded employees of the Company are generally eligible to participate in the Plan after completing 30 days of service. Prior to January 1, 2023, all non-excluded employees of the Company were generally eligible to participate in the Plan after completing three months of service and prior to January 1, 2018, all non-excluded employees of the Company were generally eligible to participate in the Plan after completing four months of service. The entry date is the first day that an employee meets the eligibility requirements.

Contributions: The Plan has the following contribution options:

- *Participant Contributions* – Participants may elect to reduce their eligible compensation by a specific whole percentage (1% to 75%) and contribute the amount to the Plan utilizing pre-tax and Roth deferrals. Total deferrals may not exceed a dollar limit which is set by law. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts as catch-up contributions to the Plan. Participants may revoke or make modifications to their salary deferral election in accordance with procedures that the Company provides.

The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase of 1% in the percentage deferred and is ultimately capped at 10%. Effective December 31, 2023, the automatic deferral percentage will increase by 1% per year up to a maximum of 12% of eligible compensation.

- *Employer Contributions* – For 2024, the Company made a safe harbor matching contribution to the Plan equal to 100% of each participant's deferral that did not exceed 5% of eligible compensation. The Company also has a prior Company matching contribution which are matching contributions for eligible participants who participated in the Plan before January 1, 2012, and any matching contributions that were transferred to the Plan from MLP U.S.A., Inc. Savings & Retirement Plan on or after January 1, 2012. Lastly, the Company also has a prior Company regular contribution, which are additional discretionary nonelective contributions for eligible associates who participated in the Plan before January 1, 2012.
- *Rollover Contributions* – Participants may also deposit into the Plan taxable distributions that have been received from other qualified retirement plans and conduit IRAs.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are vested immediately in their elective deferrals, including catch-up contributions, and rollover contributions, plus actual Plan earnings or losses thereon.

Participants are vested in the employer safe harbor matching contributions and prior Company matching contributions plus actual earnings or losses based on periods of service, as defined below:

Participants active on or after January 1, 2007, are vested in the employer prior Company regular contributions plus actual earnings or losses based on periods of service, as defined below:

4 but less than 5	60%
5 or more	100%

Participants will be credited with a period of service for each 12-month period from the participant's date of hire until the date employment terminates.

Payment of Benefits: Upon termination of service due to death, disability, or normal retirement, each participant will be entitled to the full value of their accounts. Upon termination of service, a participant shall be entitled to receive a single lump-sum payment in cash equal to the value of the participant's vested account balance, installment payments, ad-hoc payments, or a direct rollover to an IRA or another employer retirement plan. For 2024, if a participant's vested account balance was \$5,000 or less, the account will be distributed directly to the participant in a cash lump-sum. For vested account balances exceeding \$5,000, participants must consent to distribute their account.

Participants may receive an in-service withdrawal from certain other accounts prior to termination of employment with the Company if they have attained age 59½ or incurred a financial hardship.

Notes Receivable from Participants: The Plan permits loans to be made to participants. Loan amounts are limited to a minimum amount of \$1,000 up to a maximum of the lesser of \$50,000 reduced by the highest outstanding loan balance during the prior 12-month period, or 50% of the participant's vested interest in the Plan. Loans are adequately secured by the vested interest in the participant's account balance under the Plan and bear a reasonable rate of interest. Loan terms may not exceed five years unless the loan is used to purchase a primary residence. Loan principal and interest repayments are made via payroll deductions, are credited directly to the participant's account, and are invested at the participant's direction in one or more of the investment options. A participant can only have one loan outstanding from the Plan.

Forfeited Accounts: Forfeitures may be used to reduce future employer contributions or to pay Plan administrative fees. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$118,552 and \$60,849, respectively. In 2024, forfeitures of \$77,075 were used to reduce employer contributions and \$28,993 were used to pay administrative fees.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Plan Transfer: Effective April 1, 2024, select employees of the Plan Sponsor and participants of the Plan were transferred to the Mitsubishi Heavy Industries Americas Inc. Shared Services Plan. As a result of the transfer, net assets of \$3,162,150 were transferred from the Plan effective August 19, 2024.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, the automatic deferral percentage will increase by 1% per year up to a maximum of 15% of eligible compensation.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3* – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

**NOTE 5 – GUARANTEED INCOME FUND**

The Plan holds an investment in a fully benefit-responsive investment contract, the Guaranteed Income Fund, with Empower Annuity Insurance Company of America (EAICA), formerly Prudential Retirement Insurance and Annuity Company, totaling \$9,812,129 and \$9,830,681 for 2024 and 2023, respectively. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on EAICA ability to meet its financial obligations. EAICA's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or contract value paid overtime. In addition, there are not any events that allow EAICA to terminate the contract and which require the Company to settle at an amount different than contract value paid either within 90 days or over time.

In addition to the terms described above, the Guaranteed Income Fund contract includes certain operational provisions that may affect plan-level transactions. Transfers from the Fund to designated "competing funds" are subject to a 90-day waiting period. The issuer also reserves the right to defer plan-level transfers or withdrawals if aggregate annual transfers from the pooled Guaranteed Income Fund exceed 10% of its assets. In such cases, deferred amounts continue to earn interest at the declared rate, and ordinary participant-level benefit payments (such as retirement, death, disability, hardship, or required minimum distributions) remain payable at contract value. These provisions are customary for stable value contracts and do not alter participants' ability to receive distributions at contract value under normal circumstances.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of pooled separate accounts managed by Empower Annuity Insurance Company and an unallocated investment contract with Empower Annuity Insurance Company. Empower Trust Company, LLC and Empower Annuity Insurance Company are service providers to the Plan and, therefore, these transactions and the Plan's payment of fees to the service providers qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated September 16, 2022 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
