Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of the Plan

The following description of the Bettcher Industries, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Bettcher Industries, Inc. and subsidiaries (the Company). Employees of the Company are eligible after completing 30 days of service. Employees may enter the Plan on the first day of the month after becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Administration Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective December 14, 2021, The Bettcher Industries, Inc. Profit Sharing Plan (formerly known as the Bettcher Industries, Inc. Employee Stock Ownership Plan and Trust) (the ESOP) was terminated. As a result of this action, ESOP participants became 100% vested in their account balances and the trustee of ESOP assets was directed to distribute the final assets during 2024. As a result, certain ESOP participant account balances in the amount of \$2,234,514 were transferred to the Plan. The transfer of assets is included on the statements of changes in net assets available for benefits.

Contributions

Each year, participants may contribute from 1 percent to 100 percent of annual compensation, as defined in the Plan up to the maximum contribution amount allowed by the law. The Plan allows for voluntary after-tax (Roth) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral contributions increased by 1 percent annually in May, up to a maximum of 6 percent, unless otherwise elected. Effective January 1, 2024, the maximum automatic increase is 10 percent.

The Plan allows for Company matching contributions equal to 50 percent of a participant's contribution, not to exceed 6 percent of eligible compensation. The Plan allows for discretionary Company profit sharing contributions. There were no discretionary profit sharing contributions authorized in 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, prior transfers from the ESOP, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. Allocations of the Company's profit sharing contribution are given to employees who were active participants at any time during the Plan year and are based on participants' compensation for the Plan year relating to the contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's matching and profit sharing contributions, plus actual earnings thereon.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from 1 to 5 years or longer if the note receivable is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.00%. No participant may have more than one outstanding loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon death, disability, retirement, or termination of services, a participant's voluntary contributions plus the vested amount of the Company contributions and earnings are paid in a lump sum payment or annual installments over a future period, as provided by the Plan. If the participant's account is between \$1,000 and \$7,000, the Plan may make an automatic rollover of the participant's vested interest in his or her account to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan may make an automatic lump sum distribution to the participant equal to the participant's vested interest in his or her account. Upon reaching age 59 ½, participants in service may elect to receive distributions of their fully vested account balances. The Plan also permits distributions to participants who have a qualifying financial hardship.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,808 and \$28,169 respectively. These accounts will be used to pay expenses of the Plan or reduce future employer contributions. During 2024 and 2023, forfeited non-vested accounts totaling \$39,425 and \$328,604, respectively, were used to reduce Company contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments and certain administrative service fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value in investments.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust), the trustee, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. The mutual funds are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

Collective trust funds - stable value funds: The funds are composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell for an amount different from the reported NAV. There are no unfunded commitments or significant restrictions on redemptions relating to these funds. There are no redemption restrictions upon which the participant may redeem investments in the funds. However, the Plan is required to provide a one-year redemption notice to liquidate its entire investment in the fund.

Self-directed brokerage accounts: Valued at the underlying values of the individual assets held within the brokerage accounts. The brokerage accounts primarily consist of mutual funds and individual equities that are valued on the basis of readily determinable market prices.

Collective trust funds: Valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell for an amount different from the reported NAV. There are no unfunded commitments or significant restrictions on redemptions relating to these funds. Participant transactions may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that security liquidations will be carried out in an orderly manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Company has adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement sponsored by Principal Life Insurance Company (Principal). Principal received an opinion letter dated June 30, 2020 from the IRS stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

7. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by Principal Trust, the trustee, as defined by the Plan and, therefore, such transactions qualify as party in interest transactions.

Principal Trust provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Principal Trust. Principal Trust receives revenue from mutual fund and collective trust fund service providers for services Principal Trust provides to the funds. This revenue is used to offset certain amounts owed to Principal Trust for its administrative services to the Plan. If the revenue received by Principal Trust from such mutual funds or collective trust fund service providers exceeds the amount owed under the MSA, Principal Trust remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or the Company may make a payment to Principal Trust for administrative expenses not covered by revenue sharing.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
