## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and Plan Administrator

### **Opinion**

We have audited the financial statements of Tempo, Inc. Employee Stock Ownership Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Tempo, Inc. 1. DESCRIPTION OF PLAN

General

Tempo, Inc. Employee Stock Ownership Plan and Trust (Plan) was established September 1998 for eligible employees of Tempo, Inc. (Company) and was amended and restated effective January 1, 2015. The Plan is an employee stock ownership plan covering substantially all employees of the Company as of their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following descriptions provide only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Contributions

Effective January 1, 2015 eligible employees are automatically enrolled with a contribution of 2% of compensation unless elected otherwise. The Company may make discretionary contributions at the option of the Company's board of directors. The employer discretionary contribution is made on an annual basis and may be made in cash, Company stock, or a combination of both. The employer discretionary contribution may be made as a fixed amount to each participant or in proportion to either base salary or compensation, at the discretion of the board of directors. The Company may make a matching contribution at the discretion of the board of directors to participants who contributed to the Plan during the year. The percentage of such matching contribution is at the discretion of the board of directors and will be applied at the ratio of the participant's contribution for the Plan year to the total of all participant contributions for the Plan year. The Company made discretionary matching contributions totaling \$172,608 for 2024. Participant contributions, including any rollover contributions, totaled \$894,123 for 2024.

Participant accounts

Separate accounts are established for each participant. Each participant's account is credited with the participant's contributions, the Company's contribution, and investment earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings, matching or account balances, as defined by the Plan. Certain administrative expenses may be charged directly to the participants' accounts incurring those expenses. Administrative expenses were not charged directly to the participants' accounts in 2024.

Vesting

Participants are vested immediately in their rollover balances, their contributions, and earnings thereon. Vesting in the Company's discretionary contribution portion of a participant's account and the earnings thereon is based on years of service. Participants are 100% vested in Company contributions after three years of service.

1. DESCRIPTION OF PLAN - continued

Voting rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to the participant's account and is notified by the Company prior to the time that such rights are to be exercised. The Company may vote any shares for which instructions have not been given by a participant. The Company may only vote shares held or controlled by the Company in a fiduciary capacity.

Forfeitures

Forfeitures are to be allocated as of December 31 each Plan year. Forfeitures will first be used to restore any previously forfeited amount to the employer contribution accounts of those participants entitled to restoration, second to pay administrative expenses of the Plan and third among the participants in proportion to their contributions to the total participant contributions to the Plan for that year. At December 31, 2024 and 2023, the balance of the forfeiture accounts were \$67,717 and \$50,760, respectively. In 2024, no forfeitures were used to reduce employer contributions.

Termination of the plan

While the Company has not expressed any intent to do so, it may terminate the Plan at any time. In the event the Plan is terminated, participants would become fully vested in their account balances, and net assets of the Plan would be distributed to participants in accordance with the provisions of the Plan.

Benefits paid to participants

Distribution of a participant's vested account balance is available upon the participant's retirement, death, disability, attainment of age 59 1/2 or for a financial hardship meeting the requirements of the Internal Revenue Code (IRC). In the event of death, disability, retirement or termination of employment, the Company has the option to require those participants with account balances of less than \$1,000 to take lump-sum distributions. If a participant's vested account balance exceeds \$5,000, the participant must consent to the distribution before it is made except in the case of a termination of employment in which the company, at its discretion, may diversify the vested balance into the Tempo Retirement Saving Plan without consent of the participant. If a participant's account balance exceeds \$1,000, they may elect to rollover their vested account balance, to receive a lump-sum distribution, or to receive installments over a specified period of time. Distributions are made in cash or, if the participant elects, in the form of Company stock plus cash for any fractional shares of common stock.

The Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Any fee or expense paid, directly or indirectly, by the Company is not considered a contribution to the Plan, provided the fee or the expense relates to the ordinary and necessary administration of the Plan.

Put option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitation, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company may pay for the purchase with additional interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash for their shares.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared under the accrual method of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

Estimates and assumptions

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities. Actual results could vary from the estimates used in preparing the accompanying financial statements.

Investment valuation and income recognition

The shares of Company common stock are valued at fair value. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits paid to participants are recorded when paid.

Subsequent events and date of management's review

Plan management has evaluated subsequent events through October 13, 2025, which was the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to incorporate various administrative, eligibility, and contribution changes. Some changes include revised definitions, eligibility exclusions for certain employee groups, and modifications to automatic enrollment and contribution escalation provisions. The amendment also updated rules regarding beneficiary designations post-divorce, enhanced catch-up contributions for participants aged 60–63, and clarified the allocation of discretionary employer contributions. Additional changes addressed diversification elections, participant distributions, benefit claim procedures, and processes for locating unresponsive participants. Provisions were also added to allow segregation of terminated participants' accounts into non-Company stock assets without requiring participant consent, along with amendments aligned with SECURE Act 2.0.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Sponsor company common stock:* The valuation process involves the selection of an appraiser which prepares a report of estimated fair market value per share that a participant will receive upon distribution. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The Plan's management, with the oversight of the Company's board of directors, reviews the report for consistency with the Company's expectation for future operating results. The Plan's investment in the sponsor company common stock is adjusted to its fair market value, as defined in the appraisal, as of the effective date of the appraisal. Valuation techniques include the income approach and the market approach, and rely on certain unobservable inputs. Unobservable inputs for the income approach include net cash flow, discount rate and weighted average cost of capital. Unobservable inputs for the market approach include comparable public companies, revenue and EBITDA multiples. At December 31, 2024 and 2023, the Plan administrator did not believe any adjustments to the fair value of the Company common stock as determined by a third-party appraiser were warranted.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. NONPARTICIPANT-DIRECTED INVESTMENTS

Included in net assets available for benefits at December 31, 2024 and 2023 were nonparticipant-directed investments in Company stock and other assets totaling \$17,872,108 and \$14,584,405, respectively. During the 2024, changes in net assets related to nonparticipant-directed investments included unrealized gains and interest income totaling \$2,725,977.

5. TAX STATUS

The Plan obtained an opinion letter from the Internal Revenue Service (IRS) dated September 17, 2013, which states that the Plan document satisfies the applicable provisions of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is currently not subject to examination by the IRS for plan years 2020 and before.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan held 57,544.58 shares of common stock of the Company at December 31, 2024 and 2023, The carrying value of the shares was \$17,099,947 and \$14,399,956 at December 31, 2024 and 2023, respectively. During 2024, the Plan had no stock transactions to report.
