We have performed audits of the accompanying financial statements of Cardinal Civil Contracting, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of Cardinal Civil Contracting, LLC 401(k) Plan (the "Plan") provides only general information for the Plan sponsored by Cardinal Civil Contracting, LLC. Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on February 1, 2018 as a defined contribution plan. The Plan includes employees of Envision Homes, LLC, Aviator Paving Company, LLC, Civil Transport, LLC and Cardinal Civil Contracting, NC, LLC. Effective October 1, 2021, the Plan was amended to include employees of Harrelson Utility and Repair, LLC in the Plan. Effective November 1, 2022 and December 1, 2022, the Plan was amended to include employees of G. Goodwin Enterprises, LLC and Civil Drilling and Blasting, LLC, respectively. Effective July 3, 2023, the Plan was amended to include employees of Monroe Roadways Contractors, Inc. All participating employers are collectively referred to as the "Company". The Plan covers all employees of the Company who are at least 21 years of age and who have completed one year of service. The Company is treated as a controlled group whereby all employees of each company shall be treated as employed by a single employer. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute a percentage of their pre-tax or after-tax annual compensation, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits rollover contributions from other qualifying retirement plans. The Company makes Employer Safe Harbor Matching contributions at a rate of 100% of the first 3% of an employee's compensation and 50% of the next 2% of an employee's compensation. The Company may make a discretionary employer match. Each year, the Company may also contribute to the Plan out of its current profits such amount as shall be determined by the Company. There were no discretionary employer matching contributions or profit-sharing contributions in 2024.

Participant Accounts

Employee contributions, employer contributions, and rollover contributions activity are maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investments daily. Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the salary reduction amount and safe harbor matching amount contributed to the Plan. Vesting in the Company's discretionary matching and profit-sharing contributions is based on the years of continuous service. Participants are fully vested after completing six years of credited service.

Forfeitures

At December 31, 2024, forfeited accounts totaled \$868. Forfeitures can be used to restore forfeitures, reduce employer contributions, reallocated as employer contributions or to pay reasonable plan expenses.

Payment of Benefits

Generally, a participant becomes eligible to receive benefits on their normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. Participants will receive 100% of their account balance in a lump sum amount. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions. Participants are also eligible to take in-service withdrawals once they attain age 59½. If the vested balance is less than \$5,000, a lump sum distribution is made. Effective January 1, 2024, this amount increased to \$7,000.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their elective deferral contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal. Effective January 1, 2024, participants are permitted to self-certify that their request qualifies as a hardship.

Notes Receivable from Participants

Participants may borrow from their fund a minimum of \$500 up to a maximum equal to 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. A participant can only have one loan outstanding at a time. The loans are secured by the balance in the participant's accounts and bear interest at a fixed rate equal to the prime rate plus two percent (9.50% at December 31, 2024) as of the date of the new loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 and 2023 were \$100,249 and \$61,096, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Significant Accounting Policies (Continued)

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on upon the terms of the plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 6 for a discussion of the valuation of the Plan's investments.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to the participant accounts based on participant holdings in each fund.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participant and distributions) are charged directly to the participant's account.

3. Federal Income Taxes

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. The plan administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

3. Federal Income Taxes (Continued)

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by American United Life Insurance Company ("OneAmerica"), the custodian of the Plan, and was not subject to audit for the years ended December 31:

This hierarchy consists of three broad levels:

Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 Inputs are based on significant other observable inputs such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 1, 2, or 3 investments in the Plan.

The fair value of the pooled separate accounts and collective investment trust is measured using the net asset value ("NAV") as a practical expedient and has been excluded from the fair value hierarchy. These funds do not have finite lives, unfunded commitments related to these types of investments, or significant restrictions on redemptions.

7. Collective Investment Trust Fund

The OneAmerica Stable Value Fund (the "Fund") is a collective investment trust fund that invests in separate accounts to simulate the performance of a guaranteed investment contract through the guarantee of a specific interest rate. Fund transactions are executed at contract value and are benefit-responsive for all participant-directed transactions. The contract value represents contributions, plus interest, less participant-initiated withdrawals or transfers.

The Fund sells new units and repurchases outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV per share class determined as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. The Fund records security transactions on a trade-date basis. Interest income is accrued at the Fund's crediting rate, which is generally based on the fair value, duration, and yield-to-maturity of the Fund. Realized and unrealized gains and losses on the underlying assets are typically amortized, usually over the duration of the underlying investments, through adjustments to the crediting future interest crediting rate, rather than reflected in the net assets of the Fund.

Participant-directed withdrawals, those made by a participant in a participating plan without advice, suggestion, guidance, or direction to do so by the plan sponsor, administrator, fiduciary record keeper or other plan service provider, are paid at the guaranteed value. However, if a withdrawal is made from the Fund as a result of an employer or plan sponsor-initiated event or if a withdrawal is requested due to a complete or partial termination or a participant plan in the Fund before the end of the contract, and the Fund's fair value equals or exceeds the guaranteed value, payment is made in the amount of the participating plan's guaranteed value. If the Fund's fair value is less than the guaranteed value, the amount paid is equal to the guaranteed value reduced by the amount of fair value deficit allocable to the participating plan.

In certain circumstances, all participant withdrawals may be deemed to be Participating Plan-Directed Withdrawals. A withdrawal will be deemed to be a Participating Plan-Directed Withdrawal if 1) the participant withdrawal is based on advice or direction; 2) the participating plan establishes an investment option that creates a competing fund; 3) a participating plan establishes a new plan or amends an existing plan and such plan covers participants in the participating plan and offers participants a competing fund; or 4) the participating plan makes a withdrawal for any reason, except for a participant-directed withdrawal.

8. Party-in-Interest Transactions

Plan investments are managed by OneAmerica, the custodian, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian and other parties-in-interest for contract administration, advisory and professional services amounted to \$5,902 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

9. Prohibited Transactions

During 2021, the Company failed to deposit \$7,060 of participant deferrals within the required timeframe as stated by the DOL. The DOL considers late deposits to be a prohibited transaction. The Company calculated and deposited lost earnings to correct for the failures in 2024 and filed Form 5330 for applicable excise taxes on the delinquent participant contributions. Excise tax payments were made from the plan sponsor's assets and not from the assets of the Plan.

10. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 14, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to include Purcell Construction, Inc. as a participating employer in the Plan. Effective June 1, 2025, the Plan was amended to include Page and Associates, Inc. as a participating employer in the Plan. Years of service with both employers will be credited for purposes of determining Plan eligibility and vesting.

Effective June 1, 2025, the Plan was amended to permit Cardinal Civil Contracting Triad to adopt the Plan.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective starting at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.
