### Note 1: Description of Plan

The following description of the Packer Fastener & Supply 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Packer Fastener & Supply Company, Packer Freight Systems, Inc., and Albolt Manufacturing LLC (collectively known as the "Company"). Employees are eligible to participate on the first day of the following month following their date of employment and upon turning 18 years of age. The plan excludes residents of Puerto Rico.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan, on a pre-tax or Roth basis, not to exceed the maximum allowable limits allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or make a different deferral election. Automatically enrolled participants have their pre-tax deferral rate set to 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides safe harbor matching contributions equal to 100% of each eligible participant's elective contributions up to 3% of compensation, plus 50% of each eligible participant's employee contributions on the next 2% of compensation, for a total maximum Company safe harbor matching contribution equal to 4% of compensation.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, and plan earnings or losses. Each participant's account is reduced for withdrawals and charged with an allocation of expenses paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are vested immediately in their voluntary contributions and Company safe harbor matching contributions plus actual earnings (losses) thereon.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms shall not exceed five years unless the note qualifies as a home loan. Participants may have one note outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024. Interest rates are set at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, normal retirement (age 65), or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

#### SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("GAAP").

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income on the accompanying statement of changes in net assets available for benefits. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than direct payment. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

#### Subsequent Events

The Company has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* Fair value of the common/collective trust is based on the quoted NAV of the underlying investments held by the common/collective trust. The common/collective trust fund invests in a fully benefit-responsive guaranteed investment contract whose underlying investments are pooled separate accounts that invest in funds that are actively traded and must publish their daily NAV and transact at that price.

### **Note 4: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, non-interest bearing cash and due to broker as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A., ("Alerus") the Trustee of the Plan.

### **Note 5: Party-In-Interest Transactions**

Alerus is the trustee, as defined by the plan document and, therefore, transactions with Alerus qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan to Alerus for administrative services totaled \$5,646 for the year ended December 31, 2024. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments because they are paid to Alerus through revenue sharing rather than a direct payment.

Nicolet National Bank ("Nicolet") is a nondiscretionary trustee of the Plan and acts as an investment advisor. Therefore, the fees paid to Nicolet qualify as party-in-interest transactions. Fees paid by the Plan for investment management services totaled \$39,931 for the plan year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Tax Status**

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document as then designed is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Prohibited Transactions**

Under DOL Reg. 2510.3-102(b), the Company is required to remit participant contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Company's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Company. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan year ended December 31, 2023, totaling \$467 were not timely remitted. These transactions constitute prohibited transactions as defined by ERISA.
