Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The SEER Group 401(k) Plan (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTE 1 – DESCRIPTION OF PLAN

The following description of The SEER Group 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established in January 1984 is a defined contribution and profit-sharing plan covering all eligible employees of the company who are 18 years of age, with a six-month waiting period for both employee deferrals and discretionary matching funds. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitor investment performance and reports to the Plan’s Board of Trustees. The Plan also received the assets of several other companies with common ownership. The companies included in the Plan at December 31, 2024 and 2023 included the following:

Contributions

Contributions made by participants are made either on a before-tax or after-tax basis. For before-tax contributions Federal income taxes on the earnings of the investments are deferred until amounts are withdrawn from the Plan. The earnings on after-tax contributions accumulate tax free. The amount deferred, however, shall not exceed the limit under appropriate Sections of the Internal Revenue Code during any calendar year as set forth in the Plan. After becoming eligible, participants may elect to contribute any percentage greater than 1% of their gross wages to the Plan up to the limits set in Internal Revenue Code. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has default investment alternatives established under the Plan. These default investments will be made in accordance with specific rules under which the fiduciaries of the Plan, including the Employer, the Trustee, and the Administrator, will be relieved of any legal liability for any losses resulting from the default investments. For employees who have attained eligibility, the Company will make a Safe Harbor match of 100% of employee contributions up to 4% of compensation.

The Company may make a discretionary contribution to the Plan. After the employee has met eligibility requirements for the Plan, if the Company makes a discretionary contribution to the Plan, the eligible participant's share of the discretionary contribution will equal the percentage of the participant's gross compensation in proportion to the total gross compensation of all eligible plan participants times the total discretionary contribution. The Company made no discretionary contributions to the Plan for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferrals and Safe Harbor match of deferrals plus investment earning on vested amounts. For employer match made prior to December 2012 and all discretionary employer contributions, if any, participants are vested according to the following schedule:

Forfeitures

Under the terms of the Plan, forfeited balances of participant's non-vested accounts can be used to reduce future employer contributions or pay Plan expenses. At December 31, 2024 and 2023 no forfeitures were available for plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are collateralized by the participant's account balance and must generally be repaid over a maximum period of five years, fifteen years if for the purchase of a primary residence. The interest rate on the note is 1% above the prime rate. The maximum number of notes that a participant may have at one time is limited to one. There are not penalties for early repayment. Participant notes are carried at the unpaid principal amount of the note, which approximates fair value. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, participants can elect to receive a lump-sum distribution or roll over their vested balance to an individual retirement account or another qualified plan. If no election is made by the participant, balances may be automatically rolled over to an individual retirement account or an individual retirement annuity as designated by the Administrator.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. In accordance with the modified cash basis of accounting, all accounts are presented on the cash basis with the exception of investments, which are stated at fair value.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's various investment options in mutual funds are held in registered investment accounts (mutual funds) and the Morley Stable Value Fund (common collective trust). These accounts are credited with earnings on the underlying investments and charged for Plan withdrawals. The fair value of the Plan's investment in mutual funds is determined by the value of the funds in the market at year end. Shares of the mutual funds are valued at fair value as measured by the quoted market prices, which represents the net asset value of shares held by the Plan at year-end.

The plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments which consists of realized gains or losses and unrealized appreciation (depreciation) on Plan investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan may be paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Custodian Change and Plan Spin-Off

During the year ended December 31, 2024, the Plan underwent two significant changes in the administration of its assets.

First, effective July 31, 2024, the Plan's custodian changed from Charles Schwab to Fidelity. In accordance with ASC 962, Plan Accounting—Defined Contribution Pension Plans, the transfer of assets between custodians is reported as a transfer of investments and did not impact the net assets available for benefits. All assets were transferred in kind, and participant balances were unaffected.

Second, on July 31, 2024, \$8,764,537 of plan assets were spun off into the newly established Northern Sales Company 401(k) Plan in accordance with ERISA and DOL regulations. The spin-off represented the account balances of certain participants who became participants in the new plan. This transaction is reported in the accompanying statement of changes in net assets available for benefits as a "Transfer to other plan," consistent with guidance in ASC 962 and the AICPA Audit & Accounting Guide for Employee Benefit Plans.

NOTE 3 – INFORMATION CERTIFIED BY CUSTODIAN

The Plan administrator elected the method of compliance permitted by 29 U.S. Code of Federal Regulations (CFR) 2520.103-5 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Security Act of 1974 (ERISA, the Act), Section 103(a)(3)(c). Under this provision of the Act, certain information is certified by an insurance company and need not be subject to independent audit.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the NAV of unites of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments. The Plan’s policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by Chares Schwab Trust Company, the custodian of the Plan; therefore, these transactions qualify as party in interest transactions. Certain employees of the Plan sponsor serve as trustees of the Plan. Also, certain administrative functions are performed by employees of the Plan sponsor. No such employee receives compensation from the Plan. An unrelated entity serves as the third-party administrator. Advisors and suppliers to the Plan are considered parties-in-interest under ERISA.

NOTE 6 – TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
