To the Administrator of GC America Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed an audit of the accompanying financial statements of GC America, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

1. Description of The Plan

The following description of the GC America Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and basic plan document for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 1990, is a defined contribution plan covering all employees of GC America Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

An employee of the Company becomes eligible to participate after completing six months of service and attaining age 20 1/2. The Plan's enrollment dates are monthly after meeting the eligibility requirements.

Contributions

Each year, a participant may contribute from 1% to 75% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan also permits participants to make rollover contributions in accordance with the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company contributes 100% of the first 5% of compensation that a participant contributes to the Plan, as a matching contribution. Additional amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations.

In addition, as defined in the Plan, the Company contributes 5% of the participant's annual compensation to the Plan each year (2% nondiscretionary employer contribution and 3% safe harbor nonelective contribution), not to exceed the maximum limit imposed by law. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions and allocations of the Company's discretionary contributions, if any, and Plan earnings. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service for matching contributions and discretionary contributions.

Notes Receivable from Participants

Participants may borrow from their account amounts from \$1,000 up to a maximum of 50% of their vested account balances, not to exceed \$50,000. The maximum number of loans outstanding at any one time for each participant is one. Loan terms range from one to five years. The loans are collateralized by the balance in the participant's account and bear a reasonable rate of interest as defined by the Plan administrator. Principal and interest are paid through payroll deductions.

Permitted by the CARES Act, the Plan adopted a provision permitting suspension of loan payments due for up to one year.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other termination of service, a participant will receive a lump sum or installment payments. Normal retirement age is 65. An active employee may receive an in-service withdrawal upon substantiating the criteria for a financial hardship, as defined in the Plan agreement. Participants may also withdraw their contributions, as described in the Plan, or upon their attainment of age 59 1/2. Terminated participants with account balances greater than \$1,000 are permitted to leave their account balances in the Plan. On December 29, 2022, the SECURE 2.0 Act of 2022 ("Secure Act 2.0") was enacted. As part of Secure Act 2.0, the required minimum distribution date was changed to age 73, effective January 1, 2023.

Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. These accounts are used to reduce future Company contributions. In 2024 and 2023, Company contributions were reduced by approximately \$105,297 and \$98,482 from forfeited nonvested accounts, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related expenses are recorded as administrative fees and are expensed when they are incurred. Delinquent loans are reclassified as distributions based on the terms of the Plan agreement.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Participants are charged transaction fees for loan and withdrawal processing. The Company, at its discretion, pays other record-keeping and administration fees.

Risks and Uncertainties

The Plan provides for various investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Revision

During 2024, an error was identified in the accounting for the fair value of the Plan's pooled separate investment account. The investment had historically been incorrectly recorded at contract value. The plan administrator assessed the qualitative and quantitative impact of the error and has concluded it is not material to the 2023 Plan's as issued financial statements. However, the Plan has revised the 2023 Statement of Net Assets Available for Benefits to appropriately classify \$8,372,781 its pooled separate account investment at fair value. In addition, the Plan has revised Note 3 for the error.

3. Fair Value Measurements

The Financial Accounting Standards Board (FASB) issued guidance that defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and expands disclosure related to the use of fair value measurements in financial statements. The guidance establishes a fair value hierarchy from observable market data as the highest level to fair value based on an entity's own fair value assumptions as the lowest level.

In accordance with the guidance, the Plan sponsor groups Plan assets and liabilities measured at fair value into three levels, based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are as follows:

Registered Investment Companies

Valued at net asset value ("NAV") per share, using available inputs to measure fair value by such companies or funds, for shares held by the Plan at year-end. Generally, mutual funds have a quoted market price in an active market. The pooled separate account is valued based on the unit value established for each fund on the valuation date. Reporting entities are permitted, as practical expedient, to measure the fair value of an investment on the basis of the Net Asset Value ("NAV") per share of the investment if the NAV is calculated in a manner consistent with measurement principles. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Were the Plan to initiate a full redemption of the pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Account

Units held in the pooled separate account are valued at the NAV, based on the fair market value of the underlying investments of the account less its liabilities. The NAV is used as a practical expedient to fair value. If the Plan initiates a full redemption of the PSA, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidation will be carried out in an orderly business manner. The New York Life Anchor Account ("Anchor Account") is a pooled separate account group annuity contract seeking to provide a low-risk, stable investment option. The Anchor Account offers participants competitive yields and limited volatility, with a guarantee of principal and accumulated interest. The Anchor Account has no unfunded commitments and a daily redemption frequency.

4. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Trust Management Company has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i -schedule of assets (held at end of year) as of December 31, 2024.

5. Related-Party Transactions

Certain Plan investments are managed by Fidelity or an affiliate thereof. Fidelity Management Trust Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Plan is a Volume Submitter Profit Sharing Plan ("Volume Submitter Plan") sponsored by Fidelity Management & Research Company. The Volume Submitter Plan obtained its latest advisory letter on October 31, 2016, in which the Internal Revenue Service (IRS) stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Company has determined that the Plan is eligible and has chosen to rely on the current IRS advisory letter. The Plan has been amended since the date of the letter; however, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. Subsequent Events

The Plan evaluated its December 31, 2024, financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued.
