Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of the Iowa Tribe of Oklahoma's Prototype 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE A--DESCRIPTION OF THE PLAN

The following description of the Iowa Tribe of Oklahoma's (the "Tribe") Prototype 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of the Tribe (which includes the Enterprises of the Tribe) who have three months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may make voluntary contributions to the Plan up to the lesser of their annual compensation or the annual limitation imposed by the Internal Revenue Service of \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 for 2024. Rollover and transfer contributions from qualifying plans are permitted under the Plan agreement.

The Tribe may make matching contributions in an amount to be determined by the Tribe on an annual basis. For the year ended December 31, 2024, the Tribe matched employee deferrals 100% up to 6% of compensation. Additionally, profit sharing amounts may be contributed to the Plan at the option of the Tribe. There were no profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution, Tribe matching contributions, if any, and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts. Profit sharing contributions would be allocated based on the ratio of a participant's compensation to the total compensation of all participants.

Investment Options: Participants direct the investment of their contributions into various pooled separate accounts offered by the Plan consisting of index funds, target date funds, or a guaranteed investment account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Matching contributions from the Tribe vest at the rate of 20% per year of continuous service. A participant is 100% vested after five years of service.

NOTE A--DESCRIPTION OF THE PLAN--Continued

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at reasonable rates determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: On termination of service, participants are entitled to the vested portion of their account balance. Distributions under the Plan may be made in a lump sum or installments. Distributions are subject to the applicable provisions of the Plan agreement.

At December 31, 2024 and 2023, net assets available for benefits included \$2,467,487 and \$1,950,940, respectively, relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

Forfeitures: Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees and are used to offset future contributions of the Tribe. During the year ended December 31, 2024, participants incurred forfeitures of \$50,172.

Plan Termination: Although it has not expressed any intent to do so, the Tribe has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded as expenses when they have been approved for payment.

Administrative Expenses: The majority of expenses related to the administration of the Plan's investment transactions, recordkeeping, custodian fees, and other expenses incurred in the administration of the Plan are paid by the Tribe.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant's loan balance is reduced and a benefit payment is recorded.

Income Tax Status: The Internal Revenue Service has determined and informed the Plan by a letter dated November 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Investment Valuation and Income Recognition: Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events: Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure.

NOTE C--GUARANTEED INVESTMENT ACCOUNT

The Plan invests in the Mutual of America Interest Accumulation Account whose underlying assets are fully benefit-responsive investment contracts. This guaranteed investment account seeks to provide preservation of principal and provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The guaranteed investment account is an insurance company guarantee, backed by the applicable underwriting company's general asset account, which offers competitive, consistent investment returns relative to its asset category. The guaranteed investment account has no fluctuation of principal and offers liquidity to withdraw funds for benefits payments and investment elections. The underwriting company's general asset account is a well-diversified, managed portfolio of bonds, mortgage loans, and other appropriate investments.

The guaranteed investment account investment policy strictly limits the bond holdings by type, quality, and maturity to create a stable low-risk bond portfolio. The guaranteed investment account has appropriate asset/liability management strategies which are utilized to insulate portfolio assets from the effects of adverse interest rate movements and to offer competitive, risk-adjusted returns.

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D--FAIR VALUE MEASUREMENTS--Continued

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Investments represented by a unit of account whose unit per value is the result of the accumulated values of the underlying investments. The underlying investments are public investment vehicles using net asset value (NAV) per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, then divided by the number of shares outstanding. The underlying investments of the NAVs are valued as follows:

Mutual Funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at the price. The mutual funds held by the Plan are deemed actively traded.

Guaranteed Investment Account: Valued at contract value (See Note C).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

NOTE E--INFORMATION CERTIFIED BY PLAN CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan as of and for the years ended December 31, 2024 and 2023, Mutual of America Life Insurance Company, has certified that the following data included in the accompanying financial statements and supplementary Schedule of Assets Held at End of Year is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Schedule H, Line 4i--Schedule of Assets Held at End of Year as of December 31, 2024, except for notes receivable from participants which have not been certified.

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information per the custodian's certified statements to the related information included in the financial statements and supplementary Schedule of Assets Held at End of Year.

NOTE F--TRANSACTIONS WITH EXEMPT PARTY-IN-INTEREST

Certain assets of the Plan consist of pooled separate accounts managed by the custodian which is considered an exempt party-in-interest transaction under ERISA.

Certain assets of the Plan consist of notes receivable due from participants which are considered exempt party-in-interest transactions under ERISA.

NOTE G--INVESTMENT CONCENTRATION, RISKS AND UNCERTAINTIES

As of December 31, 2024, approximately 7% of Plan assets consist of one guaranteed investment account.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE H--VOLUNTARY CORRECTION PROGRAM

The Plan had untimely participant contributions during 2024 of \$3,744. Lost earnings were calculated and remitted in 2025. These remittances constitute prohibited transactions as defined by ERISA. Management does not believe the amount of any lost earnings, interest, or penalties required to be paid is significant.
