Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Community Healthlink Section 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Description of Plan

The following description of the Community Healthlink Section 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement and any amendments thereto for more complete information.

General

The Plan is a defined contribution Plan covering all employees of Community Healthlink, Inc. (the Employer) who have attained the age of 16 and have completed one (1) year of service 1,000 hours in a 12 month period. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, investment managers and trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 90% of annual compensation on a pre-tax as defined by the Plan. Participant contributions cannot exceed the annual limits specified under Internal Revenue Code (IRC) Section 402(g). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with the IRC. Participants may also contribute amounts representing distributions from other qualified retirement plans.

Participants are eligible to receive Employer discretionary contributions and non-elective discretionary match contributions once they have completed 1,000 hours of service during the Plan year if they are employed on the last day of the Plan year. The Employer's discretionary contribution for 2024 was 2% of eligible compensation. No Employer non-elective discretionary match contribution was made for 2024.

All contributions are invested in the Plan based upon participant elections.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) Employer contributions, (b) investment earnings based on investment options selected, and (c) certain Plan administrative expenses, as applicable. Allocations are based on participant earnings, account balances, or participant requested transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts is based on years of continuous service. Participants become vested in any type of Employer contribution after the following consecutive years of service:

Investments

Participants direct the investment of the employee and Employer contributions into various investment options offered by the Plan. The Plan currently offers various Registered Investment Companies (RICs) and a common/collective trust (CCT).

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that ranges from 4.25% to 9.50%, which is commensurate with local prevailing interest rates as determined by the Plan administrator. Loans must be fully repaid with after-tax dollars through payroll deductions within a time period specified by the Plan administrator.

Payment of Benefits

Participants are entitled to receive either lump-sum or partial distributions based on the value of the participant's vested interest in his or her account upon retirement, death, termination of service, or for reasons of financial hardship. If, upon severance of employment, a participant's vested balance account is equal to \$5,000 or less, the Plan will roll over the amount to an individual retirement Plan designated by the Plan administrator.

Forfeited Accounts

Forfeitures of the non-vested portion of withdrawing employees' accounts are retained in the Plan and used first to pay administrative expenses and then to reduce future Employer contributions. At December 31, 2024 and 2023, the balance of forfeited non-vested accounts was \$74,725 and \$37,072, respectively. During the year ended December 31, 2024, forfeitures of \$1,000 were used to reduce employer contributions and \$1,185 was used to pay administrative expenses.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's pension committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions

Contributions from Plan participants and Employer discretionary nonelective matching contributions from the Employer, if any, are recorded in the year in which the employee contributions are withheld from compensation. Employer discretionary matching contributions are recorded in the year in which the contributions are earned.

Other Income

Other income consists of revenue earned from revenue sharing in connection with Plan investments in excess of contractual compensation. These amounts must be used for payment of qualified Plan expenses or allocation to eligible participants, as defined by the agreement. Fidelity Management Trust Company (Fidelity) provides certain administrative services to the Plan pursuant to a Recordkeeping Agreement (RA) between the Company and Fidelity. Fidelity receives revenue from fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such fund service providers exceeds the amount owed under the RA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were excess amounts of \$58,958 which is included in other income on the statement of changes in net assets available for benefits. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments on the statement of changes in net assets available for benefits.

Note 3 – Certified Investments

The Plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity, the trustee of the Plan.

Note 4 – Fair Value Measures

Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement that should be determined based on assumptions that market participants would use in pricing an asset or liability. Assets and liabilities reported at fair value are classified and disclosed in one of the following three categories:

Level 1 – Observable inputs such as quoted prices for identical assets and liabilities in active markets at the measurement date. The fair value hierarchy gives the highest priority to Level 1 inputs;

Level 2 – Valuations using observable inputs other than Level 1 prices such as quoted prices in active markets for similar assets and liabilities; quoted prices for identical or similar assets or liabilities in markets that are not active; broker or dealer quotations; or inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; and

Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

In accordance with Subtopic 820-10, certain investments that are measured at fair value using the net asset value (NAV) per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts represented in this table are intended to permit reconciliation of the fair value hierarchy to the amount presented in the statements of net assets available for benefits.

The Plan categorizes, for disclosure purposes, investments measured at fair value in the financial statements based upon whether the inputs used to determine their fair values are observable or unobservable. Observable inputs are inputs that are based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own assumptions about pricing the investments based on the best information available in the circumstances.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

RICs including Money Market Fund: Valued at the daily closing price as reported by the registered investment company. RICs held by the Plan are open-end RICs that are registered with the United States Securities and Exchange Commission. These RICs are required to publish their daily net asset value (NAV) and to transact at that price. The RICs held by the Plan are deemed to be actively traded.

Common/Collective trust: The fair value of a single CCT, Fidelity Managed Income Portfolio (MIP) is based on the NAV of the fund, representing the fair value of the underlying investments, which are generally securities traded on an active market and are redeemed daily. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

There were no unfunded commitments for the Fidelity MIP as of December 31, 2024. Participant level transactions take place daily at the current NAV. Were the Plan to initiate a full redemption of the Fidelity MIP, notice to Fidelity is required and could result in the Plan's investment in the MIP being placed into an investment only account for up to 12 months. The fund's strategy is income and capital preservation. In accordance with the current accounting guidance, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Plan made direct payments to the third-party administrator of \$61,538 during the year ended December 31, 2024, which were not covered by revenue sharing. The Employer pays, directly, any other fees related to the Plan's operations. These qualify as exempt party-in-interest transactions. Notes receivable from participants are also exempt party-in-interest transactions.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Internal Revenue Service (IRS) has determined and informed Fidelity Management & Research Company by a letter dated June 30, 2020, that the Fidelity Volume Submitter Profit Sharing Plan with CODA, Fidelity Basic Plan Document No. 17, adopted most recently by the Plan on December 17, 2018, is designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

Note 9 – Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
