INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the
National Production Workers Union Insurance Trust Fund

Opinion

We have audited the accompanying financial statements of the National Production Workers Union Insurance Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that modified cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. We draw attention to Note 2 of the financial statements, which described the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Note 1. Description of the Plan

The following description of the National Production Workers Union Insurance Trust Fund (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan document for a complete description of the Plan's provisions, copies of which may be obtained from the Plan's sponsor ("Plan Sponsor"). The current Plan document is determined to be obsolete. The Plan document is currently being redrafted to describe the new plan of benefits currently implemented.

General

The Plan was established during 1955, as the result of collective bargaining agreements between the affiliated locals of the National Production Workers Union and various employers (collectively, the "Employer") to provide health care, death and disability benefits for eligible employees and their dependents. In 1979, the Plan added a dental plan. The Internal Revenue Service ("IRS") ruled favorably on this Plan amendment. The Plan changed its short-term disability coverage from self-insured to fully insured during the year ended December 31, 2021.

Benefits

The Plan provides or has provided health benefits, life insurance coverage, short-term disability, dental, optical and accidental death & dismemberment to eligible employees and to their beneficiaries and covered dependents.

Employees and their dependents initially become eligible for benefits on the first day of the month of covered employment for which an Employer makes the required monthly contribution on the employee's behalf, in accordance with the applicable collective bargaining agreement. An employee may elect to self-pay for coverage if the Employer is not required to pay for benefits under the collective bargaining agreement. However, if an employee works for an Employer who begins participation in the Plan for the first time, eligibility begins on the first day of the first month for which the Employer is first obligated to make and does make the required contribution on the employee's behalf, in accordance with the applicable collective bargaining agreement.

Coverage continues on a calendar month basis, provided an Employer makes the required monthly contribution on the employee's behalf, in accordance with the applicable collective bargaining agreement. Coverage is terminated at the end of the calendar month for which an Employer made the last monthly contribution to the Plan on the employee's behalf, unless the employee elects to make self-

payments, in which case, coverage terminates at the end of the calendar month for which the last self-payment is made.

Continuation of health care benefits to persons, who would otherwise lose those benefits due to certain events, as mandated by COBRA (Consolidated Omnibus Budget Reconciliation Act), was adopted by the Plan on January 1, 1989. The Plan did not provide any medical benefits during the year ended December 31, 2024.

The Plan is fully insured with respect to health, dental, optical, short-term disability, and life insurance benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting. Under that basis, certain revenues and the related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred. That basis differs from generally accepted accounting principles primarily because the Plan has not recognized contributions receivable from Employers and employees and accounts payable to vendors and their related effects on earnings in the accompanying financial statements. It also does not recognize benefit obligations as claims payable and claims incurred and unreported are reported when paid rather than when incurred.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Fixed Assets

Furniture and equipment are carried at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation and amortization are computed

over the estimated useful lives of the related assets by the straight-line method. There was no depreciation and amortization expense for the year ended December 31, 2024.

Shared Expenses

The Plan shares office facilities and staff with Production Workers Union of Chicago and Vicinity, Local 707; National Production Workers Union; Truck Drivers, Chauffeurs, Warehousemen and Helpers Union, Local 707; Professional, Technical, and Clerical Employees Union, Local 707 and the National Production Workers Union Severance Trust Fund. The entities are considered related parties to the Plan. In 2010, the shared operating expenses of the combined facilities were paid initially by the unions and were allocated annually on the basis of space and staff utilized as approved by the Plan's board of trustees (the "Trustees"). Subsequent to 2010, the Plan began paying expenses from each of the related entities based on allocations approved by the Trustees.

Note 3. Priorities Upon Termination

Although they have not expressed any intent to do so, the Trustees have the right to terminate the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the beneficiaries and participants. In the event the Plan terminates, the net assets available for benefits of the Plan will be allocated as prescribed by ERISA and its related regulations.

Note 4. Tax Status

The IRS has advised the Plan that it qualifies under Section 501(C)(9) of the Internal Revenue Code and is, therefore, not subject to income tax under present income tax laws.

Note 5. Notes Payable - Bank

On April 21, 2023, the Plan refinanced a preexisting loan at a principal amount of \$307,224. The note has a variable interest rate which is the prime rate as published in the Wall Street Journal plus a margin of 1 percentage point, resulting in a 9.5% rate at December 31, 2024. The note required monthly payments of \$2,000, plus interest, with a final payment of principal and accrued interest on April 21, 2025. The note was guaranteed by an officer of a related labor union

On April 21, 2025, the note was refinanced for a due date of July 21, 2025. On July 21, 2025, the note was refinanced at a principal of \$261,224. The note has a final payment of principal and accrued interest due on October 21, 2025, with all other terms unchanged.

Plan management intends on paying principal payments in excess of what is required when cash flows allow, as was the case in the year ended December 31, 2024.

Note 6. Related-Party Transactions

The two Employer trustees of the Plan are independent trustees. The Plan compensated these trustees a total of \$8,750 during the year ended December 31, 2024.

Note 7. Delinquent Contributions

As of December 31, 2024, there was approximately \$3,000 in late remittances owed from five Employers. The Plan still covered the premiums for that Employer's participants to ensure there was no lapse in coverage. The Employers subsequently remitted the funds in 2025.

Note 8. - Contingencies

For the short-term disability self-insured program, the Plan did not withhold the proper withholding taxes on disability payments prior to 2014 and is delinquent with the related required payroll tax filings for third party sick pay. These financial statements have not been adjusted for this contingency. Any penalties related to this contingency will be assessed against the Plan. The amounts of these contingencies are unknown, and these financial statements do not include any adjustments that might result from the outcome of these contingencies.

The Plan has been involved with various settlements of prior self-funded claims over the years and continues to be subject to outstanding unpaid claims. The amounts of these contingencies are unknown and these financial statements do not include any adjustments that might result from the outcome of these contingencies.

Note 8. - Contingencies (continued)

The Plan has not filed its Form 5500 for the years 2008 through 2010 and those filings may be considered incomplete by the Department of Labor ("DOL"). It has since filed its 2011 through 2023 returns, although a number of prior years have no filings. The lack of filings and the potential for a variety of breaches of fiduciary duty claims by the DOL could result in unknown contingencies to the Plan and/or the Plan Sponsor. These financial statements do not include any adjustments that might result from the outcome of these contingencies.

Note 9. - Concentrations of Credit Risk

For the year ended December 31, 2024, the top two contributors represented eighty-seven percent of total contributions.

Note 10. - Subsequent Events

Management has evaluated all known subsequent events from December 31, 2024 through October 14, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that have not been disclosed in the notes to the financial statements.
