Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kane 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of the Kane 401(k) Profit Sharing Plan (formerly, Premiere Communications & Consulting, Inc. 401(k) Profit Sharing Plan) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 1997, is a defined contribution plan originally covering substantially all employees of Premiere Communications & Consulting, Inc., the Plan Sponsor at that time. Effective January 1, 2023, the Plan was amended to modify the name of the Plan to Kane 401(k) Profit Sharing Plan. Effective March 1, 2023, Kane Infrastructure Services Intermediate Holdings, LLC became the Plan Sponsor (the Employer or the Plan Sponsor) and the employees of certain affiliates and subsidiaries of the Plan Sponsor, including Premiere Communications & Consulting, LLC, Kane Communications, LLC, and Cable Solutions, LLC, became eligible to participate in the Plan. Effective January 1, 2024, the employees of Net100, LLC became eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective March 1, 2024, the Plan was amended to define the early retirement age as 59 ½ and completion of 6 years of vested service.

Plan Merger

Effective March 1, 2024, the Net100 401(k) Plan (the Net100 Plan) merged into the Plan. The net assets of the Net100 Plan totaling \$7,676,781 were transferred, which included outstanding loans of \$257,415.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan are Fidelity Management Trust Company and Fidelity Workplace Services, LLC, respectively (collectively, Fidelity). Principal Life Insurance Company (Principal), a separate entity, also holds an investment in the Principal U.S. Property Separate Account. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The administrator of the Plan is the Company. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Employer who are age 18 or older are considered eligible for participation on the first day of each month upon meeting the eligibility requirement, except for employees subject to a collective bargaining agreement, leased employees and nonresident aliens who do not receive any earned income from the Employer which constitutes United States source income.

Contributions

Each year, participants may contribute pre-tax salary, after-tax or Roth deferrals, not to exceed the maximum limits set by the Internal Revenue Code (IRC). Participants who are 50 years of age or

older by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The Plan Sponsor contributes a safe harbor matching contribution of 100% of the participant's contributions up to a maximum of the first 3% of the participant's eligible compensation, and 50% of the next 2% of the participant's compensation. Effective April 27, 2023, the Plan was amended to remove the option to allow employees to contribute after tax contributions.

The Company may also make a non-elective discretionary contribution (profit-sharing contribution) to the Plan. Participants must have performed one year of service (defined as 1,000 hours of service during the Plan year) and be employed on the last day of the plan year, except in the event of death, disability or retirement during the year, to be eligible for the profit-sharing contribution. No non-elective discretionary contribution was made for the year ended December 31, 2024. The Company may make a discretionary employer matching contribution as a percent of eligible compensation deferred by participants.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer safe harbor, profit-sharing and matching contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested portion of their account.

Vesting

Participants are immediately vested in their participant contributions, rollover contributions, and Employer safe harbor matching contributions, plus actual earnings and losses thereon. Vesting in the Employer's discretionary matching contribution or profit-sharing contributions, plus actual earnings thereon, is based on years of service. Participants are vested ratably over six years of service. Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

Employees of Cable Solutions, LLC who were previously participants in the Cable Solutions, LLC 401(k) Plan which merged into the Plan effective March 1, 2023, became 100% vested in their prior discretionary non-elective and matching contributions upon the effective date.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. The notes

are repaid ratably through after-tax payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 10 years. Each participant may not have more than one loan outstanding at any time. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, disability, attainment of normal retirement age, termination of service or any other reason. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be made upon circumstances of financial hardship (minimum of \$500), in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$7,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$15,023 and \$16,279, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. During the year ended December 31, 2024, there were \$21,245 forfeitures used to reduce employer contributions or used to pay Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the accompanying financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by its investment advisors. See Note 4 for further information related to fair value measurements.

Mutual funds are valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange

Commission. These funds are required to publish their daily net asset values and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The pooled separate account is valued based on the publicly quoted pricing input which was used in determining the net asset value of the pooled separate account, which was not publicly quoted. The value of each pooled separate account was determined at the close of each business day based on fair value of the underlying assets, which consisted of a single mutual fund or multiple securities. The NAV was provided by the issuer and was used as the practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. These investments were direct filing entities and there were no unfunded commitments.

The Reliance Trust Company New York Life Anchor Account Series I Class 0 Stable Value Fund is a collective investment trust (CIT) valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient is not used when it is determined to be probable that the CIT will sell for an amount different than the reported NAV. The CIT provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to the investment. The CIT is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit-sharing contributions are recorded in the period in which the contribution has been declared in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account

and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, Schedule H-Line 4i, Schedule of Assets (Held at End of Year), related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

The Plan's investment in the Principal U.S. Property Separate Account, an investment held by Principal totaling \$56,281 at December 31, 2024, which was merged into the Plan as part of the Net100 401(k) Plan merger on March 1, 2024, has a 12-month redemption notice period and is not certified. Earnings, including interest and dividends, and net depreciation in fair value of this investment totaled (\$2,130) for the year ended December 31, 2024, and is not certified.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 or 2023.

5. Related Parties and Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, transactions with Fidelity qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Income Taxes

The Plan adopted the pre-approved plan document sponsored by Fidelity, which received an opinion letter from IRS dated June 30, 2020 stating that the written form of the underlying plan documents are qualified under Section 401(a) of the IRC and that any employer adopting these forms of the plans will be considered to have a plan qualified under Section 401(a) of the Code. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

10. Delinquent Participant Contributions

During the Plan year ended December 31, 2024 and 2023, participant contributions and loan repayments totaling \$47,480 and \$92,073, respectively, were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions and prohibited transactions as defined by ERISA. The Employer corrected the 2023 remittances, and \$14,106 of the 2024 remittances, during 2025 and remitted related lost earnings. The remaining 2024 remittances will be corrected later in 2025.

11. Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date which the accompanying financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
