## Independent Auditors' Report

### **1. Description of the Plan**

The following description of the Mansueto Ventures, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for more detailed information.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Mansueto Ventures, LLC (the "Company" or "Employer"). The Plan excludes employees who are: (1) residents of Puerto Rico; (2) covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan; (3) leased employees; (4) nonresident aliens with no income from a U.S. source; or (5) temporary employees (if they did not obtain 21 years of age and completion of 1,000 hours of service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Contributions to the Plan are made by both participating employees and the Company. Participants may contribute up to 60% of their eligible compensation, as defined by the Plan document, on a pre-tax, after-tax, or Roth basis, subject to Internal Revenue Code ("IRC") limitations. Participants may also elect to make after-tax contributions on up to 100% of their eligible compensation, subject to IRC limitations. All eligible employees and new hires are automatically enrolled in the Plan with a pre-tax deferral contribution of 6% unless they sign a waiver indicating that they do not wish to participate in the Plan. Those participants who are automatically enrolled will have their contributions increased by 1% each year not to exceed 10%, unless otherwise elected. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements.

The Company may make discretionary matching contributions. In addition, the Company may also elect to make discretionary non-elective contributions to those employed on the last day of the plan year. For the year ended December 31, 2024, the Company made a discretionary matching contribution to participants and were employed at the end of the year. The matching contribution was of 100% of the participant deferrals up to \$2,500. No discretionary non-elective contributions were made for the year ended December 31, 2024.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **1. Description of the Plan (*continued*)**

#### ***Vesting***

Participants are fully vested in that portion of their account which represents their contributions and the income earned thereon. Participants hired prior to January 1, 2020 who had a Company discretionary matching balance are 100% vested in all contributions and earnings thereon. Participants hired after January 1, 2020 are subject to a 4-year graded vesting schedule with 100% vesting occurring after 4 years of service. Participants become 100% vested in all contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. A participant's interest in the Company's discretionary non-elective contributions fully vests after one year of service.

#### ***Payment of Benefits***

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants may elect a lump sum distribution.

A participant may also request a withdrawal upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from a hardship. A hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the Internal Revenue Code or standards established by the Secretary of the Treasury or his delegate.

#### ***Notes Receivable from Participants***

A participant may borrow an aggregate amount up to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to plan limitations. The minimum loan allowed is \$1,000. Loans must bear a reasonable rate of interest commensurate with local prevailing interest rates, as determined by the plan administrator. Loans are collateralized by the participant's nonforfeitable interest in the Plan and are supported by a promissory note. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. A participant may only have one outstanding loan at any given time. Principal and interest is generally paid ratably through payroll deductions each pay period.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective Plan assets. Investment related expenses are included in net appreciation in fair value of investments.

### **1. Description of the Plan (*continued*)**

#### ***Forfeitures***

When certain terminations of participation in the Plan occur, the non-vested portion of a participant's account represents a forfeiture, as defined by the Plan document. Forfeited balances are first used to restore re-employed participants' accounts. Any remaining forfeitures may be used to pay Plan expenses or reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,759 and \$16. During 2024, forfeitures of \$1,750 were used to offset Plan expenses and no forfeitures were used to reduce Employer contributions.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### *Investment Valuation and Income Recognition (continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

#### *Benefit Payments*

Benefits are recorded when paid.

#### *Subsequent Events Evaluation by Management*

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in fair value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### 5. Common/Collective Trust

The Fidelity Managed Income Portfolio I (“MIP I”) is a common/collective trust and has no unfunded commitments. Fidelity Management Trust Company is the trustee of the MIP I. The MIP I invests in assets (typically fixed income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters wrap contracts issued with third parties, and invests in cash equivalents represented by shares in money market funds. Wrap contracts are purchased from issuers rated in the top three long-term rating categories (A- or the equivalent and above).

Net asset value per unit is determined each business day. Issues and redemptions of units are recorded, upon receipt of unitholder’s instructions in good order, based on the next determined net asset value per unit normally each day. In unusual market conditions, the trustee may impose restrictions on issues and redemptions of units.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the MIP at net asset value.

### 6. Exempt Party-in-Interest Transactions

Certain investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

### 8. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, FMR LLC, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

## Independent Auditors' Report

### The Plan Administrator of Mansueto Ventures, LLC 401(k) Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Mansueto Ventures, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

### **1. Description of the Plan**

The following description of the Mansueto Ventures, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for more detailed information.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Mansueto Ventures, LLC (the "Company" or "Employer"). The Plan excludes employees who are: (1) residents of Puerto Rico; (2) covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan; (3) leased employees; (4) nonresident aliens with no income from a U.S. source; or (5) temporary employees (if they did not obtain 21 years of age and completion of 1,000 hours of service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Contributions to the Plan are made by both participating employees and the Company. Participants may contribute up to 60% of their eligible compensation, as defined by the Plan document, on a pre-tax, after-tax, or Roth basis, subject to Internal Revenue Code ("IRC") limitations. Participants may also elect to make after-tax contributions on up to 100% of their eligible compensation, subject to IRC limitations. All eligible employees and new hires are automatically enrolled in the Plan with a pre-tax deferral contribution of 6% unless they sign a waiver indicating that they do not wish to participate in the Plan. Those participants who are automatically enrolled will have their contributions increased by 1% each year not to exceed 10%, unless otherwise elected. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements.

The Company may make discretionary matching contributions. In addition, the Company may also elect to make discretionary non-elective contributions to those employed on the last day of the plan year. For the year ended December 31, 2024, the Company made a discretionary matching contribution to participants and were employed at the end of the year. The matching contribution was of 100% of the participant deferrals up to \$2,500. No discretionary non-elective contributions were made for the year ended December 31, 2024.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **1. Description of the Plan (*continued*)**

#### ***Vesting***

Participants are fully vested in that portion of their account which represents their contributions and the income earned thereon. Participants hired prior to January 1, 2020 who had a Company discretionary matching balance are 100% vested in all contributions and earnings thereon. Participants hired after January 1, 2020 are subject to a 4-year graded vesting schedule with 100% vesting occurring after 4 years of service. Participants become 100% vested in all contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. A participant's interest in the Company's discretionary non-elective contributions fully vests after one year of service.

#### ***Payment of Benefits***

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants may elect a lump sum distribution.

A participant may also request a withdrawal upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from a hardship. A hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the Internal Revenue Code or standards established by the Secretary of the Treasury or his delegate.

#### ***Notes Receivable from Participants***

A participant may borrow an aggregate amount up to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to plan limitations. The minimum loan allowed is \$1,000. Loans must bear a reasonable rate of interest commensurate with local prevailing interest rates, as determined by the plan administrator. Loans are collateralized by the participant's nonforfeitable interest in the Plan and are supported by a promissory note. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. A participant may only have one outstanding loan at any given time. Principal and interest is generally paid ratably through payroll deductions each pay period.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective Plan assets. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Forfeitures***

When certain terminations of participation in the Plan occur, the non-vested portion of a participant's account represents a forfeiture, as defined by the Plan document. Forfeited balances are first used to restore re-employed participants' accounts. Any remaining forfeitures may be used to pay Plan expenses or reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,759 and \$16. During 2024, forfeitures of \$1,750 were used to offset Plan expenses and no forfeitures were used to reduce Employer contributions.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### *Investment Valuation and Income Recognition (continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

#### *Benefit Payments*

Benefits are recorded when paid.

#### *Subsequent Events Evaluation by Management*

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in fair value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### 5. Common/Collective Trust

The Fidelity Managed Income Portfolio I (“MIP I”) is a common/collective trust and has no unfunded commitments. Fidelity Management Trust Company is the trustee of the MIP I. The MIP I invests in assets (typically fixed income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters wrap contracts issued with third parties, and invests in cash equivalents represented by shares in money market funds. Wrap contracts are purchased from issuers rated in the top three long-term rating categories (A- or the equivalent and above).

Net asset value per unit is determined each business day. Issues and redemptions of units are recorded, upon receipt of unitholder’s instructions in good order, based on the next determined net asset value per unit normally each day. In unusual market conditions, the trustee may impose restrictions on issues and redemptions of units.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the MIP at net asset value.

### 6. Exempt Party-in-Interest Transactions

Certain investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

### 8. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, FMR LLC, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
