Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

Note 1: Description of the Plan

The following description of the Bruna Implement Employees' 401(k) Plan (the Plan) provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of Bruna Brothers Implement, LLC (the Company). Eligibility is age 18 for all contribution types and 3 months of service. An employee becomes eligible to enroll in the Plan on the first day of each plan quarter. Participants are eligible to receive employer matching and non-elective contributions at 1 year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and later amendments.

Plan investments were in the custody of Voya Retirement Insurance and Annuity Company (the Custodian). These assets consist primarily of shares in various mutual funds.

Participant Contributions - Self Directed

Participating employees may elect to enter into a contribution reduction agreement to reduce compensation up to the maximum allowable (100%) not to exceed IRS limits, which will be contributed to the Plan in their name. The Plan also permits Roth contributions. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, money market funds and pooled separate fund as investment options for participants. The Plan also offers target date fund choices which are pre-determined allocations of the available mutual funds.

The Plan may accept a proper rollover from another qualified plan.

Employer Contributions

The Company made a discretionary matching contribution up to 50% of the deferral up to 6% for December 31, 2024 and 2023.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make a profit sharing contribution, as defined in the Plan document. For December 31, 2024 and 2023, the Company did not elect to make a profit sharing contribution. This contribution is invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. All cost, fees, and expenses associated with the participant's account maybe charged or deducted from the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer match contributions and profit sharing contributions are based on years of service and subject to a six year graded vesting schedule.

Participant Loans

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at a rate of 1% over prime. Loan repayments are made ratably through payroll deductions. Generally loans may not exceed five years and only one loan is allowed at a time.

At December 31, 2024 and 2023 there were no participant loans in default.

Benefits

Distributions are made upon death, disability, retirement or termination of employment. The participant may receive a lump-sum amount equal to the value of their vested interest or a annuity payment. In-service distributions are permitted from the participant's deferral accounts. Benefits are recorded when paid.

Forfeitures

Employer match contributions are subject to a 6 year vesting period. Forfeitures can be used to reduce employer contributions or plan expenses. For the Plan years ending December 31, 2024 and 2023, forfeitures totaled \$11,391 and \$10,829, respectively. For the Plan years ending December 31, 2024 and 2023 forfeitures of \$25,068 and \$0, respectively, were used to reduce employer contributions or plan expenses. The balances of the forfeitures accounts were \$6,602 and \$18,925 for the years ending December 31, 2024 and 2023, respectively.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of the participants accounts or distributions are charged directly to the participant's account. Other expenses paid to Voya Retirement Insurance and Annuity Company or the third party administrator such as administrative fees are included in administrative expenses. Investment fees are paid through revenue sharing.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employee's payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by the Custodian as of the Plan year-end. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end.

Net appreciation (depreciation) includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions at year end.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Mutual Funds, Money Market Funds and Insurance Annuity Contract

Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Investment Account

The fair value of the Plan's fixed investment account are determined by the daily crediting of interest subject to a minimum rate in the contract. Investment transfers to and from the account, and withdrawals to pay participant benefits are made at contract value.

Note 4: Related Party and Party in Interest Transactions

The Plan Sponsor absorbs some administrative expenses of the Plan, cost of audit fees and the cost of fiduciary bonds. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements.

Investment related expenses are included in the administrative expenses. The third-party administrator, ERP Retirement Solutions, Inc. is paid fees through revenue sharing with the Custodian. These transactions qualify as exempt party-in-interest transactions.

Administrative functions are performed by officers or employees of the Company. Additional party-in interest transactions include audit fees paid to Varney & Associates, CPAs, LLC and investment fees paid to CreativeOne Wealth, LLC. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time subject to the provisions of ERISA. In the event of termination, each participant will have a non-forfeitable interest in his/her entire individual account.

Note 6: Tax Status

The Company adopted a non-standardized prototype plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8: Information Prepared and Certified by Custodian (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and loans to participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

Note 9: Reconciliation of Financial Statements to Form 5500

The net assets available for benefits per the financial statements at December 31, 2024 and 2023 reconcile to Schedule H of Form 5500.

Note 10: Subsequent Events
