Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Liebert Cassidy Whitmore Profit Sharing/401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Liebert Cassidy Whitmore Profit Sharing/401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Liebert Cassidy Whitmore Profit Sharing/401(k) Plan and Trust (the Plan), provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a qualified defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). It is designed to provide both current economic security and retirement benefits to employees of Liebert Cassidy Whitmore, A Professional Corporation (the Company). The Plan covers all eligible employees of the Company who are age twenty-one or older.

A Retirement Plan Committee has been appointed by the Company's Board of Directors to provide day-to-day administration, management and oversight of the Plan. The Plan's assets were held by Transamerica Life Insurance Company, and the recordkeeper was Transamerica Retirement Solutions, LLC through April 7, 2024. Effective April 8, 2024, the Plan's Trustee and recordkeeper changed to Fidelity Management Trust Company (Fidelity or the Trustee) and Fidelity Workplace Services, LLC, respectively.

Eligibility and entry date – Until August 31, 2023, employees were eligible to make salary deferrals once they had reached the age of 21 and had worked at least three consecutive months and 250 hours of service within that time period. If an employee had not worked at least 250 hours during the first three months of employment, they would become eligible once they had completed 1,000 hours of service or 12 full calendar months of employment. Effective September 1, 2023, the minimum hours requirement was eliminated. Employees are eligible to participate in the Plan by making salary deferrals on the first day of the month following the date the eligibility conditions described above are satisfied.

Employees are eligible to receive employer matching contributions and employer profit-sharing contributions once they have reached the age of 21 and have completed a year of service (1,000 hours during an eligibility computation period). An employee's first eligibility computation period is their first 12 months of employment; thereafter, it is the twelve months within each Plan Year (October 1 through September 30). Employees will be eligible to participate in the Plan by receiving employer matching contributions and employer profit-sharing contributions on the first day of the Plan Year or the first day of the seventh month of the Plan Year, coinciding with the date the eligibility conditions described above are satisfied.

Contributions

Participant contributions – Employees may elect to contribute on a pre-tax basis and/or make Roth contributions at their discretion up to the Internal Revenue Service maximum for the applicable calendar year but not to exceed 75% of their compensation during the Plan year. Participants may also make rollover contributions which represent distributions from other qualified defined benefit or defined contribution plans.

Liebert Cassidy Whitmore Profit Sharing/401(k) Plan and Trust

Notes to Financial Statements

Employer match and profit-sharing contributions – Employer contributions consist of matching contributions and profit-sharing contributions. On behalf of each employee who is eligible to share in matching contributions for the plan year, a matching contribution is made equal to 25% of each such employee's deferred compensation for salary reductions up to 4% of the participant's annual compensation. The Company may also elect to make discretionary profit-sharing contributions to the Plan. The profit-sharing contribution for the year ended December 31, 2024, was \$1,794,389.

Participant accounts – Each participant's account is credited with the participant's contribution, employer matching contributions, and allocations of (a) the Company's profit sharing contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants will be credited with a year of service in each year in which at least 1,000 hours are worked. Employer contributions, and earnings thereon, become vested to the extent of twenty percent (20%) after two years of continuous service and increases by twenty percent (20%) annually for each additional year of continuous service. A participant is one hundred percent (100%) vested after six years of credited service.

Participant loans and hardship withdrawals – Participant loans are not permitted. However, participants may withdraw the employee deferred portion from their fund accounts for reasons of financial hardship, as defined by regulations issued by the Internal Revenue Service under Internal Revenue Code (IRC) Section 401(k).

Payment of benefits – Benefits are recorded when paid. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or under a deferred payment schedule if so elected. For terminations of service due to other reasons or payment of benefits due to financial hardships, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

If a participant's total vested interest is between \$1,000 and \$5,000 when employment is terminated and the participant does not request a distribution, the total vested balance will automatically be rolled over to an IRA provider selected by the Plan Administrator. If the total vested interest exceeds \$5,000, no distribution will be made from the Plan without the participant's consent. If the total vested interest is \$1,000 or less, the entire vested interest will be distributed to the participant, even if the participant does not consent to the distribution.

Forfeitures – The portion of a participant's interest which is not vested upon the employee's break in service is forfeited. The non-vested forfeited balances are available to reduce the employer matching contribution and/or profit-sharing contribution. During the year ended September 30, 2024, forfeitures applied to reduce Company contributions totaled \$25,268. Forfeitures were not used to reduce employer contributions for the year ended September 30, 2024.

Unallocated funds – The Plan holds assets in an unallocated account that relate both to forfeitures and the expense budget account. Forfeitures are available to reduce future employer contributions. The expense budget account is funded from plan service fees and monthly credits and used for the payment of administrative expenses. There were no amounts in unallocated funds accounts relating to forfeitures for the year ended September 30, 2024. As of September 30, 2023, amounts in the unallocated funds account relating to forfeitures were \$24,915, and the amounts in the expense budget account were \$28,848, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments – Participant-directed investments (Plan Assets) are invested in a variety of different investment options and are invested based solely upon instructions received from participants. Participants can direct their employee and employer contributions among any of the investment options offered by the Plan. No assurance of actual fund performance can be given.

Investments valuation and income recognition – The Plan's investments are stated at fair value. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan's net appreciation in fair value of investments includes realized and unrealized gains and losses on investments purchased and sold, as well as held by the Plan during the year.

Expenses – Recordkeeping fees are charged and deducted from Plan Assets. Mutual fund sales charges and annual expenses charged by fund managers, investment advisor fees charged by NFP and third-party administrator fees charged by CBIZ are also deducted from Plan Assets, along with other administrative expenses.

The recordkeeper utilizes an expense budget account for the purpose of paying plan expenses. Funding comes from plan service fees and monthly credits are transferred to the expense budget account for the payment of administrative expenses.

The Plan charges an annual maintenance fee to participants who are no longer employed by the Company but still maintain an account with the Plan. These fees can be used to offset the Plan expenses.

No credits were used to offset administrative expenses during the Plan year ended September 30, 2024. Plan expenses exceeding the credits available were borne by the Company.

Reclassification – Certain amounts from the prior year statement of net assets available for benefits have been reclassified in order to conform to the current year presentation.

Note 3 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Fidelity, qualified institutions :

- Investments and unallocated funds reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023.
- Net appreciation in fair value of investments, interest, and dividends, on the accompanying statement of changes in net assets available for benefits for the year ended September 30, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to modify, amend or terminate the Plan at any time, subject to the provisions of ERISA. Upon complete discontinuance of Company contributions or the termination or partial termination of the Plan, each affected participant's account shall become fully vested. Distributions to participants of the entire amount of their accounts shall be made in accordance with the normal distribution policy of the Plan.

Note 5 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Administration of Plan Assets

The Retirement Plan Committee has the authority and duty to select the record keeper of the investment portfolio and oversee management of the Plan assets. Participants direct the investment of all contributions into various investments offered under the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 7 – Party-in-Interest Transactions

Certain Plan investments are managed by Transamerica Life Insurance Company. Transamerica Retirement Solutions, LLC, is the recordkeeper of the Plan and an affiliate of Transamerica Life Insurance Company. Therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

The Plan invests in funds which invest in securities of foreign countries, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those securities of comparable U.S. companies.

Note 9 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at September 30, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Stable value fund – Valued using the NAV practical expedient of units held by the Plan in the stable value fund. The NAV is based on the fair value of the underlying investments held by the stable value fund. There are no unfunded commitments or redemption restrictions on the fund.

Collective trusts – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported and published daily by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
