December 31, 2024 and 2023

Note 1. Description of the Plan

The following description of the Bonitz, Inc. Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution employee stock ownership plan (ESOP) covering substantially all employees of Bonitz, Inc. and participating subsidiaries (the “Company”) who have completed one year of credited service consisting of 1,000 hours and are employed on the last day of the Plan Year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Argent Trust Company (the “trustee”).

Plan amendment:

The Plan was amended on January 1, 2023, to increase the normal retirement age to 65 years of age for participants who enter the Plan after January 1, 2024. The normal retirement age for participants in the Plan prior to January 1, 2024 will remain at 60 years.

Contributions:

Each year, the Company may contribute shares or cash to the Plan as determined by the Board of Directors. Company contributions are allocated among participants’ accounts based on participants’ eligible compensation, in relation to total compensation. For the year ended December 31, 2024, the Company made \$2,100,000 in contributions to the Plan.

Participant accounts:

Participants who are actively employed on the last day of the Plan Year and have worked 1,000 hours during the Plan year are eligible to share in the allocations of any contributions made for that Plan Year, as well as forfeitures of terminated participants’ nonvested accounts. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s account balance, relative to total plan assets. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting:

If a participant’s employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. A participant is 100 percent vested after 6 years of credited service, in accordance with the gradual vesting schedule.

Voting rights:

The trustee of the Plan usually decides how shares of Company common stock held by the Plan will be voted. However, with respect to certain corporate matters presented to the Company’s shareholders for a vote, such as a merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of the business or similar transaction, each participant will be entitled to give directions as to the voting of the shares of Company common stock allocated to his or her account. If the participant does not provide the trustee with voting instructions, the shares will be voted in the manner determined by the trustee.

Note 1. Description of the Plan, Continued

Put option:

The Company common stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitation includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market within the two put option periods. The put price is representative of the fair market value of the stock as determined by an independent valuation specialist. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. The first put option period is at least 60 days beginning on the date of distribution. The second put option period is for at least 60 days beginning after the new determination of fair market value (and notice to all participants thereof). No put options were received during 2024.

Payment of benefits:

No distributions from the Plan will be made until a participant retires, becomes permanently disabled, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share. On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. All fully vested balances are available for distribution after the participant reaches the age of 60 for participants who entered the Plan prior to January 1, 2024. For participants entering the Plan after January 1, 2024, fully vested balances are available for distribution after reaching age 65.

Forfeited accounts:

Forfeited nonvested amounts are treated as additional Company contributions and are reallocated among active participants' accounts. Allocations are based upon the relation of the participant's total eligible compensation to total eligible compensation for the Plan. Forfeitures totaling \$482,539 and 18.59 shares of Company common stock were reallocated during the year ended December 31, 2024.

Diversification:

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of his or her account less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify may receive their distribution in the form of cash, Company common stock or direct transfer of shares to another qualified plan, as defined by the plan document.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Company's common stock is valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the independent appraisal. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses:

The majority of expenses incurred to maintain the Plan are paid by the Company and are excluded from these financial statements.

Payment of benefits:

Benefits are recorded when paid.

Subsequent events:

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 3. Administration of Plan Assets

The Plan's assets, which consist entirely of the Company's common stock, are held by the trustee of the Plan. Company contributions are held and managed by the trustee, who makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Company.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Company common stock: Value is determined by an independent valuation specialist using unobservable inputs. Factors considered in determining the fair market value included historical and projected cash flow and net income, return on assets, return on equity, and market comparables.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value of Level 3 Assets:

The Plan acquired 68 shares valued at \$2,100,000 of Level 3 investments during the year ended December 31, 2024. Additionally, 261 shares valued at \$8,077,308 of Level 3 investments were sold during the year ended December 31, 2024.

Note 6. Related-Party and Party in Interest Transactions

The Plan invests in Company common stock. As described in Note 3, the Company pays the expenses of the Plan. Also described in Note 3, the Plan assets are held by the trustee. The trustee is a party in interest under ERISA. These are related-party and party in interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. In the event of Plan termination, participants would become 100 percent vested in their Company contributions

Note 8. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated August 18, 2017, stating that the Plan is qualified under the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in the Company's common stock. The common stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and/or other such techniques. Due to the level of risk associated with the investment in the common stock, and to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in the values of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
