INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of
the Travelpro 401(k) Employee Benefit Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Travelpro 401(k) Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Travelpro 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Travelpro 401(k) Employee Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Travelpro 401(k) Employee Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Travelpro 401(k) Employee Benefit Plan's internal control. Accordingly, no such opinion is expressed.



- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Travelpro 401(k) Employee Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, line 4i – Schedule of Assets (Held at End of Year), referred to as “supplemental information,” as of or for the year ended December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Travelpro 401(k) Plan (the “Plan”) provides only general information. More complete information regarding items such as employee and employer contributions, eligibility, vesting, and benefit provisions, may be found in the Plan document. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, which is available upon request.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was adopted effective January 1, 1994, by its sponsor, Travelpro Products, Inc. (the “Company”).

The Plan is administered by a designated employee of the Company who is responsible to, and serves at the discretion of, the Company. The designated employee is responsible for providing information to participants and also has the primary authority for filing various reports, forms and returns with the U.S. Department of Labor and Internal Revenue Service (“IRS”). The HR Director has been designated by the Company to serve as the administrator for the Plan for the period under audit. The Plan administrator has delegated the record-keeping function of the Plan to The Standard, formally known as Securian Retirement Services, a business unit of Minnesota Life Insurance Company, for the period through December 31, 2024.

Eligibility Requirements

To become eligible to participate in the Plan, employees must be the age of 21 and must have completed 6 months of service. Participants may enter the Plan as an active member on the first day of the month coinciding with or next following the date they become eligible.

Contributions

For the Plan year ended December 31, 2024, annual additions paid to a participant’s account cannot exceed the lesser of 100% of the participant’s salary or \$58,000 of combined employee and employer contributions. For Plan purposes, the participant’s base compensation is W-2 compensation. Contributions are subject to certain limitations established by the Internal Revenue Service. The maximum pre-tax contribution for the years ended December 31, 2024 and 2023 was \$23,000 and \$22,500, respectively.

The Plan provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make a catch-up contribution. For the 2024 and 2023 Plan years, a maximum catch-up contribution of \$7,500 was allowed, respectively.

The Company will match 50% of the amount each participant contributes to the Plan up to 3% of the participant’s pre-tax compensation.

Rollovers

The Plan accepts rollover contributions from other tax-qualified plans for those participants who choose to invest in the Plan.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Participants may receive an amount equal to the value of their vested interest upon the termination of employment, death, disability, or retirement. The form of payment is a lump sum distribution, or participants may have their account balance transferred to an individual retirement account or other qualified plan.

Funds can be accessed prior to the date they become distributable by way of a hardship withdrawal. Hardship withdrawals can be made for any event that constitutes an "immediate and severe financial need" as prescribed by current IRS guidelines.

Participant Accounts

Each participant account is credited with the participant's contribution, an allocation of the Company's contribution, and the Plan's earnings and losses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Percentage

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested in the Company's contributions after four years of credited service.

Forfeitures

Forfeited amounts are reallocated to participants in the same manner as employer contributions. Forfeited nonvested accounts of \$15,543 and \$4,500 were used to reduce employer contributions for the year ended December 31, 2024 and 2023, respectively.

Death and Disability Provisions

Upon death and disability of participants, the accrued benefits will be paid to the beneficiaries as designated by the participants.

Plan Termination and Amendments

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. However, an amendment to the Plan (other than an amendment required to obtain or retain approval of the Plan under the Internal Revenue Code ("IRC") or other statute or any regulation or ruling thereunder) cannot retroactively deprive participants of their accrued benefit or interests. If the Plan is terminated, each participant account becomes 100% vested.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions to be vested in one or more of the investment options available to the Plan.

Notes Receivable from Participants

On March 27, 2020, the Pandemic began, and Congress passed the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act. Section 2202 of the CARES Act, enacted on March 27, 2020, allowed plan sponsors to amend their 401(k) plans to allow for coronavirus-related loans to qualified individuals. For those plans that were amended to allow for these loans, the maximum loan amount available to qualified individuals for loans made from March 27, 2020, to September 22, 2020, was increased to the lesser of: (1) \$100,000 (minus outstanding plan loans to the individual), or (2) the individual's vested benefit under the plan. If a loan was outstanding on or after March 27, 2020, and any repayment on the loan was due from March 27, 2020, to December 31, 2020, that due date may have been delayed under the plan for up to one year. Any payments made after the suspension period are adjusted to reflect the delay and any interest accrued during the delay.

For all others, the maximum amount of a participant's outstanding loans cannot exceed the lesser of \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans during the one-year period ending on the day before the new loan is made, over the outstanding balance of loans from the Plan on the date the new loan is made, or one-half of the participant's vested interest in the Plan. A participant may not request a loan for less than \$1,000, nor may a participant have more than two outstanding loans at any one time. Principal and interest are paid ratably through payroll deductions.

Loans are provided at a commercially reasonable rate of interest determined by reviewing the interest rates charged for similar types of loans by other lenders. Interest rates are fixed for the duration of the loan. Normally, the maximum term of any loan is five years unless the proceeds are to be used to acquire a principal residence of the participant. Loans are secured by no more than one-half of the participant's vested account balance.

Concentration of Credit Risk

Concentration of credit risk with respect to notes receivable from participants is limited due to the note receivable being secured by 50% of the participant's vested account balance and the maximum loan amount allowed per the loan policy.

SECURE 2.0 Act

SECURE 2.0 was signed into law with the Consolidated Appropriations Act in December 2022. It contains numerous provisions related to retirement plans to assist with making it easier to establish new retirement accounts, creates automatic enrollment rules for participants, and more. The Standard has implemented provisions to support SECURE 2.0 effective Jan 1, 2025.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Investment Valuation and Income Recognition

The Plan provides for investments in pooled separate accounts and a general account, which is held within a fully benefit-responsive Group Annuity Contract (“GAC”). The units of pooled separate accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Investments in pooled separate accounts are stated at the corresponding unit value of the pooled separate account. Assets within the pooled separate accounts include fixed maturity securities, equity securities and cash and cash equivalents.

Investment Valuation and Income Recognition (Continued)

In accordance with FASB ASC Topics 946 and 962, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Under the definition referenced in ASC Topic 962, the contract provided by the Plan is fully benefit-responsive. Therefore, the general account is reported at contract value in the statements of net assets available for benefits. In addition, the statement of changes in net assets available for benefits is prepared using contract value for the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Any gain or loss resulting from the sale of fund units is determined as the difference between the sales proceeds and the cost of units sold.

The Plan presents in the accompanying statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments in pooled separate accounts, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Participant Loans

FASB ASC 962-310-45-2 requires participant loans to be classified as notes receivable from participants and measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent contributions receivable from participants are recorded as distributions based upon the terms of the Plan document.

Risk and Uncertainties

The Plan invests in mutual funds, which invest in various securities including corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate risk, market risk, credit risk and overall market volatility.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the value of participants’ account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are deducted from investment earnings before those earnings are credited to participants' accounts. Audit fees are paid by the Company.

Excess Contribution Payable

The Plan is required to return contributions received during the plan year in excess of the IRC limit. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in February 2025.

Date of Management's Review

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – TAX STATUS

The Plan is in the form of a defined contribution pre-approved plan, sponsored by Travelpro Products, Inc. The IRS ruled that the Plan qualifies under Section 401(a) of the IRC and is, therefore, exempt from income taxes. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the plan administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition as a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 4 – FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 - other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.)

Level 3 - significant unobservable inputs (including management's own assumptions in determining the fair value of investments).

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Pooled Separate Accounts:

The value of the units held in pooled separate accounts are based on quoted market prices of the underlying investments and are based on the Net Assets Value "NAV" of the shares held by the Plan at year end. The NAV is based on the value of the underlying investments owned by the fund, minus its liabilities and administrative expenses, and then divided by the number of shares outstanding. In determining fair value, the market approach is used which utilizes process and other relevant information generated by market transactions involving identical generated assets or liabilities. Observable inputs reflect the assumptions market participants would use in valuing a financial instrument based on market data obtained from independent sources.

ASU No. 2015-07, *Fair Value Measurement (Topic 820): Disclosure for Investments in Certain Entities That Calculate Net Asset Value per Share (or its Equivalent)*, removes the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the NAV per share practical expedient. As such, as of December 31, 2024 and 2023 investments held in pooled separate accounts and measured at fair value have not been categorized within the fair value hierarchy.

Insurance Company General Account:

Insurance company general account is measured at contract value for financial statement purposes. ASU No. 2015-12 *Defined Benefit Pension Plans (Topic 960): (Part I) Fully Benefit-Responsive Investment Contracts, Defined Contribution Pension Plans (Topic 962) and Health and Welfare Benefit Plans (Topic 965)*, includes removing the fully benefit-responsive investment contract from the fair value hierarchy and other Topic 820 fair value disclosures for all periods presented.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE 5 – INSURANCE COMPANY GENERAL ACCOUNT

In 2003, the Plan entered into a fully benefit-responsive Group Annuity Contract (“GAC”) with Minnesota Life Insurance Company (“Minnesota Life”) to fund the Plan. The GAC offers a general account plus various pooled separate accounts, from a variety of investment managers.

The ML General Account 3 is an investment option available through a group annuity contract issued by Minnesota Life Insurance Company. It is an insurance contract, not a mutual fund or bank product, and is backed by the full faith and credit of the Insurance Company. The contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity is available at contract value for participant transactions.

Contract value is considered an appropriate measurement for financial reporting purposes and approximates fair value. The plan’s ML General Account 3 is a general liability of Minnesota Life Insurance Company; there are no segregated or identifiable assets ascribed to the plan.

As of December 31, 2024 and 2023, the contract values and crediting rates were:

Crediting rates are declared annually and guaranteed to be no less than 0.10%. Rates are determined based on asset yield forecasts and business margins, and once declared, apply to contributions for a set duration.

Liquidity and Transfer Restrictions:

- Daily liquidity is available, but the Insurance Company may defer withdrawals or transfers for up to 90 days, with an additional 90 days under special investment conditions.
- Transfers to competing investment options are limited to 5% of a participant’s balance. After any transfer out, no transfers into either a competing option or the ML General Account 3 are allowed for 90 days.
- Certain events (e.g., plan termination, layoffs, divestitures) may trigger market value adjustments or withdrawal restrictions.

Termination Provisions: The Insurance Company may terminate the contract with 90 days’ notice for reasonable cause. Market value adjustments may apply upon termination.

NOTE 6 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Under the Department of Labor’s Rules and Regulations, certain assets and related information held by a bank, trust company or similar institution, or an insurance company, that is regulated and subject to periodic examination by a state or federal agency does not have to be audited, provided the plan administrator exercises this option and the institution holding the assets certifies the required information. Standard Insurance Company and Minnesota Life Insurance Company have provided certification as to the completeness and accuracy of the investments and related transactions, including investment income, participant loans and fees, as presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and in the statement of changes in net assets available for benefits for the year ended December 31, 2024. The accompanying supplemental schedule also includes investment information certified by Standard Insurance Company and Minnesota Life Insurance Company as being complete and accurate.

NOTE 8 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan assets include certain investments managed by The Minnesota Life Insurance Company, the Plan's custodian. The Standard, an affiliate of The Minnesota Life Insurance Company, performs recordkeeping and administrative functions such as handling contributions and benefit payments. Accordingly, these transactions are considered party-in-interest transactions and are exempt from prohibition under ERISA of 1974.

NOTE 9 – NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants represent participant loans that are secured by the participants' account balances and bear interest at rates that range from 5.25% to 10.50% with maturities from January 2025 to August 2048. As of December 31, 2024, the balance of notes receivable from participants was \$87,314. Included in this balance are loans that have been deemed distributed under Internal Revenue Code Section 72(p) due to noncompliance with loan repayment provisions. These loans are considered taxable distributions to the participants and are reported on Form 1099-R in the year of default. However, for financial reporting purposes, such loans remain classified as notes receivable until a distributable event occurs, or the plan administrator formally writes off the loan. As of December 31, 2024, the balance of deemed distributed loans included in notes receivable from participants was \$9,911.

NOTE 10 – RECLASSIFICATION OF PRIOR YEAR AMOUNTS

In the Statement of Net Assets Available for Benefits as of December 31, 2024, the Plan separately presents Interest-bearing cash and Pooled separate accounts, at fair value as distinct line items. In the prior year's Statement of Net Assets as of December 31, 2023, these amounts were combined and presented as a single line item. For comparative purposes, the 2023 amounts have been reclassified in the 2024 financial statements to conform to the current year's presentation. This reclassification had no impact on the total net assets available for benefits as of December 31, 2023.

NOTE 11 – SUBSEQUENT EVENT

Closure of Securian Asset Management Separate Accounts

On July 17, 2025, the Plan received notification from Securian Asset Management regarding the planned closure and liquidation of its Separate Accounts by the end of calendar year 2025. As of the notification date, the Plan's investment lineup included one or more of these Separate Accounts.

In response to this development, the Plan sponsor, in coordination with its recordkeeper, The Standard, has scheduled the replacement of the affected investment options with comparable alternatives. Unless otherwise directed by the Plan sponsor, the following fund changes will be implemented on the dates indicated:
