Notes to Financial Statements

**Terra Dotta, LLC 401(k) Plan**

Year Ended December 31, 2024

NOTE A--PLAN DESCRIPTION

The following brief description of the Terra Dotta, LLC 401(k) Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, established January 1, 2023, covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility: Employees are eligible to participate in the Plan on their date of hire and upon attaining age 21.

Directed Investment Accounts: The Plan permits every participant to direct the investment of his account balance under the Plan. Participants may invest their Plan accounts in any or all of the investment funds offered by the Plan.

Contributions: Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan. The participants may also make contributions to a Roth account and after tax contributions. Certain participants may also catch-up contributions in accordance with IRS guidelines. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Unless an election as defined by the Plan is made, employees are automatically enrolled in the Plan and deemed to have elected to contribute 5% of eligible compensation. Participants may stop or change this election at any time.

The Plan allows for discretionary matching contributions. During 2024, the Company elected to make discretionary matching contributions equal to 100% of the first 5% of eligible employee deferrals. Those matching contributions totaled \$440,486 for the year ended December 31, 2024.

The Company may make discretionary nonelective contributions. Discretionary nonelective contributions are allocated based on the eligible compensation of participants for the Plan year. The Company made no discretionary nonelective contributions in 2024.

Participant Accounts: Each participant's account is credited with the participant's and Company contributions and allocation of earnings. The participant's account is charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and an allocation of losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Funding Policy: The employer is generally required to pay its contribution to the Plan for each Plan year within the time prescribed by law, including extensions of time for the filing of the employer's federal income tax return for the fiscal year. However, employee elective contributions accumulated through payroll deductions shall be paid to the custodian as of the earliest date on which contributions can reasonably be segregated from the employer's general assets, but in any event, within the time prescribed by law. Furthermore, any additional employer contributions which are allocable to participants' accounts for a Plan year shall be paid to the Plan no later than the twelve-month period immediately following the close of such Plan year.

Payment of Benefits: A participant is entitled to distributions under the Plan (a) when such participant attains their 59 1/2 birthday (the normal retirement date) or the later of the participant attaining their fifty-fifth birthday or five years of vesting service (early retirement date); (b) in the event of the death of the participant before retirement or other termination of employment; (c) in the event of the participant's total or permanent disability; (d) in the event that a participant's employment is terminated for any reason other than those stated in (a) through (c) above; or (e) in the event of a financial hardship as defined by the Plan.

NOTE A--PLAN DESCRIPTION--Continued

Participants entitled to distributions may elect a lump-sum distribution or annual installments.

Vesting: Vesting in any Company nonelective contributions is based on years of service as follows:

Forfeitures: The nonvested portion of a terminated participant's account balance derived from employer contributions is forfeited on the earlier of the last day of the plan year in which the former participant incurs (5) consecutive 1-year breaks in service or distribution of the vested portion of the participants account. At December 31, 2024, forfeited nonvested accounts totaled \$11,117. Forfeitures are first used to pay administrative expenses and then to reduce any future employer contributions.

Notes Receivable from Participants: Loans are granted at a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the vested account balance, whichever is less, and bear interest at the prime rate. The loans are secured by the balance in the participant's account with principal and interest to be paid ratably through payroll deductions. All loans must be repaid within five years unless the loan is for the purchase of the participant's principal residence. Then, the loan must be repaid within a thirty-year period.

Hardship Withdrawals: Withdrawals due to financial hardship are permitted with the approval of the Administrator for an immediate and heavy financial need based on the facts and circumstances. Examples include medical expenses, purchase of primary residence, post-secondary tuition payment, eviction from or foreclosure on principal residence, funeral expenses, or as otherwise provided by the Plan. Hardship withdrawals are limited to employee elective deferrals and earnings thereon.

Rollover Contributions: The Plan provides for rollover contributions from other qualified retirement plans.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

Investment Options: The investments of the Plan are held by The Standard Insurance Company (“Standard”), custodian of the Plan. Standard executes investment transactions within the guidelines adopted for each fund. At December 31, 2024, participants could direct the investment of their account balances in the following mutual funds: JP Morgan Large Cap Growth R6 Fund, Vanguard MDCP Value Index Adm Fund, JP Morgan Mid Cap Growth R5 Fund, Fidelity Small Cap Index Fund, Vanguard Explorer Admiral Fund, Fidelity Global ex U.S. Index Fund, Vanguard Balanced Index Admiral Fund, Vanguard Equity Income Adm Fund, Fidelity 500 Index Fund, Fidelity Advanced Total Bond I Fund, Vanguard Target Retirement 2025 Fund, Vanguard Target Retirement 2040 Fund, Vanguard Target Retirement 2045 Fund, Vanguard Target Retirement 2055 Fund, and Standard Stable Asset D Fund.

Contributions: Employer and employee contributions are accrued in the Plan year to which they relate.

Payment of Benefits: Benefit payments are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Accordingly, actual results may differ from those estimates.

Date of Management’s Review of Subsequent Events: Plan management has evaluated events through October 14, 2025, the date which the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 “*Fair Value Measurements*” are as described as follows:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the NAV of units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments and participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The pooled separate accounts are not required to be classified within a level on the fair value hierarchy.

**NOTE D--INVESTMENT CONTRACTS**

Effective December 31, 2024, the Plan's investment in its fully benefit-responsive investment contract was liquidated into cash. As a result there was no investment contract held by the Plan on December 31, 2024.

At December 31, 2023, the Plan held an investment in a fully benefit-responsive investment contract. The investment is credited with earnings from the underlying investments and charged with withdrawals and expenses. The contract value of the investment was \$127,841 as of December 31, 2023. The crediting interest rates are based on an agreed-upon formula with the issuer.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974 (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE E--RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by The Standard Insurance Company the trustee and contract administrator of the Plan, therefore, related transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management services were \$28,238 for the year ended December 31, 2024.

**NOTE F--TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust, are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the Determination Letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE G--PLAN TERMINATION

While the Company has not expressed an intent to terminate the Plan, it is free to do so at any time subject to the provisions of ERISA. The Company also reserves the right to amend the Plan as conditions may require. However, neither through amendment, nor by termination, may any part of the Plan assets ever be returned to the Company. All assets of the Plan must be used for the exclusive benefit of participants.

NOTE H--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE L--ADMINISTRATIVE ERRORS**

During 2023, the Plan sponsor became aware that the proper vesting parameters were not setup when the Plan was originally established. As a result, certain participants who took distributions in 2023 were incorrectly 100% vested. The Plan sponsor is working with its plan custodian to restore participant balances to their proper amount. The Plan sponsor does not believe the issue will have a material impact on the financial statements.

During 2024, the Plan sponsor determined that a certain eligible compensation code was improperly excluded from employee deferrals. The Plan sponsor is working with its plan custodian to restore participant balances to their proper amount.
