## INDEPENDENT AUDITOR'S REPORT

To the 401(k) Committee  
of the TELACU Accumulation Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TELACU Accumulation Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of TELACU Accumulation Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TELACU Accumulation Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TELACU Accumulation Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the TELACU Accumulation Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**1. General**

The Plan is a defined contribution plan established by The East Los Angeles Community Union (“TELACU”) and its subsidiaries (collectively, the “Employer”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan provides for a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer. The 401(k) Committee, which includes the plan administrator, is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance. VOYA Retirement Insurance and Annuity Company (“VOYA”, the “Custodian”) and Citizens Business Bank (“CBB”, the “Former Trustee”), and VOYA Institutional Trust Company (“VOYA Trust”, the “Successor Trustee”) are responsible for the custody and management of the Plan’s assets (see Note J). The Employer also utilizes the services of a third-party administrator (“TPA”) (see Note E).

Effective October 1, 2023, the Former Trustee ceased trustee and other responsibilities, and the Successor Trustee assumed trustee responsibilities. In addition, the TPA assumed the recordkeeping responsibilities for notes receivable from participants.

**2. Eligibility**

All non-union, non-leased employees who are U.S. residents may participate in the Plan upon attainment of age 18 and completion of 30 days of service. The entry dates are on the first of each calendar month. Participants who are employed on the last day of the plan year are also eligible for Employer matching contributions based on the Plan’s provisions.

**3. Contributions**

Participants may elect to contribute, on a tax-deferred basis, up to 100% of their eligible compensation, subject to certain limitations under the IRC (see Note J). Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may direct contributions, as desired, in any of several investments offered by the Custodian. Participants may change their investment options daily. In addition, the Employer makes matching contributions to active and eligible participants in an amount equal to 20% of the participant’s deferred compensation.

The Employer may also make a discretionary profit-sharing contribution for each active and eligible participant, in an amount subject to determination on an annual basis by the Board of Directors of the Employer.

**NOTE A - DESCRIPTION OF THE PLAN (Continued)**

**4. Participant Accounts**

Each participant's account is credited with the participant's contributions and the Employer's matching contribution, as well as allocations of the Employer's discretionary profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of investment management expenses that are paid by the plan (see Note E). Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**5. Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000 less the highest outstanding loan balance during the prior twelve-month period) and are subject to a \$125 loan fee. A participant's loan is secured by the balance in the participant's account. Participants may have one loan outstanding at any time (see Note J). All loans shall bear a fixed rate of interest at the prime rate (as stated in the Wall Street Journal), plus 1%, determined at the date of issuance. Loans must be paid back within five years of the date of issuance in accordance with terms established by plan management. Loans for the purchase of a principal residence may be paid back within thirty years. Loans are due and payable upon the participant's termination of employment with the Employer.

**6. Vesting**

Employee contributions, Employer qualified non-elective contributions, rollovers and actual earnings on all such contributions are fully vested at all times. Vesting of Employer matching contributions, Employer discretionary profit-sharing contributions, if applicable, and actual earnings thereon, are based upon the participant's years of service with the Employer as follows:

**7. Benefit Payments**

Upon termination of employment with the Employer, a participant will receive a lump sum disbursement if his or her vested account balance is \$1,000 or less. Prior to January 1, 2024, if the vested account balance was between \$1,000 and \$5,000, a lump sum could be distributed directly to an individual retirement account unless the participant elected otherwise. Effective January 1, 2024, this threshold was increased from \$5,000 to \$7,000 (See Note I). For balances greater than \$7,000, the participant is entitled upon request to receive a lump sum amount. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. In addition, upon attaining age 59½, participants may receive distributions. Hardship withdrawals are also permitted if certain criteria is met.

**8. Administrative Expenses**

Certain expenses of maintaining the Plan are paid from the assets of the Plan, unless otherwise paid by the Employer (see Note A-9). Expenses that are paid by the Employer are excluded from these financial statements (see Note E). Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

**9. Forfeitures**

Forfeitures of terminated participants' nonvested accounts will be applied against future Employer contributions or to pay plan expenses. During the year ended December 31, 2024, \$39,895 of forfeitures was utilized to pay plan expenses (see Notes A-8 and E). As of December 31, 2024 and 2023, there was \$164,374 and \$104,754, respectively of unallocated forfeitures included in net assets available for benefits.

**10. Plan Amendments and Termination**

Although it has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**2. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**3. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The group pension funding contract is not considered fully-benefit responsive and is reported at fair value which equals contract value. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the Custodian and Former Trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**4. Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans if applicable, are reclassified as distributions based upon the terms of the plan document.

**5. Excess Contributions Payable**

If applicable, any amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding increase to deductions from net assets, or as a qualified non-elective contribution.

**6. Benefit Payments**

Benefits are recorded when paid.

**7. Subsequent Events**

Plan management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE C - CERTIFICATION BY CUSTODIAN**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all of the investment information, including investment income, included in the accompanying financial statements and supplemental schedules has been certified as complete and accurate by the Custodian of the Plan.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the fund’s net asset value reflecting all investments at fair value, including direct and indirect interests in mutual funds, as reported by the fund manager, held by the Plan at year end.

*Group pension funding contract:* Valued at net participant contributions plus credited interest calculated at a pro-rated yearly rate based on maturity date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

Realized gains from the group pension funding contract shown above represent interest income and are reported in interest and dividend income in the statement of changes in net assets available for benefits. Unrealized gains/(losses) from the group pension funding contract are not included in the statement of changes in net assets available for benefits as the contract is recorded at fair value which approximates contract value.

**NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

VOYA is the custodian for the participant-directed investment funds and also provides recordkeeping services to the Plan. The Former Trustee maintained notes receivable from participants and processed all plan level activity through October 1, 2023. The Successor Trustee provides trustee services to the Plan effective October 1, 2023. The TPA provides administrative services, and effective October 1, 2023, provides recordkeeping for the notes receivable to the Plan (see Note A-1). Therefore, all transactions with the Custodian, Former Trustee, Successor Trustee and TPA are considered exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than direct payment. Additional fees may be paid directly to the Custodian, Successor Trustee, TPA or other parties-in-interest (see Notes A-4, A-8 and A-9). Notes receivable from participants and the related interest income are considered related party transactions.

**NOTE F - INCOME TAX STATUS**

The IRS has issued an opinion letter issued to a service provider utilized by the TPA dated June 30, 2020, that the adopted non-standardized prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan did not seek a favorable determination letter with respect to the initial adoption of the plan document, nor with any plan amendments or restatements, plan management and the TPA believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H – PROHIBITED TRANSACTION**

During the year ended December 31, 2024, the Employer failed to remit one contribution for one participating subsidiary (isolated occurrence) to the Plan on a timely basis, as required by DOL Reg. 2510.3-102, resulting in a prohibited transaction. Plan management has computed and deposited the lost earnings for remittance to the Plan as of the date of these financial statements.

**NOTE I – PLAN AMENDMENT**

Effective January 1, 2024, the Plan implemented certain provisions of the “Secure” 2.0 Act (Setting Every Community Up for Retirement Enhancement) that was signed into law on December 29, 2022 (see Note A-7). The required amendment to the plan will be adopted by the final adoption date allowed by the IRS.

**NOTE J - SUBSEQUENT EVENTS**

On October 24, 2024, the 401(k) Committee elected to transfer custodial services from VOYA to Empower (“Empower”, the “Successor Custodian”) and the Plan was amended effective September 9, 2025. The change in service providers initiated a blackout period from September 2, 2025 through September 30, 2025, during which time participants could not request loans or distributions or make investment allocation changes. On October 1, 2025, plan assets totaling \$47,875,445 were transferred to Empower from VOYA (see Note A-1).

On August 1, 2025 the Plan was amended effective September 1, 2025 to allow for participants to have two loans outstanding at any one time (see Note A-5). In addition, effective January 1, 2026, participants may now elect deferrals on a Roth basis (see Note A-3). There were no other material modifications to the Plan.
