Notes to Financial Statements

Note 1: Description of Plan

The following description of the Prairie Ridge Health, Inc. Employer Matched 403(b) (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Prairie Ridge Health, Inc. is the Plan sponsor (the "Sponsor"), and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants direct their contributions and/or their account balances among the Plan's investment alternatives. All investments are participant-directed.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Eligibility and Participation

Substantially all employees of the Sponsor are eligible to participate in the Plan upon employment. To be eligible for the purpose of receiving Sponsor matching contributions, employees must complete one year of service, defined as completing 1,000 hours of service in a 12-month period, and must be 18 years of age or older. Eligible employees begin receiving Sponsor matching contributions immediately following the attainment of these requirements.

Contributions

Each year participants may contribute a portion of their total compensation, as defined by the Plan, not to exceed the maximum allowable limits under the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Sponsor will make a matching contribution equal to 4% of compensation, as defined in the Plan, if the participant has contributed at least 4% and has less than 10 years of service. If the participant has contributed at least 6% of compensation and has 10 years or more of service, the Sponsor will contribute a matching contribution equal to 5% of compensation. Participants with 10 or more years of service who contribute more than 4% and less than 6% will receive a 4% contribution match. Any participants who do not contribute at least 4% will not receive a matching contribution.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, Plan earnings (losses) thereon, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and Sponsor matching contributions plus actual earnings (losses) thereon.

Notes Receivable From Participants

Specific terms regarding notes receivable from participants are established by Lincoln Financial Group. Generally, participants may borrow from their account balance the lesser of \$50,000 or 50% of the participant's account balance, subject to the Plan's provisions and the respective contracts.

Certain notes with Lincoln Financial Group Trust Company, a division of Lincoln Financial Group, are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates as determined annually by the Plan Administrator. The interest rate on these loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payments by participants.

Certain notes with Lincoln National Life Insurance Company, a division of Lincoln Financial Group, are not from Plan asset dollars, but rather loaned directly from Lincoln Financial Group and, therefore, are not recorded as notes receivables from participants in the accompanying statements of net assets available for benefits. The notes are secured by the participant's balance in the Lincoln Financial Group Fixed Account. These notes bear interest at a rate determined by the Plan Administrator based on prevailing market conditions. Principal and interest is paid ratably by the participant to Lincoln Financial Group, and each payment will reduce amounts secured by the participant's balance in the Lincoln Financial Group Fixed Account. The amount of such outstanding notes was \$5,528 and \$50,716 at December 31, 2024 and 2023, respectively.

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination of employment up to the amount of the participant's account. Benefits may be paid in a lump sum distribution or installment distribution if the account balance is greater than \$1,000. Hardship distributions out of the participant's account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value, except for fully benefit responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor.

Expenses that are paid by the Sponsor including third-party administration and audit fees are excluded from these financial statements. Investment advisory and management fees are allocated proportionately to Plan participants based on their respective account balances. Loan fees are charged directly to the participant's account against the investment option for which the loan was originally charged.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that provides the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Lincoln Financial Group Fixed Account: Value derived from contract provisions, and contract value approximates fair value. In determining the reasonableness of the methodology, management evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms, while others are substantiated utilizing available market data (for example, interest rates).

Notes to Financial Statements

Note 4: Stable Value Fund with Lincoln Financial Group

The Plan entered into a fully benefit-responsive investment contract (Stable Value Fund) with Lincoln Financial Group. Lincoln Financial Group maintains the contributions in a general account. As described in Note 2, because the Stable Value Fund is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln Financial Group, represents contributions made under the contract, plus/less earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity was provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 5: Information Prepared and Certified by Custodians

Certain information disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information certified as complete and accurate by Lincoln National Life Insurance Company and Lincoln Financial Group Trust Company, divisions of Lincoln Financial Group, the Custodians of the Plan. This information includes investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024.

Note 6: Tax Status

The Plan's terms have been drafted in reliance on the sample language provided by the IRC. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. The Plan's management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-in-Interest Transactions

Plan investments are managed by the Custodians. Transactions with the Custodians are party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
