Independent Auditor's Report

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Crossett, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **NOTE A - DESCRIPTION OF PLAN**

The following description of Crossett, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General and Eligibility:**

The Plan, established on April 1, 2007, is a defined contribution 401(k) plan that covers all employees of Crossett, Inc. (the Company and Plan Sponsor). Employees become eligible to participate in the Plan upon completing at least one month of service. The Plan is administered by the Company and Principal Trust Company serves as the Plan's trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions:**

Each year, participants may contribute up to the legal limit of pre-tax annual compensation, as defined by the Plan, not to exceed the limits of Internal Revenue Code Section 401(k) of \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of a maximum of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans.

Participants covered by a collective bargaining agreement, union participants, are eligible to receive non-elective employer contributions in varying amounts as defined in the collective bargaining agreement. Participants not covered by a collective bargaining agreement, non-union participants, are eligible to receive a discretionary profit-sharing contribution made by the Company following one month of service.

A participant may elect to have their account invested in one or more of the investment funds established by the trustee of the Plan.

#### **Participant Accounts:**

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, Plan Sponsor's contributions, an allocation of the change in market value of the underlying investment, which is based on units owned of the investment, and charged with an allocation of investment fees, which is based on a percentage of the value of the participant's assets.

Each day the investment income and the net realized and unrealized appreciation and depreciation on investments are allocated to participant accounts based on each participant's pro-rata share of the fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

**Forfeitures:**

Non-vested portions of terminated participants' accounts represent forfeitures. The plan document permits the use of forfeitures to pay administrative expenses or to reduce employer contributions. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions at year end shall be allocated as follows. Forfeited amounts resulting from employer non-elective contributions and earnings thereon may be used to reduce future contributions made by the employer. Forfeited amounts resulting from employer profit sharing contributions and earnings thereon are allocated to participants at the end of the plan year. During 2024, the Plan Sponsor utilized \$57,758 of forfeited monies to reduce employer contributions and \$15,476 to pay administrative expenses.

**Investments:**

Participants direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily, subject to certain restrictions on transfer frequency for certain investments. The Plan offers various mutual funds as investment options for participants.

**Vesting:**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer non-elective contributions and discretionary profit-sharing contributions is based on years of service. Participants are vested in the Company's contributions plus actual earnings thereon as follows:

#### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

##### **Participant Notes Receivable:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant is limited to two outstanding loans at one time. The loans are collateralized by the balance in their participant's account and bear interest at rates that are commensurate with local prevailing rates, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### **Benefits:**

The Plan provides for normal retirement benefits upon reaching age 59½. Upon termination of service due to death, disability, retirement, or other reasons, a participant may receive a distribution equal to the vested value of the participant's account. Unless a lump-sum distribution is required by the Plan, participants may elect to receive alternate forms of distributions as defined by the plan document. The Plan provides for in-service withdrawals. Financial hardship withdrawals are not permitted.

##### **Plan Termination:**

Upon complete or partial termination of the Plan or upon complete discontinuance of contributions by the employer, the participants' interests under the Plan, as of the date of termination, become fully vested and nonforfeitable. The Plan Sponsor has not expressed any intent to terminate the Plan or to discontinue contributions.

##### **SECURE 2.0 Act:**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE ACT of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. The Plan is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2025.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting:**

The financial statements have been prepared on the accrual basis of accounting.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition:**

Investments are reported at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Net appreciation or depreciation in the fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold as well as held and distributed and the change in appreciation from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits:**

Benefit payments to participants are recorded when paid.

**Subsequent Events:**

Management evaluated all activity of the Plan through October 14, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

**NOTE C - TAX STATUS**

The Plan was established using the Principal Life Insurance Company's Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which, according to an opinion letter dated June 30, 2020 from the Internal Revenue Service, may be relied upon by an employer to adopt and qualify as an approved plan under the applicable sections of the Internal Revenue Code (IRC).

**NOTE D - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Principal Trust Company, the trustee of the Plan, that all information relating to the Plan's investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024 is complete and accurate. Information as to the value of the investments in the Plan and investment income is presented in reliance solely upon those certifications.

**NOTE E - FAIR VALUE MEASUREMENTS AND INVESTMENTS**

FASB ASC 820 establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs).

The three levels of the fair value hierarchy under FASB ASC 820 are described in the table below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used attempt to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the net asset value of shares of registered investment companies held by the Plan at year end. These values are quoted prices from active markets. (Level 1)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

During 2024 and 2023, the Plan invested in mutual funds managed by Principal Funds, Inc. Transactions in such investment qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. These funds had a fair value of \$759,613 and \$735,288 at December 31, 2024 and 2023, respectively.

Administration fees paid by the Plan to Principal Life Insurance Company for recordkeeping services amounted to \$68,011 for the year ended December 31, 2024. Additionally, the Plan paid advisor fees of \$38,108 for the year ended December 31, 2024 to Cambridge Investment Research Advisors Inc., an investment advisor. These transactions qualify as party-in-interest. Other costs of administering the Plan are paid by the Plan Sponsor.

Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan. The Plan has notes receivable from participants subject to specific guidelines as defined in the plan document, see Note A. These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE H – PROHIBITED TRANSACTIONS

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions and loan repayments to the Plan from its general assets as soon as practicable. The Plan has contributions totaling \$154,098 which represented employee salary deferrals and participant loan repayments that were not remitted timely. These contributions were considered prohibited transactions.
