1. Description of the Plan

The following description of the Debevoise & Plimpton LLP Cash or Deferred Plan for Associates and Counsel (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan is a defined contribution retirement plan established by Debevoise & Plimpton LLP (the Firm or Plan Administrator) effective January 1, 1984. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee

The Plan's trustee and record-keeper is Vanguard Fiduciary Trust Company (the Trustee). The Trustee relies on Charles Schwab & Co, Inc. (Schwab) to operate the Self Direct Brokerage Account feature (SDBA).

Eligibility

An Associate or a Counsel is eligible to participate in the Plan one month following the date upon which he or she becomes an Associate or a Counsel.

Contributions

The Plan provides eligible active Counsel, as defined in the Plan agreement, with a fixed Firm contribution (Firm Contribution), subject to Internal Revenue Service (IRS) limitations. The Firm Contribution is \$1,250 per month.

All Plan participants (Participants) may elect to contribute a portion of their compensation (Deferred Salary), as defined in the Plan, provided that such contribution for a year does not exceed \$23,000 in 2024. The total of a Participant's deferral elections for a plan year may not exceed 50% of his or her compensation. In addition, for 2024, Participants age 50 and over could contribute a \$7,500 "catch-up" contribution.

Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions).

The Plan provides certain eligible active participants, as defined in the plan agreement, with fixed Firm contributions, subject to Internal Revenue Service (IRS) limitations.

Participants' Accounts

Each Participant has an account in which each of the above types of contributions is separately maintained. Firm Contributions for a plan year are allocated to the related account of each Participant.. Participants' Deferred Salary and Voluntary Contributions are allocated directly to their related accounts. Each Participant's account is also credited with the allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account.

Participants' accounts are invested and administered in accordance with the provisions of the trust agreement. The trust agreement provides for separate investment options, and Participants may direct the investment of their accounts into any one or more of such funds, as well as changes in such investment direction and transfers among the funds, pursuant to rules prescribed by the committee appointed by the Firm to administer the Plan (the Committee).

Vesting

Participants are fully vested at all times in their own contributions to their accounts. The Firm's contributions to a participant account shall be 100% vested upon completion of three years of service.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, except for the loan used for the purchase or construction of a principal residence, in which case the Committee may permit a longer loan period. Successive semi-monthly installments are paid by the Firm on behalf of the Participants (the Borrowers), supplied concurrently by payroll deductions from the Borrowers' compensation for the term of the loan. The loans are secured by the balance in the Participant's account and bear interest at a rate determined by the Committee.

Payment of Benefits

Participants are entitled to receive the vested balance in their accounts after they terminate employment with the Firm. If a Participant is not fully vested in the amounts derived from Firm contributions when he or she terminates employment, the unvested amounts allocated to the Firm contributions account will be forfeited when the Participant takes a distribution from the Plan.

When a Participant leaves the Firm, he or she has several options available to consider for his or her account:

- He or she can take the cash as a lump-sum distribution (e.g., all of vested interests in the Plan are paid at one time),
- He or she can roll over his or her funds into another employer's qualified plan,
- He or she can roll over his or her funds into an individual retirement account (IRA), or
- He or she can defer payment of his or her account balance.

If a Participant's account balance is under \$1,000 when he or she terminates, the balance in his or her account will automatically be paid to him or her. If his or her balance is more than \$1,000 but less than \$7,000 when he or she terminates, he or she has the option of rolling over his or her account directly into another employer's qualified plan or an already established IRA.

If a Participant becomes a Partner of the firm, or transitions to a Staff position, the Participant's account under this Plan is closed, and the full balance transferred to the Cash or Deferred Plan for Partners and Staff.

If a Participant in the Cash or Deferred Plan for Partners and Staff becomes an Associate or a Counsel, the Participant's account under that plan is closed, and the full balance is transferred to this Plan.

Hardship withdrawals are allowed for Participants incurring an immediate and heavy financial need, as defined by the plan document. Hardship withdrawals are strictly regulated by the IRS and the Plan is abiding by the applicable provisions in the Bipartisan Budget Act of 2018.

Administrative Expenses

Administrative expenses consist of loan and distribution processing fees, which are borne by the Participants of the Plan. All other administrative expenses of the Plan are paid by the Firm and are excluded from these financial statements.

Termination of the Plan

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event of termination of the Plan in whole or in part, the Committee shall determine the date and manner of distribution of all Participants' accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements. Investment transactions are recorded on a trade-date basis. The differences between the current market values and historical costs of securities held at the beginning of the year versus the current market values and historical costs of securities held at the end of the year represent the unrealized appreciation for the current year. The net realized appreciation from sales of investments is determined on an average-cost basis.

Interest is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued and unpaid interest.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

3. Investments

Information Certified by Trustee

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

4. Fair Value Measurements

Investment Options

The Participants' contributions and any related income are invested in accordance with the election made by the Participants among those investment funds selected and authorized by the Firm.

4. Fair Value Measurements (continued)

The investment options as of December 31, 2024 and 2023 include equity mutual funds (registered investment companies), balanced mutual funds, intermediate term bond mutual funds, money market mutual funds and several common/collective trusts. The Plan also offers a Self-Directed Brokerage Account Option which allows a Participant to invest his or her participant account in a separate individual brokerage account for the purpose of purchasing and holding various investments not offered as part of the Plan's core fund options described above.

The Plan assets and liabilities are measured at fair value. To measure fair value, a hierarchy has been established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs. As such, the hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Observable inputs other than quoted prices that are used in the valuation of the asset or liability (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

4. Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments are carried at fair value using a daily valuation method. The values of mutual funds are based on the quoted redemption net asset values of the respective investment company. The Plan holds shares in several common/collective trusts, including the Vanguard Retirement Savings Trust III as well as several Target Retirement trusts. The underlying investments in the Retirement Savings Trust III include fully benefit-responsive investment contracts and the trust is valued daily using published net asset value as determined by the Trustee. The Target Retirement Trusts are composed of several Vanguard index funds chosen to provide a diversified exposure to major asset classes, with the underlying exposure designed to become more conservative over time and the trust is valued daily using published net asset value as determined by the Trustee. Self-directed brokerage accounts consist of common stocks and mutual funds. Common stocks in the self-directed brokerage account are valued based on closing market prices.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Tax Status

The Plan has received a determination letter from the IRS, dated August 24, 2015, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is exempt from taxation. Subsequent to the receipt of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code, and therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan Administrator to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan holds units of common/collective trusts, mutual funds, and loans managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

8. Subsequent Events

Management evaluated subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued.
