INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the

**Opinion**

We have audited the accompanying financial statements of Swope Group Employee Benefit Fund, an employee benefit plan subject to Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis, and the changes in benefit obligations - modified cash basis for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

A DESCRIPTION OF PLAN

The following description of the Swope Group Employee Benefit Fund (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

GENERAL

The Plan is a multiple employer, self-insured health benefit plan established to provide certain health and medical expense benefits to active employees and covered dependents. Plan funding is from employer and employee contributions to a trust. The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees oversees governance of the Plan.

BENEFITS

All full-time employees scheduled to work at least 30 hours per week are eligible for the Plan. Eligibility for these employees begins the first day of the first month after 60 days of continuous full-time employment. Post employment benefits are not given under the Plan.

The claims for the Plan are processed by a third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and is then reimbursed by the Plan's trust. Despite the Plan's utilization of a third-party claim's processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

CONTRIBUTIONS

Employee and employer premiums are determined annually for the following plan year based upon the balance in the trust bank account and expected claims for the next plan year. Employees have an open enrollment period to make changes to their benefits.

OTHER

Although it has not expressed any intention to do so, the Plan administrator has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

STOP LOSS

Premiums for stop loss insurance are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

B ACCOUNTING POLICIES

BASIS OF ACCOUNTING OTHER THAN GAAP

The financial statements of the Plan are prepared on a basis of accounting other than GAAP, namely the modified cash basis. Under this basis of accounting, revenues and the related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred.

**B ACCOUNTING POLICIES (continued)**

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. The departure from GAAP mentioned in the preceding paragraph does not change the need for management estimates in regard to certain information.

**CONCENTRATION OF CREDIT RISK**

The Plan maintains its cash in bank deposit accounts at a high credit quality financial institution. The balances, at times, may exceed federally insured limits.

**ADMINISTRATIVE EXPENSES**

All administrative and accounting expenses are paid by the Plan. The fees related to the audit are paid by a participating employer and are reimbursed by the Plan.

**C BENEFIT OBLIGATIONS**

Claims incurred by participants and their covered dependents are paid by the Plan through a third-party claims processor.

Claims payable and claims incurred but not reported are presented at the gross claim amount. Any future credits on these claims are reflected in the year the credit is utilized.

**D CLAIMS RECOVERIES**

Stop loss recoveries included in claims paid for 2024 totaled \$439,595 and \$15,555 for 2023.

**E PAYMENT OF BENEFITS UPON PLAN TERMINATION**

Upon termination of the Plan, benefits to participants will be limited to those claims incurred up to the date of termination. Funding for such liabilities will remain in accordance with the funding requirements described in note A.

**F INCOME TAX STATUS**

The Internal Revenue Service has ruled that the Plan qualifies under Section 501(c)(9) of the Internal Revenue Code. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G SUBSEQUENT EVENTS**

Subsequent events were evaluated for potential recognition and disclosure through the date of this report, which is the date the financial statements were available to be issued.
