### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Happy Money 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of Happy Money 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined-contribution plan subject to the provisions of Section 401(k) of the Internal Revenue Code (IRC). The Plan was established on January 8, 2020. The Plan covers substantially all employees of Happy Money, Inc (the “Employer”). The Plan is administered by management of the Employer and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Fidelity Management Trust Company, the trustee, is responsible for the custody and management of the Plan’s assets. The Baldwin Group Wealth Advisors is used by the Plan as investment advisors.

#### Eligibility

All employees are eligible to participate in the Plan who are not union employees. Participation in the Plan may begin immediately upon employment.

#### Contributions

Participants may elect to contribute, on a pretax basis or as Roth deferrals, up to 100% of their eligible compensation, in an amount not in excess of the maximum allowed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. During the year ended December 31, 2024, the Employer matched 50% of participant contributions up to 6% per paycheck with a maximum contribution of \$3,000. Additional amounts may be contributed at the discretion of the Employer. No discretionary contributions were made for the year ended December 31, 2024. Participants may also roll over amounts representing distributions from other qualified defined benefit or contribution plans. All Employer contributions are invested in the manner in which a participant directs his or her investments.

#### Participant Accounts

Individual accounts are maintained for each of the Plan’s participants. Each participant’s account is credited with the participant’s contributions, rollovers from qualified plans, Plan earnings or losses and an allocation of the Employer’s matching contribution and discretionary contribution, if any. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Investment Options

Participants may direct all contributions, as desired, in any of several investment options held offered by the Plan. Investment elections may be changed online or through telephone access at any time.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Vesting

Employee and Employer contributions, rollovers, and actual earnings on all such contributions are fully vested at all times.

#### Benefit Payments

Upon termination of employment with the Employer, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. If the total vested account balance under the Plan is between \$1,000 and \$5,000, the vested balance will be automatically rolled over to an individual retirement account selected by the Plan Administrator. For balances of \$1,000 or less, the entire vested account balance will be automatically distributed in a lump-sum payment.

#### Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with Internal Revenue Service (IRS) regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

#### Notes from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance, not to exceed \$50,000. The notes are secured by the balance in the participant's account and bear a reasonable interest rate that is determined by the Plan Administrator. Current note interest rates range from 3.25% to 8.50% with maturity dates through July 17, 2029 and June 5, 2028 as of December 31, 2024 and 2023, respectively. Note terms are normally up to five years but may be longer for the purchase of a primary residence of the participant. Principal and interest are paid ratably through biweekly payroll deductions. Notes are due and payable upon termination of the participant. Participants may only have one loan outstanding at any time. Defaulted participant notes are reclassified as distributions based upon the terms of the Plan document.

#### Forfeited Accounts

The amounts in the forfeiture account at year end are used to offset Employer contributions or pay any reasonable costs and expenses incurred on behalf of the Plan. Any balance in the forfeiture account at December 31st is carried over to the next year. The forfeiture account totaled \$12,502 and \$12,226 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no amounts were used to reduce Employer contributions or administrative expenses.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### Use of Estimates

The preparation of the Plan’s financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan’s investments in registered investment companies and the common collective trust are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year. Dividends are recorded on the ex-dividend date.

Management fees charged to the Plan for investments in registered investment companies (mutual funds) are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

#### Notes from Participants

Notes from participants are measured at their unpaid, principal balance plus any accrued unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. As December 31, 2024 and 2023, there were no delinquent participant notes. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Most administrative expenses for maintaining the Plan are paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Note application fees and investment services are charged to the individual participant’s account.

#### Uncertain Tax Positions

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the Department of Labor's (DOL). The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or asset, or disclosure, in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan's management has elected the method of compliance permitted by 29 CR 2520.103-5(c) of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the ERISA-required supplemental schedule (Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024), and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification Topic No. 820 (ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Registered investment companies (mutual funds):*

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transfer at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common collective trust:*

Units held in common collective trust (CCT) are valued using the net asset value practical expedient (NAV practical expedient) of the CCT as reported by the CCT managers. The NAV practical expedient is based on fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on a compilation of primarily observable market information. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Fidelity Investments, a related party to Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions permitted by the United States Department of Labor's (DOL) Rules and Regulations. Burnham Gibson is the investment advisor, and therefore, these transactions qualify as party-in-interest transactions permitted by the DOL's Rules and Regulations. For the plan year ended on December 31, 2024, the Plan paid fees of \$38,959 to Fidelity Investments and \$56,720 to The Baldwin Group Wealth Advisors for investment advisory services. Notes receivable from participants and the related interest income of \$8,806 are also considered related-party transactions.

### **NOTE 6 – PLAN TERMINATION**

Although the Board of Directors has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease, and all participants who are affected by such termination shall become 100% vested. Thus, net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

### **NOTE 7 – TAX STATUS**

Effective May 20, 2022, the Plan adopted a non-standardized form of a pre-approved profit sharing plan sponsored by FMR LLC. The profit sharing plan provider has received an opinion letter from the IRS as to the profit sharing plan's qualified status. The profit sharing plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed, and is being operated in compliance, with the applicable provisions of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan's management will make any changes deemed necessary to ensure the Plan maintains its tax-exempt status.

### **NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### **NOTE 9 – PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the Employer is required to segregate participant contributions from its general assets and remit them to the Plan as soon as administratively feasible.

During the Plan year ended December 31, 2023, the Employer failed to remit certain participant contributions totaling \$41 of participant deferrals within the required timeframe as stated by the DOL. In March 2024, the Employer deposited the late lost earnings on the late contributions with the Plan trustee.

During the Plan year ended December 31, 2024, the Employer failed to remit certain participant contributions totaling \$219,704 within the required timeframe as stated by the DOL. The Employer will calculate and deposit the lost earnings on the \$219,704 of late participant contributions outside of the DOL's Voluntary Fiduciary Correction Program in 2025.

### **NOTE 10 – SUBSEQUENT EVENTS**

Effective March 25, 2025, the Employer elected to enroll the Plan in the Auto Portability program administered by Portability Services Network, LLC and Retirement Clearinghouse, LLC. The Auto Portability program is designed to facilitate the automatic transfer of small account balances from terminated participants' retirement plans to their new employer's plan, thereby reducing cash-outs and preserving retirement savings.

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were made available to be issued. Except for the matter described above, no events were identified that would require adjustment to or disclosure in the accompanying financial statements.
