**Note 1 - Plan Description**

The following description of the HDL Research Lab 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering eligible employees of HDL Research Lab Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on January 1, 2020, and has since been amended and restated.

The Company serves as the plan administrator and two employees of the Company serve as trustees of the Plan. John Hancock Life Insurance Company (U.S.A.) (John Hancock) serves as the Plan's asset custodian.

**Eligibility**

Participation in the Plan for employee and employer contributions is available for all employees, as defined, who are at least 18 years of age and have completed one year of eligibility service with 1000 hours of service. Prior to July 1, 2024, employees needed to be at least 21 years of age and had to complete one year of eligibility service with 1000 hours. Upon meeting the age and service requirements, eligible employees may enter the Plan on January 1<sup>st</sup> or July 1<sup>st</sup>. The Plan includes a savings feature designed to permit the employee and the Company to contribute to the Plan, at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC).

**Contributions**

Employee pre-tax contributions are made to the Plan by electing to contribute up to 100% of the employee's compensation, as defined, subject to the maximum limits allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. All employees may make rollover contributions to the Plan from other qualified plans and certain other qualified sources as defined in the plan document even if the employee is not yet eligible to participate in the Plan.

For the year ended December 31, 2024, the Company made safe harbor non-elective contributions to all eligible participants in an amount equal to 3% of eligible compensation.

**Participant Accounts**

Participants direct the investment of their accounts into various investment options offered by the Plan. Under the Plan, earnings and losses are allocated to the participants' accounts daily according to an allocation formula provided in the plan document.

**Vesting**

Participants are immediately vested in their contributions, the Company's contributions, plus actual earnings thereon.

**Benefit Payments**

Distributions may be made to participants upon termination of employment, death, disability or retirement. Withdrawals may be made by active participants due to financial hardship or for any other reason stated in the plan document. Distributions from the Plan may be paid in the form of a lump sum distribution or installment payments if needed to satisfy the required minimum distribution rules. Upon withdrawal from the Plan or termination, participants with an account balance of \$7,000 or less receive an automatic lump sum distribution from the Plan. Withdrawals from the Plan may be subject to income tax on contributions and income earned.

**Notes Receivable from Participants**

Notes receivable from participants are loans to participants secured by the vested portion of their accounts. Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the preceding 12 months, or 50% of their account balance in the Plan. The minimum loan is \$1,000. Interest rates are based on the prime rate at the date of origination, plus 1%. Principal and interest are generally repaid through payroll deductions. Loans are to be repaid within five years unless the purpose of the loan is to acquire a principal residence, which allows the loan to extend to 15 years. A participant may only have one loan outstanding at any given time.

**Note 2 - Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. The net appreciation or depreciation in the fair value of investments includes realized gains and losses on investments sold during the year as well as appreciation or depreciation of investments held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as the notes are collateralized by the participants' account balances. In general, notes receivable from participants are placed into default in the calendar quarter following the quarter in which no payment on the note is made and such defaults are recognized as distributions based upon the terms of the plan document when a distributable event has occurred.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses**

Withdrawal fees and certain transactional charges are paid by the participants. All other administrative costs are paid by the Plan unless paid by the Company, at its discretion. Investment-related expenses are included in the net appreciation or depreciation in the fair value of investments.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances and the amounts reported in the financial statements.

**Subsequent Events**

Management of the Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Information Certified by the Asset Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained a certification from John Hancock as of December 31, 2024, and for the year then ended, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to the financial statements as to investments, notes receivable from participants, net appreciation in the fair value of investments, interest income on notes receivable from participants, and all of the related information in the supplemental schedule is presented in reliance solely upon the certification.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule.

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* These funds are valued at their net asset value (NAV) as determined by the issuer, based on the value of each of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than reported NAV.

The pooled separate accounts that are measured using NAV as a practical expedient have been excluded from the fair value hierarchy in accordance with GAAP. The following table provides additional information for the pooled separate accounts as of December 31, 2024 and 2023.

**Note 5 - Federal Income Tax**

The pre-approved plan adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan has been amended since receiving its IRS letter; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

During 2025, the plan administrator became aware of operational deficiencies relating to the Plan's definition of compensation for employee deferrals for plan years 2020 through 2024. The Company determined that corrective contributions including related earnings of \$9,510 for plan year 2024 and \$35,320 for plan years 2020 through 2023 were necessary to bring the Plan back into compliance with the IRC. The corrective contributions will be remitted in 2025 and are reflected on the financial statements as other employer contributions. Aside from these matters, the plan administrator believes that the Plan, through its adoption of the pre-approved plan, was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 7 - Party-in-Interest Transactions**

Certain Plan investments are units of pooled separate accounts issued by John Hancock. The Plan's investment transactions in these funds qualify as party-in-interest transactions. These transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.
