## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of  
the Companion Professional Services, LLC  
dba TM Floyd & Company 401(k) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Companion Professional Services, LLC dba TM Floyd & Company 401(k) Retirement Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

### **Basis for Opinion**

### **Auditor's Report on the 2023 Financial Statements**

We were engaged to audit the 2023 financial statements of the Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform and we did not perform any auditing procedures with respect to the information certified by a qualified institution. In our report dated July 26, 2024, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2023 financial statements, and (b) the form and content of the information included in the 2023 financial statements other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Companion Professional Services, LLC dba TM Floyd & Company 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**Note 1 - Description of Plan:**

The following description of the Companion Professional Services, LLC dba TM Floyd & Company 401(k) Retirement Plan (“Plan”) is provided for informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all full-time employees of the Company who meet requirements as to length of service. During the year, the assets of the Plan were held and invested by John Hancock Life Insurance Company (U.S.A.). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the trustees of the Plan.

Contributions: Participant contributions to the plan are limited by Section 402(g) of the Internal Revenue Service code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes a discretionary match of the first 5% of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, their calculated amount of the Company’s contribution, Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contributions plus actual earnings thereon is based on years of continuous service.

The effective date of participation by an eligible employee is the first day of the month following a thirty-day service requirement. The following vesting schedule has been adopted by the Plan:

0 - 1 years	25% vested
2 years	50% vested
3 years	75% vested
4 years	100% vested

Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes Fund. Loan terms range from one to five years and up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Currently the interest rate on participant notes receivable range from 4.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive the value of the participant's vested interest in his or her account as a lump sum distribution or any other form that is permitted under the Plan. Benefits are recorded when paid.

Forfeited Accounts: The non-vested portion of a terminated participant's account balance may be used by the Plan for the payment of the Plan administrative expenses or a reduction of the Company contribution to the Plan. The forfeitures used to reduce the Company contribution were \$24,843 for 2024 and \$13,279 for 2023.

**Note 2 - Summary of Significant Accounting Policies:**

Basis of Accounting: The financial statements of the plan are prepared using the accrual method of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance. Interest income on notes receivable from participants is recorded when it is received. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Valuation of Investments and Income Recognition: Plan assets held by the custodian at December 31, 2024 and 2023 are invested in certain "guaranteed" accounts and certain "pooled" accounts. Individual participants direct the investment strategy for their funds. The funds are invested in fixed interest bearing guaranteed accounts or in pooled investment funds ranging from short-term securities to bond and mutual funds, as directed by participants. The investments in shares of guaranteed interest accounts are stated at their fair value. The investments are pooled in separate accounts valued using accumulation units and are stated at fair value.

The investment management fee is deducted prior to setting the daily unit value.

**Note 2 - Summary of Significant Accounting Policies (Continued):**

Interest earned on the “guaranteed” accounts and the “pooled” accounts is reflected in the accompanying financial statements as interest income. The accompanying financial statements also reflect the net appreciation and depreciation of assets invested in the pooled accounts.

Financial Information Certified by Plan Custodian: The financial information pertaining to investment assets, transactions, income and the Schedule of Investments were obtained from data that has been prepared and certified as complete and accurate by the custodian.

Payment of Benefits: Benefits are recorded when paid.

Plan expenses: Certain expenses incurred maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment-related expenses are included in the net appreciation of fair value of investments.

Date of Management Review: In preparing the financial statements, the Plan Administrator has evaluated subsequent events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant unobservable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1     Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
  
- Level 2     Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - a.     Quoted prices for similar assets or liabilities in active markets.
  - b.     Quoted prices for identical or similar assets or liabilities in inactive markets.
  - c.     Inputs other than quoted prices that are observable for the asset or liability.
  - d.     Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3     Inputs that are unobservable inputs for the asset or liability.

Mutual fund shares are valued at the net asset value of shares held by the Plan at year-end.

The Plan’s investment in “guaranteed interest accounts” are reported in the Plan’s statements at fair value.

**Note 5 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 6 - Tax Status:**

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

The Plan's Form 5500 filings are subject to review and examination by federal government. The years 2021 to 2024 are subject to examination by the federal government, generally for three years after they are filed.

**Note 7 - Risks and Uncertainties:**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Note 8 – Exempt Party-in-Interest Transactions:**

Plan investments include shares of mutual funds, money market funds and a guaranteed investment contract managed by the custodian for the year ended December 31, 2024. The plan paid certain expenses related to the plan operations and investment activity to various service providers. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.
