Notes to Financial Statements

Note 1: Description of Plan

The following description of the Miller and Sons, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

During the current plan year, the Plan was restated as of September 1, 2024 in accordance with IRS requirements. As part of the restatement, the plan sponsor implemented two key changes:

- The Plan transitioned third party plan administrator from Nationwide Trust Company to Standard Insurance Company.
- The previous limit on Company matching contributions was removed.

General

The Plan is a defined contribution plan sponsored by Miller and Sons, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

Eligible employees include all employees of the Company over the age of 20, who are not covered under a collective bargaining agreement. Employees are eligible to participate in the Plan concurrent with the day the employee completes six months of service.

Contributions

Each year, participants can contribute on a pretax basis a percentage of their annual compensation, as defined in the plan document, subject to the maximum allowed by the Internal Revenue Code ("IRC"). Participants who have reached age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers"). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may elect to make discretionary matching or profit sharing contributions. The discretionary matching contribution for 2024 was 50% of the participant's contributions, up to 5% of eligible compensation. No discretionary profit sharing contribution was made for the 2024 plan year.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Effective January 1, 2025, the plan was amended to incorporate a provision for automatic contribution enrollment and in-plan Roth rollovers.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Contributions (Continued)

Under the automatic contribution enrollment provision, eligible employees will be automatically enrolled in the Plan at 5% unless they affirmately elect a different rate (or to not participate).

The in-Plan rollover provision allows employees to convert eligible pre-tax amounts to Roth contributions within the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, allocations of the Company's discretionary profit sharing contribution, if any, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or investment balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary matching and discretionary profit sharing contribution portion of a participant's account is based on the number of years of service.

The Company's contributions, as defined above, vest according to the following schedule:

1 year	50 %
2 or more years	100 %

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during the Plan year. Upon termination of service due to death, disability or retirement (age 65), participants become fully vested in their account balances.

Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment with the Company prior to becoming fully vested. Forfeitures are used to reduce the Company's contributions. If a terminated participant is reemployed and fulfills certain requirements, the participant's account can be restored. During 2024, \$8,762 forfeitures were used to reduce the Company's discretionary matching contributions. At December 31, 2024 and 2023, there was \$9,975 and \$8,744 of unallocated forfeitures, respectively.

Payment of Benefits

Upon termination of employment, death, disability, or retirement (age 65), a participant or designated beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment. In-service distributions may be made to participants who have not terminated employment if they have attained age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses related to distributions directly attributable to a participant's transaction are deducted from that participant's account. Investment related expenses are included in net appreciation in fair value of investments. Certain expenses of the Plan are paid by the Company and are excluded from these financial statements

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are plan assets requiring the use of the Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds held in pooled separate accounts: Fair value is estimated using the net asset value (NAV) per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Fully Benefit-Responsive Group Annuity Contract

The Plan maintained a fully benefit-responsive group annuity contract with Nationwide Life Insurance Company for plan year ended 2023, that invested contributions in the Fixed Select contract. The Fixed Select contract was a general account product. The contract issuer was contractually obligated to repay the principal and specified interest rate that was guaranteed to the Plan. The methodology for calculating the interest crediting rate was based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate was reset quarterly.

The Plan maintains a fully benefit-responsive group annuity contract with Standard Insurance Company for plan year ended 2024, that invests contributions in the Stable Asset A contract. The Stable Asset A contract is a general account product. The contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive group annuity contracts since this is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due in accordance with its fully benefit-responsive group annuity contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 5: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held and fully benefit-responsive group annuity contracts at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company and Standard Insurance Company, the custodians of the Plan.

Note 6: Tax Status

The Company adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their account balances.

Note 8: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 9: Party-in-Interest Transactions

Certain plan investments are managed by the Custodians or their affiliates, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for certain administrative services by the custodians were \$30,066 for the year ended December 31, 2024.

Note 10: Contributions Payable

Benefits payable to participants as of December 31, 2024 and 2023, include \$0 and \$6,973, respectively, of accrued distributions to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan, as well as, refunds to certain ineligible participants who made contributions to the Plan. These amounts are recorded in the Plan's Statement of Net Assets Available for Benefits as contributions payable at December 31, 2024 and 2023.
