## Independent Auditors' Report

### The Board of Trustees of 401(k) Retirement Savings Plan for Employees of The Valley Hospital

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of 401(k) Retirement Savings Plan for Employees of The Valley Hospital (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### **1. Description of Plan**

The following summary of certain provisions of 401(k) Retirement Savings Plan for the Employees of The Valley Hospital (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan established under section 401(k) of the Internal Revenue Code (the "Code") for the benefit of all non-union eligible employees of The Valley Hospital and Valley Health Medical Group and related employers (the "Company" or the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Eligibility***

All eligible full-time and part-time employees (as defined in the Plan document) are eligible to participate in the Plan immediately upon employment with the Company. Temporary and seasonal employees may participate upon completion of 1 year of service, as defined in the Plan document. Participants become eligible for Employer contributions after 1 year of service.

#### ***Assets Held for Investment***

All Plan assets are held by Lincoln Financial Group Trust Company, Inc. ("Lincoln"). Among other duties, Lincoln is responsible for the custody of the Plan's assets and for the payment of benefits to eligible participants. Plan contributions are invested in certain funds offered by Lincoln as designated by the Plan participants.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### ***Contributions***

Each year participants may contribute up to 75% of their eligible compensation to the Plan on a pre-tax or after-tax (Roth) basis, up to the maximum allowed by the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan will not accept rollover contributions from former employers or from plans sponsored by any related employer.

**Contributions (continued)**

The Plan has a Qualified Automatic Contribution Arrangement (“QACA”) auto-enrollment feature that requires all newly eligible employees to contribute 4% of their eligible compensation to the Plan on a pre-tax basis, unless they affirmatively elect otherwise. The QACA automatic deferral amount will increase by 1% each Plan year up to a maximum of 10%.

The Company makes a safe harbor matching contribution equal to 100% of the first 1% of eligible compensation, plus 50% of salary deferrals up to the next 5% of eligible compensation, for a maximum of 3.5% of eligible compensation. A participant must complete one year of service in order to receive the safe harbor matching contribution.

The Company will make a basic match equal to an amount between 1.5% and 4 %of each participant’s eligible compensation if they are an employee of The Valley Hospital. A participant must complete one year of service in order to receive this match. This match is determined based on the employee’s years of service, in accordance with the following table and subject to certain restrictions in the Plan document:

Years of Service	Percentage of Compensation
0-9	1.5%
10-19	2%
20-24	3%
25+	4%

Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and an fixed income annuity contracts as investment options for participants.

**Notes Receivable from Participants**

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at 1% above the quarterly prime rate as reported in the Wall Street Journal at the time of the loan. The interest rate is fixed for the duration of the loan. Principal and interest is paid ratably through biweekly payroll deductions. The maximum loan payment period is five years, unless the loan is for the purchase of a principal residence, in which case the term may be up to fifteen years.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in annual installments, or defer receiving payment until age 73. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or have a payment made as a "direct rollover" to an Individual Retirement Account ("IRA") or to another employer's qualified plan.

In-service withdrawals are allowed upon attainment of age 59-½.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Employees vest in the Employer contributions according to the following schedule:

0-1	0%
2 or more	100%

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$575,018 and \$318,515. Balances in forfeited accounts are used to reduce administrative expenses first and leftover amounts are used to reduce future employer contributions. In 2024, employer contributions were reduced by \$24,868 from forfeited nonvested accounts.

***Plan Expense Account***

The Plan and Lincoln Retirement Services Company, LLC entered into a Recordkeeping Service Agreement whereby quarterly credits will be made to the Plan Expense Account, equal to 0.0250% annually, of the Plan's total assets, which will be used to pay Plan expenses. In order for the Plan to receive credits as a result of this arrangement, and to use these credits to reduce Plan administrative expenses, the Plan created a Plan Expense Account, which is invested in the Lincoln Stable Value Fund within the Plan. The Plan Expense Account balance was \$76,130 and \$134,510 as of December 31, 2024 and 2023. During 2024, \$60,619 of funds from the Plan Expense Account were used to reduce Plan expenses.

**2. Summary of Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”). Under this basis, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

The preparation of financial statements requires management to make estimates that affect the reported amounts of assets and liabilities and the changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded, when a distributable event occurs.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

The Plan’s investments are reported at fair value based on quoted market prices, except for its fixed income annuity accounts, which are stated at contract value. Contract value represents contributions made under the contract, plus interest credited, less benefits paid and expenses. The mutual funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at the price and are deemed to be actively traded.

**2. Summary of Accounting Policies (continued)**

***Investment Valuation and Income Recognition***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

**3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln, a qualified institution.

**4. Investments**

The following are the major categories of investments measured at fair value on a recurring basis at December 31, grouped by the fair value hierarchy:

The Lincoln Stable Value Fund is recorded at contract value on the statements of net assets available for benefits, which amounted to \$123,149,991 and \$131,902,421 at December 31, 2024 and 2023. The Plan offers investments in YourPath target date and risk portfolios. These portfolios primarily consist of iShares index mutual funds from BlackRock. Each portfolio also includes the Lincoln Stable Value Account as part of the portfolio allocation to reduce market volatility. The Lincoln Stable Value portion is carried at contract value and across all portfolios the total is \$53,418,460 and \$46,872,563 at December 31, 2024 and 2023.

**5. Fixed Annuity Contract with Insurance Company**

The Plan invests in a fully benefit-responsive fixed annuity contract with The Lincoln National Life Insurance Company ("LNLIC"). LNLIC maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. LNLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is based on a formula agreed upon with the issuer and which is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by LNLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (A+ as of July 2024), Moody's Investors (A2 as of September 2024), A.M. Best (A as of February 2025) and Fitch Ratings (A+ as of July 2024).

The Lincoln Stable Value Fund represents approximately 17% and 19% of the net assets available for benefits as of December 31, 2024 and 2023.

**6. Party-in-Interest Transactions**

The fixed income annuity is managed by LNLIC. Lincoln is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustees for administrative expenses and investment advisor amounted to \$344,249 and \$60,619 for the year ended December 31, 2024.

A Plan Expense Account is maintained by Lincoln Retirement Services Company, LLC which receives payments from Lincoln pursuant to a written agreement with the Company. Under the agreement, the Company can use the amounts in the account to pay for administrative expenses incurred by the Plan or for such purposes as determined by the Company. These transactions are considered allowable party-in-interest transactions. There were no payments received for the year ended December 31, 2024.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by employees of the Company, which is a party-in-interest. No such employee receives compensation from the Plan.

**7. Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company, and excluded from these financial statements, and not by the Plan. For expenses paid by the Plan, monthly asset charges are deducted from the participant's accounts. Certain fees related to loan processing and transfer of funds are also paid by participants.

**8. Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

**9. Income Tax Status**

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and its amendments are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

**10. Risks and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
