Notes to the Financial Statements

December 31, 2024 and 2023

Note 1 – Description of Plan

The following description of the ALS Group USA 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all eligible employees of ALS Group USA, Corp., ALS Services USA, Corp., ALS USA Inc., ALS Maverick Testing Laboratories, Inc., ALS Industrial USA, LLC, ALS Marshfield, LLC, ALS Reservoir Laboratories, LLC, and International Research Services, Inc. (collectively, the Company) that have attained age eighteen. To be eligible for contributions from the Company, an employee must have completed six months of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). ALS Group USA, Corp. is the Plan's sponsor and serves as Plan administrator. The 401(k) Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

The Company has elected to operate the Plan as a safe harbor 401(k) plan, which is a plan design where the Company commits to making certain contributions described in the Plan Document. This commitment to make contributions enables the Company to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met, which is why it is called a "safe harbor" plan.

Contributions – Each year, participants may contribute up to the regulatory maximum of pretax and after-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Company contributions to the Plan include safe harbor matching of 100% of the first 3% of a participant's contributions and 50% of the next 2% of a participant's contributions, so that the maximum Company matching contributions are 4% of compensation. Contributions are subject to certain Internal Revenue Service limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts – Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses, if any, paid by the Plan. Allocations are based on participant contributions, earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. The Company's contributions are fully vested at all times and cannot be forfeited.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 2% above the prime rate, as defined. Loan terms range up to five years, unless the loan is for the purchase of a principal residence, in which case the loan term may not exceed fifteen years. Principal and interest is paid ratably through weekly payroll deductions.

Notes to the Financial Statements

December 31, 2024 and 2023

Note 1 – Description of Plan – (Continued)

Payment of benefits – Upon death, disability, retirement, or termination of service for other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or annual installments. Vested accounts that do not exceed \$1,000 are automatically distributed in a single lump-sum payment. Further, withdrawals from the Plan before terminating employment with the Company are available for special "hardship" reasons (as defined) or after attaining the age of 59 1/2.

Forfeited amounts – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,903 and \$39,892, respectively. Forfeitures may be used to offset employer contributions to the Plan or to pay any administrative expenses of the Plan. The Plan used \$14,250 of forfeitures to pay Plan administrative expenses for the year ended December 31, 2024.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan provides for investments in mutual funds and a collective investment trust. The Plan's investments in mutual funds are reported at fair value. The collective investment trust is valued at net asset value as a practical expedient to estimate fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions – Contributions from Plan participants and employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Payment of benefits – Benefits are recorded when paid.

Note 2 – Summary of Significant Accounting Policies – (Continued)

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 3, 2025, the date the financial statements were available to be issued.

Note 3 – Information Certified by Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, custodian of the Plan, has certified to the completeness and accuracy of:

Note 4 – Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Note 4 – Fair Value Measurements – (Continued)

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1: Observable inputs to the valuation methodology that are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Observable inputs to the valuation methodology other than quoted market prices (unadjusted) for identical assets or liabilities in active markets. Level 2 inputs include quoted prices for similar assets and liabilities in active markets, quoted prices for identical assets in markets that are not active and inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology that are unobservable for the asset or liability and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust:

Units held in the collective investment trust are valued using the NAV practical expedient of the collective investment trust as reported by the collective investment trust managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the collective investment trust, minus its liabilities, and then divided by the number of units outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 5 – Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by The Vanguard Group, Inc. and the collective investment trust is managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the custodian of the plan and an affiliate of The Vanguard Group, Inc., and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to The Vanguard Group, Inc. and Vanguard Advisors Inc. for recordkeeping, loan, and distribution administrative services totaled \$223,246 for the year ended December 31, 2024. Fees paid by the Plan to Creative Planning Holdco, LLC, the retirement consultant of the Plan, totaled \$57,000 for the year ended December 31, 2024. Fees paid by the Plan to Larson Gross PLLC, the auditor of the Plan, totaled \$19,000 for the year ended December 31, 2024. Fees incurred by the Plan for legal, accounting, and general administration of the Plan are paid by the Company.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 – Tax Status

The prototype plan on which the Plan is based obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax returns for the prior three fiscal years remain subject to examination by major tax jurisdictions.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
