Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of the Pepe Ganga Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary of the Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all full-time employees of Pepe Ganga LLC, (the Company) who have completed one year of service and are age 21 years or older. The effective date of the Plan was January 1, 2020, with an effective date of February 1, 2020, for elective deferrals, voluntary after-tax contributions, and matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company created a committee to serve as the Plan Administrator. The Plan's Committee is composed of the Company's President and Vice-president. The Plan's Trustee, Recordkeeper and Custodian is BPAS Trust Company of Puerto Rico.

Participants accounts

Each participant's account is credited with the participant's elective deferrals and Company's discretionary profit-sharing contributions and discretionary nonelective contributions. Allocations are based on participant earnings as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions

A participant may contribute up to 100% pre-tax annual compensation as defined in the Plan and shall not exceed the pre-tax contribution limit allowed under Puerto Rico Internal Revenue Code section 1081.01(d) (\$15,000). The participants may contribute after tax contributions and may not be less than 1% nor exceed 10% of compensation. Participants who have attained age 50 or over are eligible to make catch-up contributions up to \$1,500 per Plan Year. Participants direct the investment of their total contributions into various investments options offered by the Plan.

The employer will make discretionary profit-sharing contributions in one or more installments for each Plan year.

Rollover Contributions

Participants may rollover their funds previously held for their account in another employee benefit plan on a tax-free basis.

Vesting

Vesting in the Company's discretionary profit-sharing contributions and qualified nonelective contributions is based on years of service. A participant is 100 percent vested after six years of credited service.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed in the form of a lump sum distribution equal to the value of the participant's vested interest in his/her account or annual installments over a minimum of 5 years or more.

Payment of Benefits (continued)

In conditions of “financial hardship”, a participant may apply to the Plan administrator for approval to withdraw that portion of his retirement account balance necessary to meet the financial hardship and for any reason after 59 ½ years old, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan’s provisions and existing laws and regulations.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. The balance on these accounts will be used by the Plan’s Sponsor to reduce Plan administrative expenses, future employer contributions or proportional reallocation to the participants. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,245 and \$10,749, respectively. No forfeitures were utilized in 2024 and 2023.

Investment Options

The Plan provides for separate investment programs which allow participants to direct their investment among the different investment options. Currently the participants invest in nineteen mutual funds and four collective investment trusts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contributions of their account.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of Pepe Ganga Retirement Plan have been prepared on the accrual basis and have been prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Investments Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investments in collective investments trust are reported at net asset value of units of collective trust. The net asset value, as provided by the fund houses or investment provider, is used as a practical expedient to estimate fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments which consist of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

2. Summary of Significant Accounting Policies (continued)**Use of Estimates**

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments are recorded when paid. For the year ended on December 31, 2024, the benefits paid amounted to \$35,437.

Administrative Expenses

The Companies provides certain administrative and accounting services to the Plan at no cost. Administrative expenses including audit fees and legal fees are paid directly by the Companies. Other administrative expenses directly incurred by the Plan include investment management and distributions fees charged directly to the participant's accounts. These administrative expenses are presented as a deduction to net assets on the Statement of Changes in net Assets Available for Benefits.

Risk and Uncertainties

The Plan provides for various investment options that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

Financial Accounting Standard Board (FASB) established the Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which provides a framework for defining and measuring fair value under generally accepted accounting principles. This codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. In some cases where market prices are not available, observable market-based inputs are used to calculate fair value, in which case the measurements are classified within Level 2. If quoted or observable market prices are not available, fair value is based upon internally developed models that use, where possible, current market-based parameters such as interest rates, yield curves and currency rates. These measurements are classified within Level 3.

The following methods and assumptions were used to determine the fair value of investments recorded at fair value in the statements of net assets available for benefits:

Valued at quoted market prices, which represent net asset value (“NAV”) of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investments Trust

Valued at the net asset value (“NAV”) of the units of the investment fund’s trustee. Participants are allocated units of the collective trust funds, not specific securities. The net asset value, as provided by the fund houses or investment provider, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. There are no restrictions as to the redemption of these investments, nor does the Plan have any contractual obligations to further invest in any of these collective trust funds.

4. Information Prepared and Certified by BPAS Trust Company of Puerto Rico

Investment income earned from these instruments as of December 31, 2024 and 2023 were as follows; net appreciation (depreciation) in fair value of investments, \$69,404 in 2024 and \$71,149 in 2023 and interest and dividend income of \$34,396 in 2024 and \$17,512 in 2023.

5. Tax Status

On October 28, 2020, it was requested to the Treasury Department of Puerto Rico a determination letter to qualify the Plan under Puerto Rico Internal Revenue Code of 2011, Section 1081.01(d) with effective date of January 1, 2020.

On December 15, 2020, the Trustee received the determination letter approving the participation on the new prototype retirement plan and establishing that the established new Trust is exempt under Section 1081.01(d) of Puerto Rico Internal Revenue Code of 2011.

Accounting principles generally accepted in the United States of America requires to the management of the Plan to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department.

The Trustee has analyzed the tax positions taken by the Plan, and has concluded that as December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. Related-Party Transactions and Party in Interest Transactions

Benefit Plan Administrative Services, Inc. (BPAS) through BPAS Trust Company of Puerto Rico provides trust, recordkeeping, administration, and custodial services. The Plan's participants invest in one collective investment trust that was created and sponsored by BPAS Trust Company of Puerto Rico which both qualify as party-in-interest transactions.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for these services of the employees to the Plan.

7. Subsequent events

Subsequent events were evaluated through October 15, 2025, which is the date of the financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date, and the date the financial statements were available to be issued that would require additional adjustment to or disclosure in the financial statements.

8. Non-exempt transactions

As required by ERISA Section 2510.3-102, the Company is required to segregate employee contributions to the Plan from its general assets as soon as practicable but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. During the year 2023, 2022 and 2021, the Company did not remit employee contributions as soon as they are able to remit the contributions to the trustee. The Company is able to remit in average of 3 to 4 days immediately after payroll payment and they remit in an average of over 7 to 207 days. Total participant contributions considered late amount to \$18,445 in 2024, \$27,736 in 2023, \$16,474 in 2022, \$12,604 in 2021 and \$28,220 in 2020.
