## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Quetico, LLC Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier ("qualified institution") in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### 1. Description of Plan

Quetico, LLC Profit Sharing Plan (the "Plan") is a defined contribution plan sponsored by Quetico, LLC and its wholly owned subsidiary, Quetico Arizona LLC (collectively, the "Company"). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of the Company who are age 21 or older, who have completed one year of service and who have worked at least 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by a committee that is appointed by management of the Company.

#### **Contributions**

Participants may not elect to make deferral contributions. Participants may contribute amounts representing distributions from other qualified plans. A discretionary contribution may be made to the Plan by the Company, the amount of which is determined by the Company's managing members. For the year ended December 31, 2024, the Company accrued a discretionary contribution in the amount of \$434,509. Participants entitled to receive an allocation of the discretionary contributions are those Plan participants who were employed by the Company on the last day of the Plan year, have completed one year of service, and have worked at least 1,000 hours. Contributions are based on certain percentages of eligible compensation, subject to statutory limits. The contribution amounts are invested in a portfolio of investments as directed by the Company.

#### **Participant Accounts**

Each participant's account is credited with an allocation of the Company's discretionary contributions, if any, and Plan net earnings or losses. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Vesting in the Company's contributions plus actual earnings thereon is based on length of employee service. A participant is 100% vested after 6 years of credited service. Participants who become totally disabled or die before normal retirement age become fully vested in their accrued benefits.

#### **Payment of Benefits**

On termination of service due to retirement, death, disability, or other reasons, a participant may elect to receive a lump-sum distribution, transfer the vested balance to a qualified plan, or leave the vested balance in the Plan.

The Plan provides in-service distributions for participants after attaining service or age requirements as defined in the Plan agreement.

### 1. Description of Plan, continued

#### ***Forfeited Accounts***

As of December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$9,761 and \$8,147, respectively, and may be used to pay some administrative expenses of the Plan and then reduce future employer discretionary contributions. Forfeited non-vested accounts of terminated employees are held for the participant's rehire or five years, whichever is sooner. If the former employee is not rehired within five years, then the non-vested portion of their account balance plus earnings attributable to this portion are forfeited. For the year ended December 31, 2024, forfeitures amounted to \$12,379, of which \$10,765 were used to offset the employer discretionary contributions for 2023 Plan year. In 2025, the Company applied \$9,761 of forfeitures toward the employer discretionary contributions for 2024.

#### ***SECURE Act 2.0***

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0 that contains over 90 new retirement provisions, with varying effective dates through 2027. Since the provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance, and the Plan will be amended as required. Certain provisions became effective for 2024, these changes had no material impact to the Plan's financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments, as certified by John Hancock Life Insurance Company (U.S.A.) ("John Hancock" or the "Custodian"), are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded as reported by the Custodian. Net realized and unrealized depreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year. Differences between the fair value of investments at the beginning of the year, or cost if acquired subsequently, and fair values at the end of the year are recorded as appreciation or depreciation in fair value of investments.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation of fair value of investments.

### 3. Information Prepared and Certified by Custodian

The Plan's assets are held by the Custodian pursuant to the Trust Agreement, which provides that all funds received by the Custodian shall be held, administered, invested, and distributed by the Custodian, and that no part of the corpus or income shall be used for, or directed to, purposes other than for the exclusive benefit of participants or their beneficiaries.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the Custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Pooled separate accounts:* Pooled separate accounts ("PSAs") are privately managed through investment companies and are not publicly quoted. PSAs are valued at net asset value ("NAV") which is based on the value of the underlying assets owned by the PSA minus any liabilities, and then divided by the number of shares outstanding. The Plan has concluded that the NAVs reported by the investment companies approximate the fair value of the investments. There are currently no redemption restrictions or unfunded commitments on these investments.

### 4. Fair Value Measurements, continued

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the pooled separate accounts and, consequently, the fair value of the Plan's investments.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

As of December 31, 2024 and 2023, the Plan's investments at fair value were comprised of only PSAs, which are measured at NAV as a practical expedient under U.S. GAAP. PSAs are not required to be categorized in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Party-in-Interest Transactions

The Plan has invested in participation units held in pooled separate accounts through sub-accounts of the Custodian in the amount of \$6,673,478 and \$5,732,823 as of December 31, 2024 and 2023, respectively. John Hancock provides services to the Plan as the custodian and record keeper; therefore, these investments and transactions qualify as party-in-interest transactions. As of December 31, 2024 and 2023, the Plan also had a non-interest-bearing cash account with the Custodian with a balance of \$9,761 and \$8,147, respectively.

Fees charged by the Custodian and the third-party administrator of the Plan for administrative expenses amounted to \$37,721 for the year ended December 31, 2024.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

### 7. Tax Status of the Plan

The Plan has adopted a prototype plan prepared by the Custodian. This prototype plan has obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. There are no uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by the IRS and/or Department of Labor. There are currently no audits in progress.

### 8. Risk and Uncertainties

The Plan provides for various investment options in pooled separate accounts sponsored by an insurance company. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Some of the Plan's assets are invested in securities of foreign companies, which involve special risks and considerations not typically associated with investing in United States ("U.S.") companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

Approximately 75% and 78% of net assets were held in five and six funds, respectively, as of December 31, 2024 and 2023, respectively.

### 9. Subsequent Events

In accordance with accounting standards affecting disclosures of subsequent events, the Plan evaluated subsequent events for recognition and disclosure through October 14, 2025, the date which these financial statements were available to be issued. Management concluded that, other than already disclosed and noted below, no material subsequent events have occurred since December 31, 2024 that require recognition or disclosure in these financial statements.

Effective January 1, 2025, the Plan implemented all required provisions of SECURE Act 2.0 that became mandatory for Plan year 2025.
