## Independent Auditors' Report

**To the Plan Administrator and Participants of

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the 403(b) Tax-Deferred Annuity Plan of Eger Lutheran Homes and Services, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing basis), and the related statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year then ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or derives from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Emphasis of Matter – Plan Termination and Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Board of Directors approved a plan of liquidation effective September 23, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the December 31, 2023, financial statements to the liquidation basis of accounting used in presenting the December 31, 2024 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. Description of the Plan**

The following description of the 403(b) Tax-Deferred Annuity Plan of Eger Lutheran Homes and Services, Inc., (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

Effective September 23, 2024, the Board of Directors approved a resolution to terminate the Plan. Effective December 31, 2024, all contributions to the Plan will be frozen. The assets are in process of being distributed or transferred to the ArchCare Unified Retirement Plan.

***General***

The Plan was a defined contribution plan qualifying under Section 403(b) of the Internal Revenue Code ("IRC") covering eligible employees of Eger Lutheran Homes and Services, Inc. including Eger Health Care and Rehabilitation Center and Eger Harbor House, Inc. (the "Employer" or "Plan Sponsor"). It was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Any eligible employee of the Employer was eligible to participate in the Plan through salary deductions up to the Internal Revenue Service ("IRS") limits. There was no minimum age or service requirements to become eligible. The Plan administrator was responsible for oversight of the Plan, determining appropriateness of investment offerings and monitoring investment performance.

***Employee Contributions***

An employee participating in the Plan may annually contribute through either pre-tax or after tax or roth payroll deductions, any percent up to 100% of their eligible compensation and may contribute amounts representing distributions from other qualified plans. Any participant age 50 or over may make an additional "catch-up" contribution as determined by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan. A participant may suspend, reinstate, increase, or decrease their level of contributions at any time after tax was allowed.

***Employer Contributions***

Employer contributions are not permitted.

***Participant Accounts***

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account balance.

***Vesting***

Participants' accounts were fully vested in their accounts.

***Payment of Benefits***

Prior to age 59 ½, distributions and withdrawals are not permitted from the Plan except in the instances of death, disability, hardship, or termination of employment. After attaining age 59 ½, participants may elect to withdraw an amount not to exceed 100% of the participant's vested account balance for any reason. In the event of termination of employment, a participant shall receive their participant contributions and earnings thereon in the form of a single-sum payment, partial payments, and installment payments. For termination of service for other reasons, a participant will receive the value of his or her interest in his or her account as a lump-sum distribution.

***Plan Loans/Collateralized Assets***

The Plan provides for Plan loans at a minimum of \$1,000 up to a maximum amount of \$50,000 or 50% of their vested account balance. Loans to the participant are made directly from Mutual of America Life Insurance Company. The participant's account is not reduced by the loan amount, but serves as security for the loan, the loan amount is moved into a fixed income collateral account within the borrower's account. The loan must be repaid directly to Mutual of America Life Insurance Company within a five year period in substantially equal payments (not less frequently than quarterly). The five year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower. A participant may not have more than two loans outstanding at one time.

At December 31, 2024 and 2023, total principal balances due amounted to \$109,678 and \$91,251 which also represents a collateralization of participant accounts. The interest rate on these loans are between 4.11% – 9.50% with maturities through 2032.

***Notes Receivable from Participants***

Participants that transferred or rolled their balances over to Lincoln Financial Group may borrow from their fund accounts a minimum loan amount of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance.

Loan terms are not to exceed 5 years, unless for the purchase of a principal residence, for which the repayment period shall be a reasonable time commensurate with the repayment period permitted by commercial lenders for similar loans. The loans are secured by the balance of the participant's account and bear an interest rate deemed reasonable by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Interest rates ranged from 4.11% to 9.50% for the year ended December 31, 2024.

***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions into one or a combination of the investment options offered by the Plan. Participants may transfer money from one investment alternative to another or change the allocation of future contributions.

***Forfeitures***

When a participant terminates, the nonvested portion of their account, as defined by the Plan document, is forfeited. Forfeited non-vested accounts are used to reduce future Plan Sponsor contributions and pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24,069 and \$12,083. During 2024, no forfeitures were used to reduce Employer contributions or pay Plan expenses.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The Employer approved to terminate the Plan effective September 23, 2024. As a result, the Plan has changed its basis of accounting for periods starting January 1, 2024, from the accrual basis to the liquidation basis.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") required management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan followed U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment and Income Recognition***

The Plan's investments are stated at fair value based on quoted market prices except for the fixed income annuity accounts, which are stated at contract value. The mutual funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. The fixed annuity contract was valued at contract value, which represented contributions plus credited interest less participant withdrawals and fees. Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis and related fees are recorded as administrative expenses and expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

***Payment of Benefits***

Benefit payments are recorded when paid.

***Administrative Expense Charges***

Certain administrative fees are charged against participant accounts by Mutual of America Life Insurance Company and Lincoln Financial Group Trust Company on a monthly basis for services provided. The expenses necessary to administer the Plan, including but not limited to, retaining necessary professional assistance from an attorney, an accountant, an actuary, or an investment advisor are paid by the Employer. All expenses except for account maintenance fees, transaction fees and investment fund management fees have been paid by the Employer and excluded from these financial statements. Employees are charged service fees for any loan and distribution transactions they request. In addition, certain investment related expenses have been reflected as an offset of investment income.

***Reclassifications***

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation. Such reclassifications had no impact on the Plan's net assets or changes in net assets.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

**3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., and Mutual of America Life Insurance Company, qualified institutions.

**4. Investments (continued)**

The Plan invests in a fully benefit-responsive fixed annuity contract with Lincoln Life & Annuity Company of New York ("LLACNY"). LLACNY maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value. The fully benefit-responsive contract is reported to the Plan by LLACNY at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

**5. Fixed Annuity Contract With Insurance Company**

The crediting interest rate is based on a formula agreed upon with the issuer, which cannot be less than 0%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) the Plan is no longer qualified under the IRC, (2) an uncured violation of the Plan's investment guidelines, (3) a breach of material obligation under the contract, (4) a material misrepresentation and (5) a material amendment to the agreement without the consent of the issuer.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The Plan has the right to terminate participation in the contract after twelve months and then withdraw the full balance without penalty within twenty-four months depending on contract liquidity and the interest rate environment.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A as of February 2025), Standard and Poor's (A+ as of July 2024), Moody's (A2 as of September 2024) and Fitch (A+ as of July 2024).

The Lincoln Stable Value Fund represents approximately 9% and 8% of the net assets available for benefits as of December 31, 2024 and 2023.

**6. Insurance Company General Account**

Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America. Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of their general account at a rate of at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (“NAIC”) standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00%.

Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year.

The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America’s sole discretion, they may credit a higher rate of interest to a participant’s contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The principal and previously credited interest is guaranteed by Mutual of America. This guarantee is subject to Mutual of America’s financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A- as of April 2025), Standard and Poor’s (A as of December 2022), and Fitch (BBB+ as of April 2025).

The interest accumulation account is not benefit responsive and is reported at fair value on the statements of net assets available for benefits.

The Mutual of America Interest Accumulation Account represents approximately 11% and 12% of the net assets available for benefits as of December 31, 2024 and 2023.

**7. Party-in-Interest Transactions**

The fixed income annuity investment is managed by LLACNY. LLACNY is related to the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for administrative expenses amounted to \$32,276 for the year ended December 31, 2024.

Participants who are active employees may borrow from their accounts and such loans qualify as party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Plan Sponsor, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

**7. Party-in-Interest Transactions (continued)**

The Plan has investments with Mutual of America Life Insurance Company in pooled separate accounts, and a general account. Mutual of America Life Insurance Company is the Custodian as defined by the Plan document and, therefore, these transactions qualify as party-in-interest transactions.

**8. Income Tax Status**

The Internal Revenue Service has determined and informed the plan document preparer by a letter dated June 30, 2020, that the Plan and its amendments are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invest in various investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
