To the Participants and Trustees of

Opinion

We have audited the financial statements of Minnesota Cement Masons - Plasterers - Shophands Local 633 Vacation Savings Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Minnesota Cement Masons - Plasterers - Shophands Local 633 Vacation Savings Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Description of the Plan

Minnesota Cement Masons - Plasterers - Shophands Local 633 Vacation Savings Fund (the Plan) was established in 1994 as a result of collective bargaining agreements between the local union and the contractors' association. The Plan is a multiemployer defined contribution vacation savings (welfare) plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is managed by a board of trustees consisting of an equal number of union and employer representatives.

Participants are initially eligible to participate in the Plan when employer contributions are made on their behalf. Eligibility continues until contributions cease.

An individual account is established for each participant. Under the current provisions of the Plan, participants' accounts are credited with employer contributions made on their behalf. No earnings are credited to participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Effective November 1, 2023, the Board of Trustees approved monthly transfers into individual accounts established by the participant at Minnesota Building Trades Credit Union (the Credit Union). Previously, payment of benefits was made by debit card.

Prior to November 1, 2023, contributions received on the participant's behalf were credited to their account following the end of the calendar quarter in which they were received. Deductions, fees and distributions from the participant's account were applied to the participant's account balance after a contribution was made. Under current provisions, contributions are transferred to the Credit Union on a monthly basis.

If a participant does not create an account at the Credit Union, amounts are held within the Plan until an account is created. The Plan makes diligent efforts to track down missing or unresponsive participants.

In accordance with provisions of the Plan, participants' accounts with no activity for two years are forfeited to the Plan. Forfeited accounts are available to pay the cost of Plan administration. A forfeited benefit may be reinstated and paid out, subject to an administrative fee as determined by the Board of Trustees. No amounts were forfeited for either of the years ended December 31, 2024 or 2023.

Note 1. Description of the Plan (continued)

At December 31, 2024 and 2023, unallocated amounts totaled \$99,380 and \$130,310 respectively.

Participants should refer to the summary plan description for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Contributions Receivable - Employer contributions due and not paid at year end are recorded as contributions receivable. Contributions owed as a result of payroll compliance audits are recorded upon settlement with the employer. An allowance for doubtful accounts is considered unnecessary and is not provided.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. There were no benefits that were approved for payment that had not been paid at either December 31, 2024 or 2023.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates currently in effect, as set forth in the collective bargaining agreement. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 primarily in Minnesota, North Dakota, and northwestern Wisconsin.

Estimates - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

The right to discontinue the Plan is reserved to the Trustees. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

Note 4. Tax Status

The Plan obtained a notice of exemption dated February 17, 1995, in which the Internal Revenue Service stated that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Funding Policy

The Plan is primarily funded by employer contributions as specified in collective bargaining agreements. The hourly contribution rate for the majority of participants covered under the Plan was \$3.28 through April 30, 2023, \$3.69 through April 30, 2024, and \$3.70 thereafter. Hourly contribution rates for the remainder of participants ranged from \$2.09 to \$6.85 during the years ended December 31, 2024 and 2023.

The Plan collects and remits dues to Operative Plasterers' and Cement Masons' International Association (the International Union) and the local union on behalf of participants on a monthly basis. Total International Union dues, both collected and remitted, were \$874,595 and \$898,391 for the years ended December 31, 2024 and 2023, respectively. Total local union dues, both collected and remitted, were \$1,987,125 and \$2,049,001 for the years ended December 31, 2024 and 2023, respectively. No amounts were due to the International Union or the local union at either December 31, 2024 or 2023.

Note 6. Related Organizations

The Plan is related to a health and welfare plan, a pension plan, an apprenticeship fund and a local union, all of which are tax-exempt.

The Plan became a member of Cement Masons, Plasterers and Shophands Service Corporation (the Service Corporation), a non-profit corporation organized and established to serve in a fiduciary capacity as the servicing and collection agent for the related tax-exempt organizations. The Service Corporation maintains a receiving agency account. Contributions for the Plan and related organizations are received and deposited in the receiving agency account. Amounts owed are routinely transferred to the respective organizations. No amounts were due from the Service Corporation at either December 31, 2024 or 2023.

Note 6. Related Organizations (continued)

Before the change in Plan provisions as described in Note 1, the Plan had an administrative services agreement with the related local union, under which participants could assign their vacation savings benefits or a portion thereof to the local union for payment of membership dues. Participants were required to provide written authorization to Plan before such distributions were made. Included in benefits paid are authorized transfers of membership dues of \$0 and \$161,278 from the participant accounts during the years ended December 31, 2024 and 2023, respectively. Fees paid by the local union under the administrative services agreement totaled \$0 and \$3,000 for the years ended December 31, 2024 and 2023, respectively.

Since the change in Plan provisions, the local union works directly with the Credit Union to request amounts from the participants' accounts to pay for membership dues.
