We have performed audits of the financial statements of Heico Holding, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Heico Holding, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution savings plan. All employees, except certain union groups of Heico Holding, Inc. (the Company), are eligible to become participants in the Plan if they were employed by the Company, its subsidiaries and affiliates who have adopted the Plan, on the first day of the month following one month of employment, provided he or she has attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants elect to make pretax contributions ranging from 1% to 50% of their total eligible compensation, subject to certain limitations. Effective January 1, 2024, participants who are eligible to make pretax contributions may elect to make Roth 401(k) contributions under the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Effective January 1, 2022, all newly hired employees eligible to become participants in the Plan will be enrolled in the Plan's automatic escalation feature at 5%, which will automatically increase their elective deferrals 1% annually up to 10%.

Safe harbor matching contributions are made to eligible participants equal to 100% of employee contributions up to 3% of compensation, plus an additional 50% safe harbor matching contribution on any additional 401(k) contributions that exceed 3% but do not exceed 5% of compensation for that payroll period. In addition to matching contributions, in any Plan year, each employer in its sole discretion may contribute to the Plan a discretionary contribution. There were no discretionary contributions for the year ended December 31, 2024.

Participants are eligible for the matching contributions and discretionary contributions upon completion of six months of service and at least 500 hours service requirement.

Participants direct the investment of their total account balances into various investment options offered by the Plan.

Participant Accounts

Participants can direct the investment of their accounts on a daily basis into the investment options offered by the Plan. Each participant's account is credited with the participant's contributions, Company contributions and allocations of the Plan's earnings. Allocations of the Plan's earnings to each participant's account are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan permits participants to borrow a maximum of \$50,000 or 50% of the participants' vested account balances. Loans are generally payable within five years, with the exception of loans to purchase a principal residence. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Participants can only have two loans outstanding at any time.

Vesting and Forfeitures

Participants are at all times fully vested in their own contributions, Company matching contributions and earnings thereon. Vesting in Company discretionary contributions is based on the following schedule:

Two years	20%
Three years	40%
Four years	70%
Five years	100%

Forfeited non-vested accounts from Company contributions totaled approximately \$9,800 and \$9,400 at December 31, 2024 and 2023, respectively. Forfeitures can be used to pay Plan expenses or to reduce Company Contributions. In 2024, there were no forfeitures used for contributions or expenses.

Payment of Benefits

Upon retirement, death, disability or termination of service, a participant may elect to receive a lump-sum distribution equal to his or her vested account balance. In addition, hardship distributions are permitted if certain criteria are met.

The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) changed the age at which participants are required to take required minimum distributions from their accounts. Under the new law, effective January 1, 2020, participant distributions may not be deferred past April 1 following the year in which the participant reaches the age of 72. The age increased to 73 in 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

The group annuity contract issued by Massachusetts Mutual Life Insurance Company and managed by Great West Investments, affiliates of Empower Trust Company (Empower) (Note G) is to be reported at contract value, which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract plus credited interest less participant withdrawals and fees.

Realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain management fees and operating expenses for administration of the Plan, such as record-keeping and custodial services, are deducted from income earned on a daily basis on investments in the funds included in the Plan and, therefore, are not separately reflected. Consequently, these management fees and operating expenses are reflected as a reduction of investment return for such investments, which is included in total investment income in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits

Benefit payments are recorded when paid.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are as follows:

- Level 1 - Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.
- Level 2 - Inputs are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, and include the following:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the assets or liabilities (including volatilities); and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs are unobservable for the asset or liability (including the entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability) and significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023:

Mutual funds - Valued at the quoted and actively traded net asset value (NAV) of shares held by the Plan at year end.

Pooled separate account - Valued at the NAV of units held by the Plan. The NAV is calculated daily by the annuity provider according to the methods described in the annuity contract and is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily.

Collective trust fund - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the investment manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - TAX STATUS

The Internal Revenue Service (IRS) issued a determination letter dated July 21, 2017, stating that the Plan was designed in accordance with the applicable Internal Revenue Code (IRC) requirements as of that date. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance, in all material respects, with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE E - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, all participants will become 100% vested in their Company discretionary contribution account balances.

NOTE F - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower and Empower Annuity Insurance Company, have certified that the data included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments, group annuity contract and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE G - SEPARATE ACCOUNT INVESTMENT

The SAGIC Diversified Bond Fund (Bond Fund) is a separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market. Under the terms of the separate account investment contract, participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their balances in the Bond Fund at contract value. Contract value represents contributions, plus credited interest, less participant withdrawals and fees. The Bond Fund is considered fully benefit-responsive notwithstanding the liquidation events under the contract that would limit the ability of the Plan to transact at contract value. Company initiated events, such as layoffs, a sale of a business unit, a Company merger, or not offering the Bond Fund to participants, are considered events that could be subject to the liquidity provisions of the fund. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The interest credited to the Bond Fund option is determined based on anticipated market returns for the underlying assets of the Bond Fund. The Bond Fund invests primarily in a diversified portfolio of investment-grade fixed income securities, such as corporate, U.S. government and its agencies, foreign issuers, and mortgage-backed and other asset-backed securities.

NOTE H - RISKS AND UNCERTAINTIES

The Plan provides participants the option to direct their contributions to numerous investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of these investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower or an affiliate of Empower and therefore qualify as party-in-interest transactions.

Notes receivable from participants held by the Plan also represent party-in-interest transactions.

NOTE J - DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024, certain participant contributions and loan repayments totaling \$24,336 were not remitted timely. The Plan is in the process of remitting lost earnings.

NOTE K - SUBSEQUENT EVENTS

The Company evaluated the Plan's December 31, 2024, financial statements for subsequent events through October 13, 2025, the date through which the financial statements were available to be issued. Plan management is not aware of any subsequent events that would require recognition or additional disclosure in the financial statements.
