INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants
Wm. B. Morse Lumber Co. Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Wm. B. Morse Lumber Co. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024, and the related statement of changes in net assets available for plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Wm. B. Morse Lumber Co. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. Description of Plan

The following brief description of the Wm. B. Morse Lumber Co. Retirement Savings Plan (“the Plan”) is intended to give a general summary of the Plan’s provisions. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General

The Plan is a salary reduction plan pursuant to Section 401(k) of the Internal Revenue Code, established on January 1, 1990 and restated effective January 1, 2024 as a Safe Harbor plan. It covers substantially all employees of Wm. B. Morse Lumber Co. (“the Company”) who meet certain age and length of service requirements. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participation

Full-time employees of the Company are eligible to participate after 3 months of service with the entry dates to be the start of the following month upon eligibility. Part-time employees are eligible to participate upon attaining 18 years of age and 1,000 hours of service as determined annually on the anniversary of his or her employment commencement date.

Contributions

The Company shall make deferral contributions (elective deferrals) on behalf of each eligible participant who has an executed salary reduction agreement in effect with the Company. Participants who are eligible to participate will automatically be set up to defer six percent of their eligible compensation each week unless the employee designates a different percentage or elects not to defer. Eligible participants may elect to defer a portion of their total annual eligible compensation into the Plan as a qualified pre-tax deferral or an after-tax Roth deferral.

During 2024, Safe harbor matching contributions amounted to \$217,079 and employer discretionary contributions totaled \$105,907.

The Company has 2 discretionary contribution provisions in the plan. The first is a weekly \$18 contribution for all plan participants, regardless of whether the employee makes a contribution to the plan. This amount is approved annually by the Company’s board of directors. The discretionary contribution total in 2024 is \$105,907 as noted above.

A second type of discretionary contribution may be made in an amount determined by the Company to be allocated using New Comparability formula where participants are assigned groups and contributions are made separately to each group. This contribution is subject to a last-day requirement and will be made on a Plan Year basis.

In addition, participants may transfer funds from other qualified plans with the consent of the plan administrator.

Participant accounts

Each participant shall have an account which will be credited with the participant's contributions, employer contributions, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances.

Vesting

Participants are immediately 100% vested in their elective deferrals, rollover contributions, and, discretionary employer contributions plus actual earnings. Vesting in discretionary matching contributions are based on years of continuous service.

A vested percentage for employer matching contribution is determined in accordance with the following vesting schedule. Participants will become fully vested upon reaching normal retirement age or passing away:

Payment of benefits

Upon retirement, death or disability, the entire account balance, if less than \$5,000, will be distributed in the form of a lump-sum payment. If the account balance is greater than \$5,000, the participant may choose a lump-sum distribution, a joint and survivor annuity, or equal installments over various periods based on life expectancy. In addition, lump-sum distributions may be made, with participant consent, under the following conditions: separation from service and upon the hardship of a participant as provided for in the Plan and in government regulations. The Plan also allows participants who have attained the age of 59½ and are still employed by the Company to obtain distributions from their vested accounts.

Notes receivable from participants

The Plan allows participants to borrow funds from their accounts. Loans may not exceed the lesser of 50% of the employee's vested account balance or \$50,000. No loan in an amount less than \$1,000 will be permitted. Repayments of principal and interest are made through payroll withholding. Interest on participant loans is fixed at the prime rate as of the first business day of the month the loan is originated. At any time, no more than one loan may be outstanding from the Plan to the participant. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Administrative expenses

All record keeping, tax filing, investment commissions and loan origination costs are paid from forfeitures or the Plan's assets:

2. Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) and present the net assets available for plan benefits and changes in those net assets.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Revenue recognition

Purchases and sales of securities are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Cash equivalents: Includes money market accounts, certificates of deposit and all highly-liquid instruments purchased with an original maturity of three months or less.

Mutual funds: Values are determined based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Income taxes

The Plan evaluates income tax positions for uncertainty to determine any tax positions that may not be fully sustained upon examination by taxing authorities, despite the belief that the underlying tax positions are fully supportable. Tax positions are reviewed on an ongoing basis and are analyzed in light of changing facts and circumstances, including progress of tax audits, developments in case law, and closing of statute of limitations. The Plan administrator has determined that the Plan has no uncertain tax positions. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

Plan management's review of subsequent events

The Plan administrator evaluated events occurring between the end of the most recent plan year and October 13, 2025, the date the financial statements were available to be issued.

3. Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Financial Group, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for plan benefits, the schedule of assets held for investment purposes and the related investment activity reflected in the statement of changes in net assets available for plan benefits.

5. Related Party Transactions

The Plan invests in mutual funds managed by of Principal Financial Group. Principal Financial Group acts as custodian for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Administrative fees paid to Principal Financial Group amounted to \$61,580 for the year ended December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated July 16, 2024 that the Plan is qualified and the trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operating in compliance with the applicable requirements of the Internal Revenue Code.
