The Plan is a defined contribution plan established to provide retirement and other benefits to all full-time, part-time and temporary employees of InDyne, Inc. (InDyne or the Company). However, certain union employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

#### *Trustee, Custodian and Administration of the Plan*

The trustee, custodian and recordkeeper of the Plan is Empower Annuity Insurance Company and Empower Trust Company, LLC (collectively, Empower). The administrator of the Plan is the Company. Empower holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Contributions*

Participants may contribute up to a certain percentage of their compensation, as defined in the Plan. This percentage varies for certain groups of employees. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes contributions to employees, depending on the type or group of employees as follows:

- Employer matching contribution of 100% of each Participant's elective deferrals up to the first 3% of compensation and a 50% match of elective deferrals between 3% and 5% of compensation.
- Employer matching contribution equal to 100% of the first 4% of the employee contribution.
- Employer contribution equal to 4% of base pay only.
- Employer contribution equal to \$3.30 or \$3.65 per hour, to a maximum of 2,080 hours per year.

Both participant and employer contributions are subject to the nondiscrimination requirements of the Internal Revenue Code (the IRC).

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and allocations of the Company's matching and profit sharing contribution, if any, and Plan earnings and losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions and all Company contributions plus earnings and losses thereon.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 1%, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 120 months. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

In addition, each participant may not have more than one loan outstanding at any time.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement or any other reason, a participant or beneficiary may elect to receive a lump sum amount, defer payment until retirement age established by the Plan, or receive an annuity equal to his or her vested account balance. However, if the employee's vested balance is less than \$7,000, he or she must receive a lump-sum distribution. In certain hardship situations, as described in the Plan, participants may withdraw all or part of their account balances while actively employed.

### ***Forfeitures***

Forfeited accounts are utilized first to reduce Plan expenses and second to reduce employer contributions. Remaining forfeitures are allocated to participants in proportion to each participant's compensation for the year. During the year ended December 31, 2024, no forfeitures were used to pay Plan expenses or to reduce employer contributions. As of December 31, 2024 and 2023, the total balance in the forfeiture accounts was \$5,594 and \$909, respectively.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors. See Note 4 for further information related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### ***Revenue Credits***

The Plan's trust agreement with Empower provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. Unallocated revenue credits at December 31, 2024 and 2023 are \$76,580 and \$73,506, respectively. During 2024, the Plan allocated \$349 certain participant earnings and \$1,168 to pay administrative expenses. The allocation to participants earnings and administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

### 3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Account* - The Plan invests in a self-directed brokerage account (SDBA) offered through Charles Schwab & Co., Inc. The SDBA allows participants to select from numerous

mutual funds, exchange-traded funds (ETFs), and/or other types of securities, such as stocks and bonds, for an additional fee. The Plan's SDBA currently holds mutual funds and common stocks.

*Common Stock* - Equity securities listed or traded on a national market or exchange are valued based on their sale price at the official close of business of such market or exchange on the valuation date, or if there is no official close of business, the latest sale price, or at the mean of the latest available bid and asked prices if no sale is reported.

*Collective Trusts (CTs)* - Collective trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CT less its liabilities. This practical expedient is not used when it is determined to be probable that the CTs will sell for an amount different than the reported NAV. The CTs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

*Variable Annuities* - The Plan's investments in variable annuities are valued at NAV per share based on quoted market prices for the underlying investments. The, NAV, as provided by the custodian is used as a practical expedient to estimate fair value. There are no unfunded commitments from participants in the Plan who invest in these accounts.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Parties and Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the current trustee and custodian as defined by the Plan and, therefore, transactions with Empower qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Delinquent Participant Contributions

During the Plan year ended December 31, 2021, certain participant contributions and loan repayments were not remitted to the Plan within the period prescribed by Department of Labor regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Company corrected these transactions in 2025.

### 7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to suspend or discontinue contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of complete or partial Plan termination, the trustee shall determine whether the assets of the Plan shall continue to be held in trust or be liquidated and distributed in accordance with the terms of the Plan.

### 9. Income Tax Status

Effective January 1, 2023, the Plan adopted the Non-Standardized Pre-Approved Profit Sharing Plan (Pre-Approved Plan) established by Empower Retirement, LLC. The IRS ruled on November 14, 2022, that the Pre-Approved Plan, including related amendments, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since the adoption of the Pre-Approved Plan. The Plan Administrator believes the Plan is currently designed and is being operated in accordance with the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
