## **INDEPENDENT AUDITORS' REPORT**

To the Participants and Trustees of the  
RDR, Inc. 401(k) Profit Sharing Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of RDR, Inc. 401(k) Profit Sharing Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. ## **Responsibilities of Management for the Financial Statements**

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. DESCRIPTION OF THE PLAN**

The following description of the RDR, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan, which was established effective January 1, 1989, by RDR, Inc. (the Company). The Plan covers all eligible employees of the Company, with no minimum age or service requirements. The Plan was most recently amended effective January 1, 2024 to comply with recent tax law changes.

**Participant Contributions**

Participants may contribute up to 50% of their gross compensation, as defined by the Plan, not to exceed the maximum allowable contribution limit under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants may also contribute post-tax Roth elective contributions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code. Participants are permitted to make rollover contributions to the Plan.

**Automatic Enrollment**

The Plan has an automatic enrollment feature whereby an eligible employee will be automatically enrolled to contribute to the Plan at a rate of 6% of eligible compensation, as defined by the Plan, unless the employee opts out of participation in the Plan or elects another deferral percentage. The initial percentage will increase on the fifteenth day of each Plan year by 1% of eligible compensation, up to a maximum of 10% of eligible compensation.

**Company Contributions**

The Plan allows for discretionary matching and nonelective profit sharing contributions. The Company made discretionary matching contributions totaling \$422,964 for the year ended December 31, 2024. The Company did not make any nonelective profit sharing contributions for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is participant-directed and credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**Vesting**

Participants are immediately vested in their contributions and all matching and profit sharing contributions made by the Company, plus actual earnings thereon.

**Payment of Benefits**

Upon termination of service due to death, disability, normal retirement age, or attainment of age 59½, a participant or their beneficiary, in the event of death, is entitled to a distribution of their vested account balance. Distributions from the Plan are payable in the form of a lump sum or installment payments equal to the value of the participant's vested interest in his or her account. Upon termination, if a participant's account balance is less than \$7,000, the Plan administrator may elect to automatically distribute the participant's account balance. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59½. Distributions are subject to the applicable provisions of the Plan agreement. There were no net assets of the Plan allocated to the accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024 and 2023.

**Forfeitures**

Forfeitures resulting from Company contributions made relating to excess participant contributions, as determined from annual discrimination testing, can be used to reduce future Company contributions. As of December 31, 2024 and 2023, there were no forfeitures available to reduce future Company contributions. There were no forfeitures used to offset Company contributions for the year ended December 31, 2024.

**Notes Receivable from Participants**

Participants may borrow up to 50% of their vested account balance not to exceed \$50,000. The minimum note amount is \$1,000 and a participant cannot hold more than one outstanding loan at any given time. The notes are collateralized by the participant's vested account balance. The period of repayment may not exceed five years. All notes bear interest at rates comparable to those offered by financial institutions at the time of note origination, as determined by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions.

**Plan Expenses**

Expenses incurred in the administration of the Plan are required to be paid by the Trustee with net assets of the Plan unless paid by the Company, at its discretion. A portion of the Plan's direct expenses were paid by the Company during the year ended December 31, 2024. Administrative expenses totaling \$75,367 were paid directly from the Plan for the year ended December 31, 2024.

Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and changes therein at the date of the financial statements and reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect the amounts reported in the statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

**Fair Value Measurement**

Accounting Standards Codification, *Fair Value Measurement* (ASC 820), defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

*Interests in common/collective trusts:* Valued at the net asset value (NAV) of shares held by the Plan at year-end as a practical expedient.

*Interests in pooled separate accounts:* Valued at the net asset value (NAV) of shares held by the Plan at year-end as a practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes become due immediately upon termination of a participant’s employment. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Subsequent Events**

The Plan evaluated for disclosure any subsequent events through July 30, 2025, the date the financial statements were available to be issued, and determined there were no material subsequent events that warrant disclosure.

**3. INVESTMENTS**

All investment information contained in the accompany financial statements and supplemental schedule, including assets held as of December 31, 2024 and 2023, and interest and dividend income and net realized and unrealized appreciation in the fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the Custodian and Trustee of the Plan.

**4. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by an affiliate of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the Custodian and Trustee of the Plan. The Plan allows for participants to take loans against their vested account balances. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

**5. PLAN TERMINATION**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**6. INCOME TAX STATUS**

The Plan is governed by a pre-approved plan document sponsored by Principal Life Insurance Company. The pre-approved plan document received an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the Plan and related trust are designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving this opinion letter, but management believes the Plan remains in conformity with the Code and is exempt from Federal taxes. Therefore, no provision for income taxes has been recorded in the accompanying financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, these provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open periods.
