INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
SRK Retirement and Savings & Investment Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SRK Retirement Savings & Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the SRK Retirement Savings & Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General—The Plan is a defined-contribution plan. All employees, excluding trainees, of SumiRiko Ohio, Inc. (the Company or the Plan Sponsor), as well as Sumitomo Riko America, Inc. and SumiRiko Technical Center America, Inc. are eligible to participate in the Plan. The Investment Policy Committee has been appointed to control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company (FMTC) serves as the trustee of the Plan and Fidelity Workplace Services LLC serves as the recordkeeper of the Plan.

The Company was incorporated in January 1988 as a wholly owned subsidiary of Sumitomo Riko Co., Ltd., a public company in Japan. The Company is a manufacturer of automotive parts, and its products are primarily sold in the U.S.

Contributions—Participating employees may contribute any whole percentage of their wages up to the maximum percentage allowable not to exceed the limits of Internal Revenue Code (IRC) Section 401(k), 402(g), 404, and 415. Annual employee contributions were limited to \$23,000 in 2024 and \$22,500 in 2023, as indexed by the Internal Revenue Service (IRS). The Plan allows for tax deferred contributions, as well as Roth contributions. The Plan also places certain restrictions on contributions from those employees defined as highly compensated. Participants 50 years of age and older were also allowed to contribute an additional \$7,500 in 2024 for catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage for participants automatically enrolled will increase by 1% per year up to a maximum of 10% of eligible compensation.

The Plan provides for employer matching contributions in an amount equal to 50% of the first 6% of each eligible participant's compensation contributed to the Plan.

The Plan also allows for nonelective (discretionary) contributions by the Company. During 2024, there were no qualified discretionary contributions.

Participant Accounts—Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of the Company's nonelective contribution and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting—Participants are vested immediately in their contributions, plus actual earnings thereon. A participant’s vested interest in his/her nonelective and matching contributions subaccounts shall be 0% until the participant has completed one year of vesting service at which time his/her vested interest shall be 100%.

Investments—Upon enrollment in the Plan, participants have full discretion in how their funds and any Company contributions are allocated and invested in the Plan’s various investment options. Participants may change their investment options daily.

Notes Receivable from Participants—The amount participants may borrow from their fund accounts shall not exceed the lesser of \$50,000 reduced by the excess, if any, of the highest outstanding balance of any other loan to the participant from the Plan or any other plan maintained by the Plan Sponsor during the preceding 12-month period over the outstanding balance of such loans on the date a loan is made hereunder; or 50% of the vested portions of the participant’s account and his/her vested interest under all other plans maintained by the Plan Sponsor. The loans are secured by the balance in the participant’s account and bear interest at the prime rate, plus 1% on the day that the loan is issued, updated quarterly. Loan terms range between one and sixty months. As of December 31, 2024, participant loans have maturities through 2031 at interest rates ranging from 4.25 percent to 9.50 percent.

Payment of Benefits—On termination of service, for any reason other than retirement, death, or disability, the participant is eligible to receive his/her entire salary deferral account and the vested portion of his/her company account in cash. Upon retirement, death, or disability, a participant may generally elect to receive distribution of all or a portion of his/her account in a series of monthly, quarterly, annual, or semiannual installments over a specified period. In-service withdrawals are also permitted in certain situations.

Forfeited Accounts—Nonvested employer contributions of terminated employees remain in their accounts for one year or five years from the date of termination depending on whether the employee takes a distribution of his/her vested balance. If the employees are subsequently rehired within the applicable periods mentioned above, they shall have such forfeited amounts recredited to a new account in his/her name, without adjustment for interim gains or losses experienced by the Plan. After such period, forfeitures may be first used to pay administrative expenses under the Plan and any remaining forfeitures not used to pay administrative expenses under the Plan shall be applied to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,353 and \$26,568, respectively.

Administrative Expense—Certain administrative expenses of the Plan are paid by the Plan’s sponsor as provided in the plan document and are not reflected in the accompanying financial statements. Individual participants pay administrative costs for loans, distributions and qualified domestic relation orders, as applicable.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan utilizes various investment instruments, including a fully benefit-responsive investment contract and mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events

which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Policy Committee determines the Plan's valuation policies utilizing information provided by the trustee and insurance carrier. See Note 4 for a discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to the fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments, which consists of realized gains and losses and unrealized appreciation or depreciation on assets held at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits—Benefit payments to participants are recorded when paid.

Deemed Distributions of Loans to Participants—Deemed distributions of loans to participants represent loans with no repayments for more than 90 days that are deemed distributed and taxed. If a participant received a deemed distribution as a result of a layoff, he/she is able to refinance the loan upon returning to work with the current employer. Deemed distributions were \$ 28,593 and \$ 22,626 in 2024 and 2023, respectively and is included within benefits paid to participants in statement of changes in net assets available for benefits.

Administrative Expenses—All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that were prepared by or derived from information prepared by Fidelity Management Trust Company, the

trustee of the Plan and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENT

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Mutual funds are reported at fair value based on the unadjusted quoted market price of the fund from national exchanges and are classified within Level 1 of the valuation hierarchy.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a contract with Massachusetts Mutual Life Insurance Company (Mass Mutual). The contract includes a benefit-responsive contract (Guaranteed Interest Contract) for which Mass Mutual holds the assets in a separate account and therefore is reported at contract value. The benefit-responsive contract is credited with earnings and charged for participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan’s ability to transact at contract value with the issuer. The Plan Administrator believes the occurrence of such events that would also limit the Plan’s ability to transact at contract value with the plan participants is not probable. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

6. PARTY-IN-INTEREST TRANSACTIONS

Transactions with the trustee qualify as parties-in-interest transactions. The Plan paid certain administrative fees to the trustee, which qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 4975 of the ERISA regulations.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. FEDERAL INCOME TAX STATUS

The underlying nonstandardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax.
