Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of G1 Therapeutics 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of G1 Therapeutics 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of G1 Therapeutics 401(K) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Terminating Plan

As further discussed in Notes 1 and 5 to the financial statements, on September 18th, 2024, the Company was acquired by Pharmacosmos Therapeutics Inc, a wholly owned subsidiary of Pharmacosmos A/S. Upon close of the transaction, the Board of Directors of Pharmacosmos Therapeutics, Inc voted to terminate the Plan. Effective the date of the acquisition, all future contributions to the Plan were discontinued. The Plan was terminated on December 18, 2024, at which time all plan assets were liquidated. In accordance with accounting principles generally accepted in the United States of America, the plan will use the liquidation basis of accounting instead of the normally required accrual basis of accounting in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. DESCRIPTION OF PLAN

The following description of G1 Therapeutics 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- a. General – The Plan is a defined contribution plan established on January 1, 2015. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of G1 Therapeutics, Inc. (the "Company" and "Plan Sponsor") who are 21 years of age and have completed 30 consecutive days of service from the employee's employment commencement date are eligible to participate in the Plan. Union employees, nonresident aliens, and leased employees are excluded from participation in the Plan. The Plan management is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Plan Trustees.

Effective January 1, 2022, the Plan was restated through the adoption of a Non-Standardized Defined Contribution Pre-Approved Plan, containing substantially all the same provisions as the previously adopted Non-Standardized 401(K) Profit Sharing Plan.

On September 12, 2024, the Plan was amended to implement provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The Plan Sponsor has elected not to provide any of the relief provisions established by this act.

On September 12, 2024, the Plan was amended to implement the provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Acts. The Plan Sponsor has elected to provide all provisions established by this act.

On September 18th, 2024, the Company was acquired by Pharmacosmos Therapeutics Inc, a wholly owned subsidiary of Pharmacosmos A/S. Upon close of the transaction, the Board of Directors of Pharmacosmos Therapeutics Inc voted to terminate the Plan. Effective the date of the acquisition, all future contributions to the Plan were discontinued. The Plan was terminated on December 18, 2024, at which time all plan assets were liquidated. See note 5 for more details regarding the termination.

- b. Contributions – Participants may contribute up to the maximum amount allowed by law of pretax or after-tax annual compensation each year, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan document provides for both a discretionary matching contribution and nonelective contribution by the Company on a uniform basis for all participants each Plan year. The Company has a flexible discretionary match, in which the employer in its sole discretion elects to make to the Plan. For the plan year 2024, the Company elected to contribute 50% of the first 6% contributed to the Plan, for a potential maximum 3% matching contribution per pay period. Per the Plan document, the Company is also given the discretion to make true-up contributions in which the matching contribution is applied on a plan year basis; the Company elected to make these true-up contributions for the plan year 2024. The Company did not make a discretionary nonelective contribution for 2024.

- c. Participant Accounts – Each participant's account is credited with (1) the participant's contribution, (2) the Company's contributions, and (3) allocation of (a) plan earnings and (b) administrative expenses that are paid by the Plan. Allocations are based on participant's plan compensation or participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. Vesting – Participants are vested immediately in their elective contributions plus actual earnings thereon. Participants are also vested immediately in both the Company discretionary matching contributions and nonelective contributions.
- e. Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one outstanding loan from the Plan at a time. The loans are secured by the balance in the participant's account and bear interest at prime plus 1.00% at the date of the loan issuance. Loans must be repaid within 5 years, except for loans for the purpose of acquiring a principal residence, whose term shall be determined by the Plan administrator. Generally, principal and interest are paid ratably through semimonthly payroll deductions. Interest rates on the outstanding loans as of December 31, 2023 and new loans issued in 2024 range from 6.50% to 9.50%. There were no defaulted Plan loans due to John Hancock in 2024.
- f. Payment of Benefits – Upon termination of service due to death, disability, retirement, or any other reason, the participant or beneficiary may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account. Partial withdrawals are also permitted. In addition, during active service, a participant can take hardship distributions if certain conditions are satisfied, and a participant, upon the attainment of age 59 ½, can take in-service distributions from their accounts in which they are vested.
- g. Forfeited Accounts – At both December 31, 2024 and 2023, there were no forfeited nonvested accounts. For the year ended December 31, 2024, there were no forfeitures of terminated participants' nonvested accounts. Forfeitures of terminated participants' nonvested accounts may be used to reduce employer contributions or pay Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared using the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, third party administrator, and the insurance company. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document and loan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation or depreciation of fair value of investments.

3. FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, *Fair Value Measurements*, which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

FASB ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The categorization of each investment type within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

FASB ASC 820 established three levels of inputs that may be used to measure fair value. Level 1: Quoted prices in active markets for identical assets or liabilities at the measurement date; Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active market for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or Level 3: Unobservable inputs that are supported by little or no market activity and that reflect the Plan’s own assumptions about market participants and prices. However, in accordance with ASC 820-10, certain investments measured at fair value using the net asset value per share (or its equivalent) practical expedient are not classified in the fair value hierarchy (see Pooled Separate Accounts note below).

Investment Valuation

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

Valued at the net asset value (“NAV”) of units of a fund. The NAV is based on the fair value of the underlying mutual funds registered with the Securities and Exchange Commission held by the fund, as determined by quoted prices of identical assets in an active market, less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the insurance company reserves the right to temporarily delay withdrawal from the Plan in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. INFORMATION CERTIFIED BY THE PLAN'S INSURANCE COMPANY

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock Life Insurance Company, a qualified institution, except for comparing such information certified by the qualified institution to information included in the Plan's financial statements and supplemental schedule.

5. PLAN TERMINATION

The Company had the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balance.

On September 18th, 2024, the Company was acquired by Pharmacosmos Therapeutics Inc, a wholly owned subsidiary of Pharmacosmos A/S. Upon close of the transaction, the Board of Directors of Pharmacosmos Therapeutics Inc voted to terminate the Plan. Effective the date of the acquisition, all future contributions to the Plan were discontinued. Following the discontinuation of contributions to the Plan, participants were given the option to enroll in the Pharmacosmos Therapeutics Retirement Plan (the "PTI 401(K) Plan"). The Board approved an amendment to the PTI 401(K) Plan to provide that (i) the Company shall be a participating employer in the PTI 401(K) Plan, and (ii) employees of the Company as of September 18, 2024 shall receive credit for service rendered to the Company for purposes of eligibility and vesting under the PTI 401(K) Plan, to the same extent such service was taken into account under the Plan. The Plan was terminated on December 18, 2024, at which time all plan assets were liquidated.

6. TAX STATUS

The Company adopted Qualified Retirement Plan Services, Inc's Prototype Non-Standardized Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020 which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held in pooled separate accounts held by the insurance company. John Hancock Life Insurance Company is the insurance company for the Plan's assets; therefore, transactions between the Plan and the insurance company qualify as party-in-interest transactions. For the year ended December 31, 2024, John Hancock Insurance Company was paid \$8,907 for plan administration.

Qualified Retirement Plan Services, Inc. (QRPS) is the third party administrator for the Plan; therefore, transactions between the Plan and QRPS qualify as party-in-interest transactions. For the year ended December 31, 2024, QRPS was paid direct compensation of \$8,100 for plan administration and indirect compensation of \$6,623 in commissions and other allowances.

Cetera Advisors LLC is the investment broker for the Plan; therefore, transactions between the Plan and the investment broker qualify as party-in-interest transactions. For the year ended December 31, 2024, Cetera Advisors LLC was paid indirect compensation of \$33,084 in commissions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

9. CONCENTRATIONS

At December 31, 2023, 15% of investments were held in each of the John Hancock Multimanager 2030 Lifetime and John Hancock Multimanager 2035 Lifetime pooled separate accounts.

10. SUBSEQUENT EVENTS

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 14, 2025 which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.
