1. DESCRIPTION OF THE PLAN:

The following brief description of the Good News Publishers 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a 403(b) retirement plan covering substantially all full-time employees of Good News Publishers (Good News), except interns and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The retirement committee is responsible for oversight of the Plan.

CONTRIBUTIONS

Participants may make elective deferral contributions up to the limits prescribed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Good News provides an employer matching contribution of \$0.25 of every \$1 contributed by employees to an annual maximum of \$1,500. Good News also makes discretionary contributions to the Plan, as determined by the Board of Directors.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Good News' contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed.

VESTING

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in their employer contributions as follows:

1. DESCRIPTION OF THE PLAN, continued:

FORFEITURES

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,261 and \$1,457, respectively. These accounts will be used to reduce future employer contributions. Employer forfeitures of \$6,595 and \$7,003 were used to reduce the employer receivable to be paid into in the Plan during 2024 and 2023, respectively.

PAYMENT OF BENEFITS

Upon termination of service, death or disability, participants with account balances greater than \$5,000 generally receive payments in the form of a lump-sum or purchase of an annuity contract. Participants with vested account balances of \$5,000 or less will receive a single lump-sum payment. Upon proof to the satisfaction of the Plan Administrator of an immediate and heavy financial need, a participant may make a hardship withdrawal from employee elective deferral funds.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The fair value of the pooled separate account units is principally derived from the market value of the underlying mutual funds. Fixed annuity contracts are reported at contract value, which represents fair value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Variable annuity contracts are funded through a separate account that invests in mutual funds. The underlying investments are generally valued using market quotes obtained from independent pricing services.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, Good News has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

6. TAX STATUS:

403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. However, the Plan administrator believes that the Plan was designed in compliance with the applicable requirements of the Internal Revenue Code and will take the necessary steps, if any, to maintain the Plan's qualified status.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTIES-IN-INTEREST:

Certain investments for the Plan are units of funds managed by TIAA and CREF. TIAA and CREF performs recordkeeping services for the Plan, therefore, these transactions qualify as party-in-interest transactions. Total assets under recordkeeping services with TIAA-CREF were \$124,658 and \$120,391 for the years ended December 31, 2024 and 2023, respectively.

Collective investment funds are managed by Nationwide Trust Company, FSB. Nationwide performs recordkeeping services for the Plan, therefore, these transactions qualify as party-in-interest transactions. Total assets under recordkeeping services with Nationwide Trust Company, FSB were \$22,280,896 and \$18,796,993 for the years ended December 31, 2024 and 2023, respectively. Indirect fees paid to TIAA and CREF and Nationwide are netted against appreciation of investments in the statement of changes in net assets available for benefits.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through October 15, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
