### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Bright Future Electric 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### **Note 1 – Plan Description**

The following description of the Bright Future Electric 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Bright Future Electric, LLC (the “Company” or “Employer”). The Plan commenced effective February 1, 2007, and was amended and restated effective March 29, 2022, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

##### ***Plan Custodian and Trustee***

Fidelity Management Trust Company (“Fidelity,” the “Custodian,” or “Trustee”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

##### ***Plan Merger – Transfers of Assets to this Plan***

Eligible employees of Funderburk Electrical Services, LLC who participated in the CoAdvantage Corporation Retirement Savings Plan, a multiple employer plan, merged into the Plan effective May 1, 2024. The formal transfer of all assets was completed and net assets totaling \$681,109 were transferred from the CoAdvantage Corporation Retirement Savings Plan into the Plan.

##### ***Eligibility and Plan Entrance Date***

All employees of the Company become eligible to participate in the Plan upon reaching 18 years of age and completing six months of service. Eligible employees are permitted to enter the Plan on the first day of each month after which the employee has satisfied the eligibility requirements.

##### ***Participant Contributions***

Participants may elect to contribute, on a before-tax or Roth basis, up to 100% of their annual compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Each year, on January 2, participants with a deferral rate greater than 0% will have their deferral contribution rate increased by 1% until the rate reaches a maximum of 8% of eligible compensation, unless they elect otherwise.

##### ***Rollover Contributions***

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

#### Note 1 – Plan Description (continued)

##### ***Employer Contributions***

The Company may make discretionary Employer contributions as determined by the Employer. For the year ended December 31, 2024, the Company made discretionary contributions equal to 25% of the participant deferrals on the first 8% of the employee's eligible compensation contributed to the Plan. The Plan uses a year end true-up matching contribution feature to allow participants to receive the maximum matching contribution available by making up for any loss in matching contributions resulting from the participant's individual savings strategies.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's discretionary contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are immediately vested in all contributions, plus actual earnings thereon.

##### ***Participant-Directed Investments***

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants have the option of directing their account balances to one or more of these investment options, which vary in types of investments, rates of return, and investment risk.

##### ***Payment of Benefits***

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant receives a lump sum distribution of the vested portion of their account balance. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If the vested account balance is less than or equal to \$1,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all, or a portion of their vested account balance, in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59½.

##### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$616 and \$3,480, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative expenses. In 2024, forfeitures of \$4,536 were used to pay Plan administrative expenses.

#### Note 2 – Summary of Significant Accounting Policies

##### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

#### Note 2 – Summary of Significant Accounting Policies (continued)

##### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

##### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

##### *Payments of Benefits*

Benefit payments to participants are recorded when paid.

##### *Administrative Expenses*

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs to the valuation methodology that are unobservable inputs for the assets or liability.

#### Note 3 – Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Money Market Funds** – Valued at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.
- **Common Collective Trust Fund** – The fair value of participation units held in collective trusts are based on the NAV reported by the fund managers as of the financial statement dates and recent transaction prices. The NAV is used as a practical expedient to estimate fair value. The investment objective of the collective trust is to provide preservation of capital and provide relatively stable returns consistent with a low-risk profile. The collective trust provides for daily redemptions by the Plan at reported NAV per share with no advance notice requirement; there are no unfunded commitments.

#### Note 5 – Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and units of the common collective trust fund managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

#### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### Note 7 – Tax Status

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by FMR, LLC. The IRS has determined and informed FMR, LLC by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
