### **Basis for Opinion**

### **Responsibilities of Management for the Financial Statements**

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Pension Plan for Employees of Henry & Henry, Inc. (the "Plan") is provided for general purposes only. Participants should refer to the Plan document for more detailed information.

#### **General**

The Plan is a non-contributory defined benefit pension plan that covered substantially all employees of CSM Bakery Products North America, Inc.'s Lancaster, New York operation (the "Company"), formerly known as Henry & Henry, Inc. prior to being frozen. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Pension Benefits**

Effective December 31, 2005, accrued benefits for all participants were frozen. Employees who met the age and length of service requirements of the Plan as of December 31, 2005 are entitled to participate. No additional employees are eligible to participate in the Plan.

All participants of the Plan as of December 31, 2005 became immediately fully vested in their pension benefits. In addition, for purposes of determining benefits for participants, earnings and years of service were frozen at levels determined as of December 31, 2005.

#### **Payment of Benefits**

Beginning at normal retirement age (65), participants are entitled to a monthly benefit equal to 0.6 of 1.0% of their 2001-2005 average monthly compensation for each year of service, not to exceed a maximum monthly benefit of \$1,500. The Plan permits early retirement after 10 consecutive years of service at ages 60-64, at a reduced benefit. Participants may elect to receive their pension benefits in the form of a joint and survivor annuity. At the discretion of the Plan administrator, vested accrued benefits less than \$5,000 may be distributed immediately after termination or retirement.

#### **Death Benefit**

As specified in the Plan, a death benefit is payable to the surviving spouse of a married participant in the event that a participant dies before receiving retirement benefits.

#### **Funding Policy**

The Company's funding policy is to make contributions to the Plan periodically as cash flow permits up to the maximum recommended contribution allowed under Section 404 of the Internal Revenue Code of 1986 and to meet the minimum contribution required by ERISA. The employer contribution for 2024 and 2023 was \$116,383 and \$109,246, respectively, which met the minimum funding requirement.

#### **Plan Administration**

The Plan is administrated by the Company. Participant account records are maintained by Actuarial Consulting Services, Inc., the third party administrator of the Plan. Empower Retirement, LLC is the Trustee of the Plan. Costs of administration are paid primarily by the Company. A portion of Plan expenses may be charged to the Plan.

## 1. DESCRIPTION OF PLAN (Continued)

### Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that retired participants or their beneficiaries have been receiving for at least three years, or that participants eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (“PBGC”) (a U.S. Government agency) up to the applicable limitations (discussed below).
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor’s pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan’s termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual’s monthly benefit that the PBGC guarantees. For Plan terminations occurring during 2024, the ceiling was \$6,750 per month. This ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The Plan’s policy is to prepare its financial statements in accordance with the accrual basis of accounting in conformity with accounting principals generally accepted in the United States of America.

### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Investments

Investments are stated at contract value as reported by Empower Life & Annuity Insurance Company of New York (Empower Life & Annuity). Investment income represents earnings on the underlying investment contract, which are credited to the investment contract monthly.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

### **Payment of Benefits**

Benefit payments are recorded when paid.

### **Income Taxes**

The Internal Revenue Service has determined and informed the Plan by a letter dated March 30, 2018 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan's management and the Plan's tax advisors believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

## **3. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has an investment contract with Empower Life & Annuity. Empower Life & Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses. Empower Life & Annuity is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by Empower Life & Annuity, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. The Plan may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to transact at contract value with Empower Life & Annuity could be limited if the Plan administrator terminates the contract. The Plan administrator does not believe that the occurrence of this event is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **4. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

As of December 31, 2005, the Plan was frozen. As a result, the actuarial method was changed to the unit credit actuarial cost method from the frozen initial liability actuarial cost method for subsequent years. This unit credit actuarial cost method determines costs based on present values of accrued benefits for each participant for the frozen plan.

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to services rendered by the employees through December 31, 2005. Accumulated plan benefits include benefits expected to be paid to (1) retired or terminated participants or their beneficiaries, (2) beneficiaries of participants who have died, and (3) vested participants or their beneficiaries. Benefits for retired or terminated participants or their beneficiaries are based on participants' compensation during their 2001-2005 years of credited service.

An actuary from Actuarial Consulting Services, Inc. determines the actuarial value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the expected date of payment.

#### 4. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS (Continued)

The significant actuarial assumptions used in the valuation as of January 1, 2024 were:

1. Life expectancy of participants is based on the following: the Pri-2012 Total Employee Table with generational Mortality Improvement Adjusted Scale MP-2021, separately for males and females, for pre-retirement participants; the Pri-2012 Total Healthy Retiree Table with generational Mortality Improvement Adjusted Scale MP-2021, separately for males and females, for post-retirement participants; and the Pri-2012 Total Disabled Retiree Table with generational Mortality Improvement Adjusted Scale MP-2021, separately for males and females, for disabled participants
2. Retirement age is 65.
3. Investment return rate is 4.37% in the first 5 years, 4.96% for benefits expected to be paid in the next 15 years, and 4.95% for benefits expected to be paid thereafter, were used for the January 1, 2024 valuation. (Investment return rate is 2.13% in the first 5 years, 3.62% for benefits expected to be paid in the next 15 years, and 3.93% for benefits expected to be paid thereafter, were used for the January 1, 2023 valuation.)

The foregoing actuarial assumptions are based upon the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

#### 5. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee, Empower Retirement, LLC. The incorporation of this financial information in the accompanying financial statements is based solely on their certification and has not been audited by independent accountants.

#### 6. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a group annuity contract with Empower Life & Annuity as December 31, 2024 and 2023, respectively. Transactions in this investment qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

## **7. RISKS AND UNCERTAINTIES**

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

## **8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

**SUMMARY OF PLAN PROVISIONS**

**Plan Year:** January 1 to December 31.

**Participation:** Employees enter the plan on the first day of the month coincident with or next following attaining age 21 and completing one year of employment. Due to a plan freeze effective 12/31/05, no new participants will enter this plan after 12/1/05.

**Vesting Service:** One year of service for each plan year during which an employee works at least 1,000 hours.

**Benefit Service:** One year of service for each plan year during which an employee works at least 1,000 hours.

**Normal Retirement Date:** First day of month coincident with or next following the participant's 65<sup>th</sup> birthday.

**Average Compensation:** Average of final five years total compensation. Due to plan freeze effective 12/31/05, compensation after that date will not be used.

**Normal Retirement Benefit:** The annual benefit is 0.6% of average compensation times years of benefit service (annual maximum \$18,000). Due to freeze effective 12/31/05, no further benefits will accrue.

**Accrued Benefit:** Normal Retirement benefit multiplied by the ratio of accrued benefit service over projected service at normal retirement.

**Normal Form of Benefit:** Life annuity for single participants or an actuarially equivalent joint and 50% survivor annuity for married participants.

**Late Retirement Benefit:** Greater of benefit provided by normal benefit formula at late retirement date or the actuarial equivalent of participant's normal retirement benefit.

**Early Retirement Benefit:** A participant age 60 or older who has completed at least ten years of service may retire and receive his accrued benefit, actuarially reduced for payment prior to normal retirement age.

**Termination Benefit:** A participant's accrued benefit is fully vested after completing five years of vesting service. Due to plan freeze effective 12/31/05, all participants active at that time will become 100% vested.

**Disability:** No provision for additional disability benefits in this plan.

**Death Benefit:** The spouse of a vested participant receives the qualified pre-retirement survivor annuity.

Plan is frozen effective 12/31/05.


