Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Description of the Plan

The following description of the Precision Countertops, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan documents for complete information.

General

The Plan is a defined contribution plan covering all regular employees of Precision Countertops, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's administrator controls and manages the operation and administration of the Plan. The Plan's custodian, appointed by the Plan administrator, is responsible for holding and investing Plan assets.

Contributions

The Plan agreement provides for voluntary employee salary deferral contributions. Participants may elect to defer up to the Internal Revenue Service's annual limit of \$23,000 (\$30,500 for participants age 50 and over). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at two percent of eligible compensation and their contributions invested in a designated target retirement date fund until changed by the participant. Employees are eligible to make elective deferrals to the Plan after two consecutive months of eligible service.

The Company may make discretionary matching contributions equal to a uniform percentage of each tier of a participant's salary deferrals. The Company may also make discretionary profit sharing contributions which are allocated based on the participant's eligible compensation as a percentage of total compensation of all participants eligible to share in the contribution. Participants must have completed one year of service to be eligible for employer matching contributions. Participants must have completed one year of service, must have been employed on the last day of the year, and must have completed 1,000 hours of service to qualify for profit sharing contributions. The Company made \$231,608 of discretionary matching contributions for 2024 (\$219,444 for 2023).

Note 1 - Description of the Plan (continued)Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's matching and profit sharing contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participants also become fully vested in the Company's matching and profit sharing contributions upon reaching normal retirement age or in the event of the participant's death.

Payment of benefits

On termination of service due to death or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,805 and \$14,718, respectively. These accounts may be used to reduce future employer contributions or used to pay Plan expenses. For the year ended December 31, 2024, \$11,464 was used to pay Plan expenses (\$18 for 2023).

Note 2 - Summary of significant accounting policiesBasis of accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Tax status

The Company adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 3 - Plan amendments

During 2023, the Plan Sponsor executed an amendment to retroactively adopt the coronavirus-related distribution provisions contained within the CARES Act. The Plan had been operating in accordance with those provisions.

Effective January 1, 2024, the Plan was amended to adopt an automatic elective deferral increase provision that will increase the deferral rates of eligible participants by 1% on the first day of each year up to a maximum of 10%. This provision applies to all participants who have defaulted into the Plan and needs to be elected by participants that have previously made an active election.

Note 4 - Information prepared and certified by Ascensus Trust Company

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, the agent acting on behalf of Ascensus Trust Company (the trustee of the Plan).

Note 5 - Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 6 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 - Party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by The Vanguard Group, Inc. ("Vanguard"). Vanguard, through Vanguard Retirement Plan Services ("Vanguard RPS"), provides recordkeeping and administrative services to the Plan pursuant to a Recordkeeping Service Agreement. Vanguard RPS retained Ascensus, Inc. ("Ascensus") as a subcontractor to provide these services on behalf of Vanguard. Vanguard RPS may use one or more third parties, which may be affiliates of Ascensus (each, a "Paying Agent"), to collect 12b-1 fees, commissions and other fees payable by the investment options available to the Plan (collectively, the "Administrative Fees"), and to remit the Administrative Fees to the Plan's custodian for credit to an Administrative Fee Credit Account maintained for the benefit of the Plan. In consideration of its services, the Paying Agent retains 5% of the Administrative Fees it collects. The Plan Sponsor makes payments to Vanguard for administrative expenses not covered by the Administrative Fee Credit Account.
