Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other matter - supplemental schedule required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule, that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of The Reliable Automatic Sprinkler Co., Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of The Reliable Automatic Sprinkler Co., Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

***Eligibility***

Employees who have completed three months of service and are 18 years of age become eligible to participate in the Plan on the first day of the following month. Employees hired as of January 1, 1997 (date of inception of the Plan), were eligible to participate on that date.

***Contributions***

Each participant may defer up to the lesser of 60% of eligible compensation or the maximum allowable in a calendar year as a contribution to the Plan. The maximum allowable deferral for 2024 was \$ 23,500. The Plan permits participants to make after-tax Roth deferral contributions.

Participants may make pretax contributions on any Company-paid bonus of a whole percentage from 1% to 100% of any bonus designated by the Company into the Plan on a pretax basis.

Participants who have attained age 50 may make catch-up pretax contributions during the year of a percentage between 1% to 100% of eligible compensation into the Plan on a pretax basis, up to a maximum of \$7,500. The total amount of catch-up, bonus and regular contributions for the plan year may not exceed the lesser of 60% of eligible compensation or other applicable Internal Revenue Code (IRC) limits.

The Company makes nonelective employer contributions for each eligible participant in an amount equal to 3% of eligible compensation. The Company may also make discretionary matching contributions of a percent, if any, to be determined annually based on a percentage of the participant's pretax contributions. The Plan provided a discretionary matching contribution for the year end December 31, 2024, which was a discretionary matching contribution of 50% elective deferrals up to 2% of eligible participants' compensation.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and plan earnings. Allocations of plan earnings are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable from Participants***

Qualifying participants may borrow from their respective account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bears interest at a rate which is commensurate with local prevailing rates as determined semi-annually by Fidelity Management Trust Company, the Plan's trustee. Principal and interest is repaid through payroll deductions. Participants can have no more than one loan outstanding at a time.

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon, as well as in the Company's discretionary contributions to their accounts. Participants are vested in the Company's non elective contributions after three years.

***Participant Forfeitures***

Forfeitures related to unvested employer contributions are used to reduce future employer contributions. Former employees can have this forfeiture reinstated if they start working again for the Company, subject to certain conditions specified in plan documents. At December 31, 2024 and 2023, forfeited nonvested participant accounts totaled \$83,516 and \$4,601, respectively. There were no forfeiture used to reduce employer contributions during the year ended December 31, 2024.

***Payment of Benefits***

Upon attaining the age of 59½, retirement, termination of employment, death or total disability, a participant's salary deferral and vested employer contribution accounts may be distributed either in a lump sum distribution, or in installment payments made over a period of years. Effective May 1, 2023, the Plan was amended to limit the cash out limit to \$1,000.

***Hardship Withdrawals***

A participant may apply to withdraw certain contributions to satisfy specific and heavy financial needs. In accordance with IRS regulations, a participant must exhaust all other assets reasonably available prior to obtaining a hardship withdrawal. The minimum hardship withdrawal is \$500, and all hardship withdrawals will be subject to the 10% nonperiodic income tax withholding rate unless the participant elects out of the withholding.

***Administrative Expenses***

The Plan's administrative expenses are paid by the Plan as provided by the Plan document unless paid by the Company, at its discretion.

***Plan Termination***

The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time by taking appropriate action as circumstances may dictate, with the approval of the board of directors. In the event the Plan should terminate, each participant affected by such termination shall have a 100% vested interest in their account. The Company will facilitate the distribution of account balances in single lump-sum payments to each participant in accordance with plan provisions until all assets have been distributed by the trustee upon plan termination. Each participant in the Plan will automatically become 100% vested in his/her account balance.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Use of Estimates***

The preparation of financial statements in conformity with accounting standards generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk and uncertainty associated with certain investment securities, it is possible that participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits could be materially affected in the near-term.

***Payments of Benefits***

Benefit payments to participants are recorded upon distribution.

**NOTE C - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS AND INVESTMENTS**

The Financial Accounting Standards Board codification provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under this guidance are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, except for the money market fund which during the years ended December 31, 2024 and 2023, which is included in the leveling tables as a Level 1 investment.

*Mutual and Money Market Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end based upon quoted market prices. The mutual and money market funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - TAX STATUS**

The Plan is a non-standardized 401(k) Prototype Plan (Prototype Plan) sponsored by Fidelity Management & Research Company and adopted by the Company. The Prototype Plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is currently designed and being operated in all material respects in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and that the related trust is tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by the trustee, Fidelity Management Trust Company and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Additionally, notes receivable from participants qualify as party-in-interest transactions.

**NOTE G - SUBSEQUENT EVENTS**

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 15, 2025, the date the financial statements were available for issuance.
