Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Faxon Machining, Inc. 401(k) Retirement Plan (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value except for the guaranteed investment contract, which is reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to the guaranteed investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Certain investment-related expenses are included in net appreciation of fair value of investments.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Related-Party Transactions

Standard Insurance Company is the custodian of the Plan. Certain Plan assets are investments in common collective trusts managed by Standard Insurance Company. Standard Insurance Company also provides certain record keeping and accounting services for the Plan and, therefore, these investments and all transactions with them qualify as party-in-interest transactions.

Several employees of Plan employers provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan employers for the services of the employees to the Plan.

Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan employers have evaluated subsequent events through October 14, 2024, which is the date these financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Faxon Machining, Inc. 401(k) Retirement Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is defined as a defined contribution plan covering substantially all employees of Consolidated Boring, Inc. (the "Company"). Substantially all employees of the Company are eligible for participation in the Plan upon attaining the age of eighteen and obtaining three months of service. Effective July 1, 2023, the service requirement was reduced to two months. Eligible employees may enter the Plan on the first day of the first payroll period they become eligible. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). In 2018, the Company divided into two different companies. As a result, in February 2019, the accounts of all the Faxon Firearms employees were transferred out of the Plan to the Faxon Firearms Plan. The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Contributions

Each year, participants may contribute 100% of pre-tax annual compensation as defined in the Plan. However, contributions may not exceed limitation established under Section 402(g) of the internal Revenue Code of 1986 as amended. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their account balance into various investment options offered by the Plan.

The Company has a discretionary employer match, for the plan year ended December 31, 2024, the Plan employers elected to match 50% of the first 5% of participant compensation not to exceed the maximum contribution allowed by law. The Plan employers made match contributions of \$223,466 for the year ended December 31, 2024. The Plan employers may also make annual discretionary profit-sharing contributions to the Plan. There is no requirement for minimum annual contributions, and it is possible that, in some years, no contribution would be made to the Plan. The Plan employer made no discretionary profit-sharing contributions for the year ended December 31, 2024.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis.

Eligibility

Employees are eligible to participate in the Plan upon completion of 2 months of service and age 18. Employees are automatically enrolled into the Plan and have 4% of eligible compensation contributed into the participant's account, unless otherwise elected by the participant.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan employers' contribution and (b) plan earnings or losses and (c) administrative fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions and their allocated share of employer contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Effective January 1, 2024 vesting in the Plan employers' matching and discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on one year of credited service. A participant is 100% vested after one year of credited service or upon death.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Forfeited Accounts

At December 31, 2024 and 2023 forfeited accounts totaled \$8,205 and \$1, respectively. Non-vested portions of participant accounts that are forfeited upon payment of benefits are retained in the Plan and used to reduce future employer contributions or pay Plan administrative expenses. The Plan used \$8,438 of forfeitures to reduce employer contributions during 2024, and used \$242 of forfeitures to reduce Plan administrative expenses.

Payment of Benefits

Benefits are recorded when paid. The participant's entire account balance becomes payable upon death, disability, or retirement in the form of a lump sum distribution. Normal retirement is age 65; early retirement age is 55 with six years of service. In-service withdrawals are permitted for participants who have reached age 59 ½, and rollovers can be taken as a distribution at any time.

For termination of service due to other reasons, a participant may receive the value of the vested interest of his or her account as a lump sum distribution.

In conditions of financial hardship, a participant may apply to the plan administrator for approval to withdrawal that portion of their vested balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Notes Receivable from Participants

Participants may apply for a loan from their account under the Plan. Certain legal restrictions impose limits on the amount of the loan and repayment terms. The minimum loan amount is \$1,000 and up to a maximum loan amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at the prime rate on the last day of the previous quarter. Generally, the participant's loan must be repaid, ratably through monthly payroll deductions, within five years, unless the loan is for the purchase of a primary residence.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at fair value by taking the fair value of the investments in the subaccount as of the applicable business day, less the investment fees and less the administrative fees.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 GUARANTEED INVESTMENT CONTRACT

Stable Asset Fund II

The Plan's investment in the Stable Asset Fund II is a benefit-responsive investment with Standard Insurance Company ("The Standard"). Standard maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract (GIC) issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events may limit the ability of the plan to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. If the plan sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawals restrictions can be obtained through the plan's account manager. As of December 31, 2024, the occurrence of any such event is not considered probable.

The contract owner may terminate the contract at any time with 30 days advance written notice to The Standard. The Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by either party, the payout value may be subject to adjustment, either in a single lump sum payment or in installment payments. The Plan Sponsor has adopted a prototype plan which has received a favorable opinion letter from the Internal Revenue.

NOTE 5 GUARANTEED INVESTMENT CONTRACT (CONTINUED)

There are no reserve against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$915,736 and \$715,606, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

NOTE 6 TAX STATUS

Service dated June 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan itself has not received a determination letter from the Internal Revenue Service. The Plan has been amended since adoption of the prototype plan. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan employers has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.
