## ***Independent Auditor's Report***

### **Plan Administrators and Trustees Skillable 401(k) Plan**

#### ***Scope and Nature of ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the accompanying financial statements of Skillable 401(k) Plan (f.k.a. Hands On Learning Solutions 401(k) Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### ***1. Description of Plan***

The following description of the Skillable 401(k) Plan (f.k.a. Hands On Learning Solutions 401(k) Plan) (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees of Hands on Learning Solutions LLC, d.b.a Skillable (the Employer) who are age 18 or older. Interns are not eligible for the Plan. There is no service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Certain employees of the Employer have been appointed trustees of the Plan. The trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance. The Employer is the Plan sponsor and administrator. The Plan's third party administrator is Standard Retirement Services, Inc. The Plan's custodian is Reliance Trust Company. Prior to July 2024, the Plan covered full-time employees of the Employer who were age 21 or older, the Plan's third party administrator was Human Interest, Inc. and the Plan's custodian was Matrix Trust Company.

#### ***Participant Contributions***

Each year, participants may contribute up to the maximum amount allowed by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect to categorize a portion or all of their contribution under the Plan's Roth deferral feature. Participant salary deferral contributions are remitted following each pay period. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Prior to July 2024, participants were limited to 90% and 50% of eligible compensation under the Plan's pre-tax and Roth deferral features, respectively.

#### ***Employer Contributions***

The Employer, in order to satisfy the safe-harbor rules of the Internal Revenue Code (the Code), matches 100% of the first 3% of eligible compensation and 50% of elective contributions that exceed 3% of eligible compensation, not to exceed 5% of the participant's eligible compensation for any plan year. The Employer's safe-harbor matching contributions are remitted following each pay period. Effective July 1, 2024, safe-harbor matching contributions are determined on an annual basis, and a true-up may be required at year-end to ensure that all eligible participants receive the correct contribution amount as required under the Plan's provisions. A true-up match has been accrued for the year ended December 31, 2024, and was funded into the Plan subsequent to year end.

***1. Description of Plan, continued***

***Participant Accounts***

Each participant's account is credited with the participant's contributions, as well as an allocation of the Employer's contributions and plan earnings. Participants direct the investment of their account balances into various investment options offered by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions, the Employer's contributions, and actual earnings thereon.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set quarterly to the prime rate in effect on the first day each calendar year quarter, as defined. Principal and interest is paid ratably through payroll deductions. Prior to July 1, 2024, the loan interest rate was set at 1% above the prime rate.

***Payment of Benefits***

On termination of service, a participant or their beneficiary may receive the value of the vested interest in his or her account as a lump sum distribution. Distributions may also be made in installments to comply with required minimum distribution rules required by the Code. The Plan permits in-service withdrawals to participants meeting certain requirements, including distributions for financial hardship. Furthermore, a participant may withdraw the portion of their vested account resulting from rollover contributions at any time.

***2. Summary of Accounting Policies***

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***2. Summary of Accounting Policies, continued***

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrators determine the Plan's valuation policies utilizing information provided by the investment adviser. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions are recorded in the year in which the participant compensation is earned.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as benefits paid to participants on the basis of the terms of the plan agreement.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to plan administration of notes receivable from participants and benefit payment fees are charged directly to the participant's account and are included in administrative expenses. Fees related to the general administration of the Plan, are charged to participants in proportion to their account balances and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**3. Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) as of December 31, 2024, including investments at fair value held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Matrix Trust Company (the current and former custodian, respectively of the Plan).

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**4. Fair Value Measurements, continued**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trust funds (CTFs) and the stable value fund: Valued at the fund's per unit NAV provided by the fund's trustees. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less their liabilities. The redemption frequency for participant transactions (purchases and sales) occur daily. The CTFs require advance written notice of 5 days for any withdrawal over \$1,000,000 or 10% of the assets invested. There are no unfunded commitments in these funds.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts as reported in the financial statements.

**8. Tax Status**

The Employer has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating the form of the pre-approved plan document was in compliance with applicable requirements of the Code. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Delinquent Participant Contributions**

As reported on Schedules H, Line 4a – Schedule of Delinquent Participant Contributions, during the year ended December 31, 2024, participant contributions and loan repayments in the amount of \$87,150, were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt party-in-interest transactions between the Plan and the Employer. Plan management intends to self-correct for associated lost earnings on these contributions during the year ended December 31, 2025.
