NOTE 1 - DESCRIPTION OF PLAN

The following description of the BluRoc 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of Yak Access, LLC, New South Environmental and Access Solutions, LLC, BluRoc, LLC, Yak Mat, LLC and Lane Logix, LLC (collectively referred to as the Company), who have completed 2 months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective March, 25, 2024, Yak Access, LLC, New South Environmental and Access Solutions, LLC, Yak Mat, LLC and Lane Logix, LLC were sold. As a result of the sale, their employees terminated their participation in the Plan. BluRoc, LLC is the remaining company in the Plan. The Plan name was changed from Yak Access 401(k) Plan to BluRoc 401(k) Plan. All Plan documents and provisions will remain the same. Approximately 60 employees remain in the Plan after the sale.

Contributions - Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants may also contribute a percentage of after tax annual regular compensation as a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company has elected to make a safe harbor matching contribution of 100% of participant's elective deferrals up to 5% of a participant's eligible compensation to be contributed to the Plan. In addition, the Plan allows for discretionary profit-sharing and discretionary matching contributions. There were no discretionary profit-sharing and discretionary matching contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions and the Company's safe harbor matching and discretionary profit-sharing contributions plus actual earnings thereon. A participant is 100% vested in the Plan's discretionary matching contribution after three years. Years of service with BluRoc, LLC,

Yak Access, LLC, Yak Mat, LLC, New South Environmental and Access Solutions, LLC, Jones Companies 401(k) Plan, Klein Parent, LLC and Lane Logix, LLC will be treated as service with the Company for vesting purposes.

Payment of Benefits - On termination of service due to death, disability, retirement or due to any other reason, a participant may be paid in a lump-sum cash distribution equal to the value of the participant's vested interest in his or her account, a rollover of the vested portion into a qualified plan, or a combination of the two.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,468 and \$49,437, respectively. These accounts are used to offset Plan expenses and reduce future employer contributions. During the year ended December 31, 2024, an amount of \$2,179 from forfeited nonvested accounts was used to offset Plan expenses.

Additionally, uncashed distribution checks can be deposited into the forfeiture account if participants cannot be located. If the participant comes forward in the future, the Plan must make the participant whole by reinstating the forfeited amount and paying the distribution. If sufficient funds do not exist in the Plan's forfeiture account at the time payment is requested, such amounts will need to be paid by the Company. An uncashed distribution check in the amount of \$22,759 was placed in the forfeiture account during the year ended December 31, 2023. This uncashed check was included in other income in the statement of changes in net assets available for benefits. Subsequent to December 31, 2023, the Plan administrator located the participant and the distribution will be paid to the participant from the forfeiture account, when requested information to prepare another check is provided.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who is responsible for their integrity and objectivity. These policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE AND CUSTODIAN

The following is a summary of the plan's investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the plan's financial statements and supplemental schedule, that was prepared by, or derived from, information prepared by Voya Institutional Trust, the trustee and custodian of the plan, and furnished to the plan management. The plan management has obtained certifications from the trustee and custodian that such information is complete and accurate.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts - Valued based on the plan's interest, represented by investment units, in the underlying investments held within the trust that are traded in an active market by the trustee.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY

At December 31, 2024 and 2023, the Plan had an investment in the amount of \$21,922 and \$602,772, respectively, in the Voya Fixed Account (the Fixed Account), which is a fully benefit responsive annuity contract issued by Voya Retirement Insurance and Annuity Company (VRIAC). The Fixed Account is an obligation of VRIAC's general account, which supports all of VRIAC's insurance and annuity commitments. All guarantees are based on the financial strength and claims paying ability of VRIAC, which is solely

responsible for all obligations under its contracts. The Fixed Account guarantees a minimum rate of interest and may credit interest that exceeds the guaranteed minimum rates.

The Fixed Account is intended to be a long-term investment for participants seeking stability of principal. The assets supporting it are invested by VRIAC with this goal in mind. Therefore, VRIAC may impose restrictions on the ability to move funds into or out of this investment option or among investment options in general. These restrictions help VRIAC to provide stable credited interest rates which historically have not varied significantly from month to month despite the general market's volatility in new money interest rates. Withdrawals from the Voya Fixed Account for reasons other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge.

The Fixed Account meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VIRAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Institutional Trust Company (VITC) or an affiliate of Voya. Voya is the trustee and custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment for fees for recordkeeping services totaling \$24,743, which is included in administrative expenses as reported on the statement of changes in net assets available for benefits. The Company pays directly any other fees related to the Plan's operations.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

As a result of the sale of Yak Access, LLC, New South Environmental and Access Solutions, LLC, Yak Mat, LLC and Lane Logix, LLC effective March 25, 2024, their employees terminated their participation in the Plan. Participants became 100% vested in their employer contributions.

NOTE 8 - TAX STATUS

The Plan is designed to meet IRS guidelines in accordance with applicable sections of the Internal Revenue Code (IRC). No letter of determination has been requested. However, the provider of the prototype plan document has obtained an opinion letter as to its acceptable form under the IRC. Although the plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain
