Note 1 – Plan Description

The following description of the Moore & Giles 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Moore & Giles (the “Company”). The Plan does not cover interns, leased employees, union employees or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute from pretax compensation or make Roth deferrals, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes a safe harbor matching contribution equal to 100% of the first 5% of compensation contributed by the participant. The Company may also make a discretionary profit sharing contribution to participants that are employed on the last day of the year or work 500 or more hours during the year. The Company did not make a discretionary contribution for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, an allocation of Plan earnings, and charged with an allocation of administrative fees. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and the safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after five years of credited service. Participants will become 100% vested upon normal retirement, death, or disability while employed by the Company.

Payment of Benefits

Upon retirement, death, disability, or termination, a participant can elect to receive a lump-sum or partial withdrawal equal to the vested value of his or her account. In-service distributions are allowed, as defined by the Plan document.

Administrative Costs

Administrative expenses are paid by the Company and the Plan on a discretionary basis.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,155 and \$10,124, respectively. These accounts may be used to pay Plan expenses or reduce employer contributions, as defined. There were no forfeitures used in 2024.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum of \$50,000 or 50% of their vested account balance, whichever is less. Note terms range from one year to five years. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus one percent determined at the time the note is consummated. At December 31, 2024, the interest rates on outstanding notes ranged from 4.25% to 9.50%. Principal and interest are paid through payroll deductions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures. Actual results may differ from those estimates.

Cash

The Plan maintains a cash account with John Hancock Life Insurance Company. The cash balance is not insured by the Federal Deposit Insurance Corporation (FDIC).

Valuation of Investments and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Evaluation of subsequent events was considered through October 9, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets as fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of pooled separate accounts are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the stable value fund is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs for the stable value fund include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The stable value fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While underlying asset values are publicly quoted prices, the net asset value (NAV) of a unit in a pooled separate account or common collective fund is not publicly quoted. Units can be issued or redeemed on any business day at the NAV. All earnings and gains and losses are reflected in the computation of the NAV and are realized by the participants upon withdrawal.

Note 4 – Insurance Contracts

The Plan has invested in a contract with John Hancock Life Insurance Company (U.S.A.), which maintains contributions in various pooled separate accounts. The percentage of contributions allocated to each fund is determined by the participants.

The separate accounts are maintained on a “unit” basis. The unit value is adjusted daily to reflect investment results under the separate accounts. These accounts are reported at fair value. The value of each account on any date is determined by multiplying the number of units held by the unit value at the close of business on that particular date.

Participants may invest in John Hancock Life Insurance Company’s stable value fund. Included in this fund are certain wrapper contracts. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for the stable value fund for the years ended December 31, 2024 and 2023 was approximately 4.96% and 5.02%, respectively. The percentage of contributions allocated to each fund is determined by the participants.

Note 5 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds held and managed by John Hancock Life Insurance Company, the Plan's Custodian. Investments in funds issued and managed by John Hancock Life Insurance Company are considered related party transactions. Fees paid by the Plan to John Hancock Life Insurance Company for administrative services for 2024 were \$74,757. John Hancock Life Insurance Company provides certain administrative services to the Plan pursuant to a Service Agreement. Revenue credits generally represent the return of excess revenue generated by the Plan based upon the terms of the Service Agreement. Revenue credits are deposited to the Plan's expense reimbursement account and may be used to pay reasonable and necessary Plan expenses. During 2024, revenue credits of \$6,626 were used to reduce Plan expenses. Administrative expenses are presented net of revenue credits used.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7 – Tax Status

The Plan is an adoption of a pre-approved plan sponsored by CCH Incorporated DBA FTWilliam.com. The Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Company has obtained the most recent favorable opinion letter from the IRS dated June 30, 2020. The Company believes the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
